34. PRIVATE HIRE DRIVER - CONVICTIONS THAT EXCEED THE SCHEME OF DELEGATION

The Head of Regulatory Services submitted a report requesting Members to consider a Private Hire driver's conviction. The driver attended the meeting to enable Members to give the matter their full consideration.

Mr J. S, the driver's solicitor provided the Sub-Committee with a brief outline of what Mr B. A said were the circumstances of the offence.

The Sub-Committee were given copies of a letter from Mr B. A's wife, and also references from Abacus Travel Services and A.R. Accountancy Services in support of Mr B. A.

Mr. B. A answered questions from the Sub-Committee.

The Sub-Committee considered that the offence had taken place in Mr B. A's Private Hire vehicle and involved a passenger in his vehicle and viewed this a serious matter and decided there were no exceptional reasons for them to depart from their guidelines that state that an applicant will normally be refused a licence when the applicant has a conviction for common assault and the conviction is less than 3 years prior to the date of the application.

RESOLVED: That Mr B. A's Private Hire driver's licence be revoked.
