10. APPLICATION FOR THE GRANT OF A VARIATION TO EXISTING PREMISES LICENCE - ST ALPHONSUS PARISH CENTRE, 2 POWELL STREET, OLD TRAFFORD, M16 7QQ

LICENSING SUB-COMMITTEE DECISION

To grant a variation of an existing premises licence as follows:-

1. Licensable Activities

To extend the terminal hour for licensable activities on:
Friday and Saturdays to 01:00 hours the following morning
Sundays before Bank Holiday Mondays to 01:00 the following morning

To remove conditions 3, 4, 9 and 12 from the Licence.

Additional Condition

PPN3

Noise from music and associated sources (including DJ's and amplified voices) must not be audible to such an extent that it constitutes a nuisance at any noise sensitive properties.

LICENSING SUB-COMMITTEE'S REASONS FOR REACHING ITS DECISION

1. The Sub-Committee carefully considered the resident's concerns regarding the potential for crime and disorder, public nuisance and protection of children from harm and balanced those concerns with the interests of the applicant and the licensing objectives.
