41. PRIVATE HIRE DRIVERS APPLICATION - APPLICANT PREVIOUSLY REVOKED ON GROUNDS OF FITNESS

The Head of Regulatory Services submitted a report requesting Members to consider an application for the grant of a Private Hire driver's licence.

The applicant attended the meeting to enable Members to give the matter their full consideration.

The applicant provided the Sub-Committee with an outline of his situation since the revocation of his previous licence.

The driver also answered questions directed to him from Sub-Committee Members.

The Sub-Committee considered that he had a Private Hire driver's licence revoked previously and the reasons for that revocation.

The Sub-Committee considered that he accepted the allegations made against him as he had done in 2014. The applicant expressed remorse and said it would not happen again, a representative of Scotts Taxis and his father expressed their faith that he would not repeat the actions which led to the revocation.

The Sub-Committee sought evidence of a sustained period of time during which he had not repeated the behaviour which led to the complaints and revocation. The Sub-Committee were unable to find the requisite evidence that would enable them to determine that he no longer posed any threat to the public.

RESOLVED: That Mr. B. H's application be refused.
