To consider the following motions submitted in accordance with Procedure Rule 11:

(a) Motion Submitted by the Conservative Group - Debate Not Hate

This Council believes that:

- 1. Debating and disagreement is a fundamental part of a healthy democracy, and that this should always be done with respect;
- 2. It is a privilege to be elected to public office and comes with the responsibility of representing everyone, regardless of how they voted and anyone, regardless of their background or political affiliation, should feel safe to become a councillor and be proud to represent their community.

This Council notes that:

- The Local Government Association (LGA) has amassed a considerable volume of evidence and personal accounts of the impact of abuse, intimidation, and aggression at a national level. The research showed that seven in 10 councillors reported experiencing abuse and intimidation over the last 12 months and councillors reported feeling that abuse is becoming more common and increasing in severity;
- 2. If left to continue, this negative and unacceptable behaviour can prevent elected members from representing the communities they serve, deter individuals from standing for election and undermine local democracy.

This Council further notes that:

1. The LGA has launched its "Debate Not Hate" campaign, which aims to raise public awareness of the role of councillors in their communities, encourage healthy debate and improve the responses and support for local politicians facing abuse and intimidation;

- 2. This research outlines seven recommendations that Councils, the LGA, police forces, the Government and social media companies should take to improve the environment for current and prospective councillors, ranging from protecting privacy to creating a long-term culture change that de-normalises the abuse of politicians and other high-profile individuals;
- 3. This campaign has received support from across the political spectrum, as well as representatives from bodies such as the National Association of Local Councils, Compassion in Politics, the Local Government Information Unit and the National Hate Crime Awareness Week.

The Council resolves to:

- 1. Endorse the LGA Debate Not Hate campaign and call on all political groups to sign the public statement;
- 2. Support the LGA's proposal for a national working group to produce and implement an action plan that addresses the abuse and intimidation of elected members and candidates and ensures their safety while they fulfil their democratic roles;
- 3. Assess how it can take greater responsibility for the safety and wellbeing of its members, taking a proactive approach to preventing and handling abuse and intimidation and addressing the impacts of abuse on mental health and wellbeing

Councillors agree to continually promote diversity and inclusion ahead of the next Local Elections and beyond, including diversity of thought – publicly condemning politically fuelled abusive behaviour.

(b) Motion Submitted by the Labour Group - City of Sanctuary

This Council notes that:

- Trafford Council is proud of its rich history of welcoming and supporting all those seeking safety in our borough and is committed to continuing to uphold the principles of dignity, respect and compassion towards all our residents.
- More and more men, women and children are being forced to flee from their homes due to conflict, war, persecution, human rights violations and the effects of the climate crisis.

This Council believes that:

- Current Government laws undermine internationally recognised rights for people fleeing war and persecution to seek safety and have created a hostile environment for refugees which is cruel and divisive, causing harm and distress to some of the most vulnerable people.
- Those fleeing violence and persecution flourish and contribute to their new country when given comprehensive and well-coordinated support within their new host communities to empower them to rebuild their lives, and should always be treated with dignity and respect, housed as our neighbours and given support to integrate into our communities.
- Becoming a member of the national network of City of Sanctuary Councils will build on, support and enhance the Council's work in creating a culture of welcome, inclusion and empowerment for people seeking sanctuary in collaboration with organisations such as the Hub in Altrincham, which is supporting occupants of the Britannia Ashley Hotel in Hale, Rehoboth for Families, and St John's Centre.

This Council resolves to:

- Sign up to the City of Sanctuary membership pledge to become a non-awarded member of the City of Sanctuary Local Authority Network, agreeing to work towards a City of Sanctuary Local Authority Award with the aim of becoming a recognised Council of Sanctuary, thereby influencing and offering inspiration to other Local Authorities and committing to recognising and raising awareness of the positive contribution that people seeking sanctuary make to our borough.
- Work together with the members of the Local Authority Network to influence government policy, challenging the current hostile approach, defending the human right to seek safety, and encouraging and enabling social change.
- Develop an action plan to embed the concept of sanctuary across council services and the wider community.
- Continue to work in partnership with community and voluntary organisations and those with lived experience, and continue to enable and empower people seeking sanctuary to lead at all levels of the network and the community.

(c) Motion Submitted by the Labour Group - Local Government Funding

This Council notes that:

- 1. A Fair Funding Review for local government was first promised by the government in 2016 but has still not been delivered and there is no indication of when it will be.
- 2. In 2015, the government set out plans to reset business rates baselines for council in 2020, but this has still not happened.
- 3. The government's Autumn Statement in November 2023 failed to provide any new funding for local councils, meaning there is a £4 billion funding gap facing councils just to maintain current services.
- 4. Almost one in five council leaders and chief executives in England surveyed by the Local Government Association think it is very or fairly likely that they will need to issue a section 114 notice this year or next.
- 5. The provisional Local Government Finance settlement announced by the government on 18 December 2023 assumes that all councils will increase their council tax by the maximum allowed in 2024/25, following the same assumption used in previous years.
- 6. For the last six years, the government has only issued one-year settlements which makes it difficult for councils to plan their future financial sustainability.
- 7. Responding to the settlement, the Local Government Association noted that it "does not provide enough funding to meet the severe cost and demand pressures which have left councils of all political colours and types warning of the serious challenges they face to set balanced budgets next year".
- 8. More than 40 Conservative Members of Parliament have signed a letter to the Prime Minister, warning they are "exceptionally concerned" that their local Councils are facing financial crisis.

This Council further notes that:

 Trafford is one of the 20 worst funded councils in the country, one of the lowest spending councils and its council tax levels are the second lowest in Greater Manchester. The Institute for Fiscal Studies identified Trafford as the lowest funded local authority compared to 150 similar authorities, meaning it receives £11 million less each year on average than similar authorities.

- 2. Since 2010, Trafford has suffered a 60% real terms reduction in its budget and had to close budget gaps totalling £288 million.
- 3. Between 2010-15, when the Conservatives led the council, council tax in Trafford was frozen. This has meant the council has £15 million less in income each year.
- 4. Increases in demand for adult social care and children's services, high levels of inflation and increases in the National Living Wage are costing the council around £12 million each year. Increases in council tax, business rates indexation and certain grants only provide around £6 million each year, meaning the council budget has an underlying structural deficit, where it has to find £6 million of savings every year just to stand still.

This Council resolves to:

- 1. Launch a public campaign alongside other Greater Manchester authorities:
 - a. calling on the Government to fix the broken system of local government finance and give Trafford a fair funding settlement.
 - b. highlighting the cuts made to Trafford Council's budget, despite increases in council tax and the increasing demand for key services.
 - c. To highlight what the Council and residents can do to support reducing costs and demands on local services.
- 2. Ask the Leader or Chief Executive to write to our Trafford Members of Parliament and Greater Manchester Mayor requesting that:
 - a. they support our campaign, lobby Ministers and publicly call on the government to deliver a fair funding settlement for Trafford.
 - b. they reply to indicate their position to the Council.

APOLOGIES

Apologies for absence were received from Councillors S.J. Gilbert and J.A. Wright.

32. MINUTES

That the Minutes of the Meeting of the Council held on 19 July 2023, be approved as a correct record and signed by the Chair.

33. ANNOUNCEMENTS

(a) <u>Honorary Alderman, Former Councillor and Past Mayor Mrs. Pamela Dixon</u> MBE and Former Mayoress Mrs. Wendy Higgins.

It was with regret that the Mayor referred to the recent passing of former Councillor Mrs. Pamela Dixon MBE and Honorary Alderman who was Mayor of Trafford in 2004/05. Mrs. Dixon represented the Brooklands Ward and served on the Council for 27 years between 1990 and 2018.

The Mayor also advised the Council of the sad passing of the former Mayoress, Mrs. Wendy Higgins, who was Mayoress to her husband David in his Mayoral year 2009/10.

As a mark of respect to its former colleagues, the Council stood for a moments silence in reflection of in their memory.

(b) Israel and Gaza

The Mayor referred to the terrible events which were unfolding in Israel and Gaza and conveyed the Council's thoughts and prayers to those impacted and the people caught up in the ongoing conflict.

The Council paused and took a moment to reflect on the many innocent people who had lost their lives or who had lost loved ones.

(c) <u>His Majesty the King's Birthday Honours</u>

The Mayor took the opportunity to recognise those citizens and persons connected with Trafford who were named in His Majesty the King's Birthday Honours List, namely:

Ms Hayley Karen Citrine from Sale, awarded the citation of Member of the Most Excellent Order of the British Empire (MBE) for services to Nursing;

Mr Jonathan Grant Evans from Hale, awarded the MBE for services to Association Football in Northern Ireland;

Mrs Zoe Branka Holland from Sale, awarded the MBE for Charitable Service, particularly during Covid 19; and

Dr Rosemary McCarthy from Hale, awarded the MBE for services to Midwifery and Maternity Healthcare.

The Council joined with the Mayor in conveying the Council's congratulations for their achievements and richly deserved recognition.

(d) The Leader of the Council's Announcements

Councillor Ross provided a summary of the following Council activities since the previous meeting.

- In July, eleven of Trafford's parks and greenspaces were awarded Green Flag status. Thanks went to the Friends of Parks Groups and officers from the Council and Amey.
- In partnership with L&Q, the Council had started the regeneration of several properties in Sale Moor to bring them back into use as affordable homes.
- In early September, thousands welcomed the tour of Britain cycling race to Altrincham.
- Council had received funding of almost £2 million to support the building of new homes on the Lacy Street site in Stretford.
- Longford Park awarded £3million from the heritage lottery fund with thanks to the Friends of Longford Park, Ward Councillors, Executive Members and officers.
- Congratulations to Altrincham Bid for their successful Purple Flag award.
- The opening of Hale Library.
- The Council looked forward to the next stages of the levelling-up bid for leisure development in Partington and to the engagement with residents.
- Congratulations to Trafford Veterans and the Special Educational Needs Family Support Group on receiving the King's Award for Voluntary Service.

(e) <u>Budget Scrutiny</u>

Councillor Acton, Chair of Scrutiny Committee advised the Council that the Budget Scrutiny sessions were to take place on 28 and 30 November 2023 to which all Members were invited.

(f) <u>Health Scrutiny</u>

Councillor Butt, Chair of Health Scrutiny updated the Council on the Task and Finish Group's meeting with local social prescribers and the Committee's work programme to date in respect of Altrincham Minor Injuries Unit, Aids and Adaptations and the Integrated Care Board's governance structure. The forthcoming meeting will explore Health Social Care Winter Plans, Dental Access and Cancer Diagnosis and Prevention as well as reviewing performance during the pandemic.

34. QUESTIONS BY MEMBERS

The Mayor reported that 12 questions had been received under Procedure Rule 10.2.

On the basis that the Mayor had asked for the responses to be circulated to all Councillors and published on the website, the Council consented to taking both the question and response as read and noted and where a response was yet to be provided, they would be circulated after the meeting.

The Mayor invited any supplementary questions to be submitted in writing after the meeting. Any supplementary question received, together with the answer to that question, would also be published on the Council's website.

RESOLVED: That the Council notes the questions submitted for the meeting and the responses provided so far and notes the process by which outstanding responses and supplementary questions and their responses will be dealt with.

35. MEMBERSHIP OF THE COUNCIL, COMMITTEES AND OUTSIDE BODIES

RESOLVED: That Council notes that:

- (a) Councillor New resigned her position as a Member of the Council, with effect from 20 September 2023.
- (b) Councillor Frances Cosby was elected as a Member of the Council following the Poll held on 2 November 2023 for the Bucklow St. Martins Ward and will hold office until 2027.
- (c) Councillor G. Carter replaced Cllr K. Procter on Licensing Committee for the period 8 August 2023 to 17 August 2023.
- (d) Councillor Patel was appointed to the Greater Manchester Combined Authority Employment Skills and Work Executive Member Forum and Councillor Ged Carter appointed as the substitute Member with effect from 16 October 2023 and 8 November 2023, respectively.

36. PETITION - PEDESTRIAN CROSSING ON PARK ROAD, TIMPERLEY

Lead Petitioner, Helen Orme introduced the following petition which had received 615 signatures in support:

"We petition the Council to provide a pedestrian crossing on Park Road, Timperley in the vicinity of Heyes Lane and Stoney Bridge Lane junction.

Many people cross Park Road, Timperley near to the junction of Heyes Lane to access Stoney Bridge Lane. In particular it is used by many school children walking to Wellington School. It is also used as foot access to other schools, tennis club, allotments, dog walking and a route to Timperley village. There have been several accidents at this junction including a recent accident where a child was hit by a car. It can take several minutes to wait for a safe opportunity to cross plus there is a blind spot to pedestrians when crossing at the bottom of Stoney Bridge Lane making it very difficult for pedestrians to cross safely."

The lead petitioner outlined the main reasons for the petitions ask, namely, it was impracticable to use the next nearest crossing; school children were at risk having to make judgements about when to cross: statistically, six serious accidents on Park Road recently did not prove the junction was safe; and morally the safety imperative outweighed any budgetary concerns.

Councillor Adshead, Executive Member for Highways, Environmental and Traded Services responded to the petition on behalf of the controlling group advising that all requests were fully accessed and outlined the potential costs which were dependant on Transport for Greater Manchester funding. He thanked the petitioner for bringing the issue to the Council and indicated that road safety and highway officers would consider the request and provide a response directly.

Councillors Evans, Minnis and Jerrome responded to the petition on behalf of the opposition political parties and recognising that there was not any safety features in the vicinity were supportive of the petition's ask and urged the Council to find the necessary funding.

In summary, the Leader of the Council, Councillor Ross advised that there was a political will to support Active Travel Routes where possible and he would speak to the Executive Members to look at what the Council could do to liaise with Transport for Greater Manchester and Ward Councillors to see if progress can be made with the petitions' request.

37. STREET TRADING POLICY, DESIGNATED STREETS AND FEES 2023

The Executive Member for Communities and Safety submitted a report outlining the current position of street trading within Trafford and detailing a number of proposals and the consultation undertaken. The report had been considered by the Executive on 18 September 2023 and Council was recommended to:

- (i) designate streets in the Borough as licence, consent or prohibited;
- (ii) agree a new policy (including recommendations for a consent to be obtained for the sale of articles from private land where the public have access without payment); and
- (iii) agree revised fees.

RESOLVED -

- (1) That the Council notes the recommendations of the Executive on the 18 September 2023 and the content of the report.
- (2) That the Street Trading Policy, Designation of Streets and the new fees and charges, be approved as set out in Appendix A to the report.

38. HACKNEY CARRIAGE AND PRIVATE HIRE LICENSING POLICY 2023

The Executive Member for Communities and Safety submitted a report proposing the Council adopts a new overarching Hackney Carriage and Private Hire Licensing Policy to be effective from the 1 December 2023, and to be reviewed every five years. The recommendations of the report had been agreed by the Executive on 15 November 2023.

RESOLVED -

- (1) That the Council note the recommendations of the Executive on the 15 November 2023.
- (2) That the proposed Hackney Carriage and Private Hire Licensing Policy, be approved which includes the amendments set out at 3.19 in the report.
- (3) That authority be delegated to the Corporate Director of Place, in consultation with the Executive Member for Communities and Safety, to bring the implementation date for vehicle age and emission standards (for existing licensed vehicles) forward from 1 April 2026 should it be deemed appropriate in support of the Clean Air agenda.

39. A REVIEW OF THE CIVIC ALLOWANCES FOR THE MAYOR AND DEPUTY MAYOR OF TRAFFORD COUNCIL

The Director of Legal and Governance and Monitoring Officer submitted a report advise the Council of the recommendations of an independent review of Trafford's Civic allowances.

RESOLVED -

- (1) That the Council agrees to accept the recommendations in full, as set out in the appendix to the report, namely:
 - (i) that the Civic Allowance for the Mayor of Trafford Council is reset at £10,000 per year.
 - (ii) that the Civic Allowance for the Deputy Mayor should be reset at £2,500.
 - (iii) that the Civic Allowances paid to the Mayor and Deputy Mayor of Trafford Council are indexed to the annual percentage salary increase for local government staff (*at spinal column point 43*) as agreed each year by the National Joint Council for Local Government Services and applicable to the same year it applies to Officers and applicable for as long as the main allowances are indexed. The indexation for the Civic Allowances should commence from the start of the 2024/25 municipal year.
 - (iv) that the recommendations contained in this report are adopted from the date of the Annual Council meeting 24 May 2023.

(2) That the Council's thanks be conveyed to Dr Declan Hall for the work undertaken and report produced.

40. MOTION SUBMITTED BY THE GREEN PARTY GROUP (DEFERRED FROM COUNCIL 19 JULY 2023) - SUPPORT THE CLIMATE AND ECOLOGY BILL

The Motion set out on the Summons regarding Support the Climate and Ecology Bill was moved and seconded.

Following a debate on the matter, <u>the Motion</u> was put to the vote and declared carried.

RESOLVED: That:

Preamble

Humans have already caused irreversible climate change, the impacts of which are being felt in the UK, and around the world. The global temperature has already increased by 1.2°C above pre-industrial levels and—alongside this—the natural world has reached crisis point, with 28% of plants and animals threatened with extinction. In fact, the UK is one of the most nature-depleted countries in the world as more than one in seven of our plants and animals face extinction, and more than 40% are in decline.

Climate change remains a major concern for voters with 66% of people (according to YouGov) expressing they are 'worried about climate change and its effects'. Alongside this, the popularity of Sir David Attenborough's Save Our Wild Isles initiative demonstrates public concern that UK wildlife is being destroyed at terrifying speed.

Climate and Ecology Bill

The Climate and Ecology Bill, a private member's bill currently before the House of Commons, seeks to address the challenges that this situation poses by creating a whole-of-government approach to deliver a net zero and nature positive future.

Based on the latest science, the Bill aims to align current UK environmental policy with the need to halt and reverse nature loss by 2030, which was a goal agreed to at COP15, via the Kunming-Montreal Framework (22 December 2022); and reduce greenhouse gas emissions in line with a fair share of the remaining global carbon budget to give the strongest chance of limiting global heating to 1.5C, which was the goal agreed to at COP21, via the Paris Agreement (12 December 2015).

By bridging the gap between the UK Government's current delivery, and what has been agreed at international levels, Britain has a chance to be a world leader on the environment; seizing the opportunities of the clean energy transition, including green jobs and reduced energy bills; and boosting the UK's food and energy security. Trafford Council notes that:

The Climate and Ecology Bill, which has been introduced in the UK Parliament on four occasions since 2020, including most recently in the House of Commons 10 May 2023. The Bill is backed by 168 cross-party MPs and Peers and 237 local authorities, alongside the support of eminent scientists, such as Sir David King; environmental non-governmental organizations, such as The Wildlife Trusts and CPRE; businesses, such as The Co-operative Bank; and 30,000 members of the public.

The Bill would require the UK Government to develop and deliver a new environmental strategy, which would include:

- 1. Delivering a joined-up environmental plan, as the crises in climate and nature are deeply intertwined, requiring a plan that considers both together;
- 2. Reducing emissions in line with 1.5°C, ensure emissions are reduced rapidly, for the best chance of limiting warming to 1.5°C;
- 3. Not only halting, but also reversing the decline in nature, setting nature measurably on the path to recovery by 2030;
- 4. Taking responsibility for our overseas footprint, both emissions and ecological;
- 5. Prioritising nature in decision-making, and ending fossil fuel production and imports as rapidly as possible;
- 6. Ensuring that no-one is left behind, by providing for retraining for people currently working in fossil fuel industries; and
- 7. Giving people a say in finding a fair way forward through an independent and temporary Climate and Nature Assembly, representative of the UK population, an essential tool for bringing public opinion along with the unprecedented pace of change required.

Trafford Council therefore resolves to:

- 1. Support the Climate and Ecology Bill;
- 2. Inform local residents, and local press/media of this decision;
- Write to Trafford's MPs, Andrew Western, Sir Graham Brady and Mike Kane, to inform them that this motion has been passed, urging them to sign up to support the Climate and Ecology Bill, or thanking them for already doing so;

4. Write to Zero Hour, the organisers of the cross-party campaign for the Climate and Ecology Bill, expressing its support (campaign@zerohour.uk).

41. MOTION SUBMITTED BY THE LIBERAL DEMOCRATS GROUP -ALTERNATING THE WEED SPRAYING PROGRAMME

RESOLVED: That the Motion be withdrawn.

42. MOTION SUBMITTED BY THE LIBERAL DEMOCRATS GROUP - A FAIR DEAL ON BUSINESS RATES RETENTION

The Motion set out on the Summons regarding A Fair Deal on Business Rates Retention was moved and seconded.

Following a debate on the matter, the Motion was put to the vote and declared lost.

43. MOTION SUBMITTED BY THE LABOUR GROUP - VAPING

The Motion set out on the Summons regarding Vaping was moved and seconded.

The first proposed Amendment which had been set out and published, was withdrawn.

The second proposed Amendment was moved and seconded, as set out and published.

Following a debate on the matter, <u>the Amendment</u> was put to the vote and was unanimously carried. <u>The substantive Motion</u> was then put to the vote and was also carried unanimously.

RESOLVED: That over the last few years, vaping among our young people has risen sharply, both nationally and locally.

In Trafford our Public Health team undertook a Young People's Trading Standards Survey 2022 which told us:

- 10% of young people who completed the survey claimed to vape occasionally or regularly compared to the GM average of 22%;
- 77% answered that they had never tried a vape, which is higher than the GM average of 59%.

However, our Voice of the Child Champions group told us in February 2023 that they felt the prevalence estimated in this survey are inaccurate, and the number of young people vaping was higher and that most people who vaped had not smoked before.

Also, some data we have accessed from Action on Smoking Health (ASH) shows that 8.6% of 11- to 18-year-olds in England vaped in 2022, compared with 4% in 2021.

Further data from ASH shows that single-use vapes are the chosen product for the vast majority of young people who have started using e-cigarettes (69% in 2023).

Some health groups are calling for single-use vapes to banned completely. Unscrupulous retailers who sell vapes to children, often stock illegal products, containing high levels of toxic elements like chromium and lead.

Single-use vapes are detrimental to the environment, with over a million single-use plastic vapes and associated batteries going to landfill or littering the streets each week.

Recent Chartered Trading Standards Institute research found that 60% of local trading standards services report high street shops selling vapes or vaping products to children. Trading standards teams reported a significant rise in underage vape sales last year, with more than a fifth of youngsters buying vaping products from newsagents while 16.3% buying them from a supermarket. Schools in Trafford are

mirroring this trend with secondary schools now having to confiscate vaping products on school premises.

The effects of e-cigarettes and vaping are still not yet fully understood which is especially important in the context of young people, as their lungs are still developing. There is growing evidence that e-cigarettes can help people manage their nicotine cravings – but this isn't without risk. While research has shown vaping poses a small fraction of the risks of smoking, it is deeply worrying that more and more children – who have never smoked – are starting vaping.

The LGA has called on its members to step up enforcement to deal with growing numbers of shops selling vapes to children despite the 18-age limit, with many "especially concerned" by child-friendly marketing, including colourful packages and different flavours. We are aware of the anti-social aspects of vaping and the environmental problems that are also associated; however, this motion is concentrating on our young people's health and what we do to prevent ill health for them in the future.

This Council asks the following:

- that the Leader writes to the Secretary of state for tighter regulations on the marketing of vape products, including a ban on brightly colour packaging and a review of the flavours vape companies use which are likely to appeal to children.
- that all parties across the chamber lobby the government and their local MPs for extra funding for councils for education and support to deliver

to our young people the real health issues that vaping causes in the long term and the short term around popcorn lung and more.

- Call for harsher punishments for companies which flout advertising rules to promote their products on social media, and for more licensing powers to allow local authorities to ban the sale of e-cigarettes in shops near schools.
- that all parties across the chamber lobby the government and their local MPs to support a ban on single-use vapes.

Also resolves that the Councils Trading standards team continue working with Public Health to:

- Carry out regular test purchases and seize products and issued fixed penalty notices when a business has been found to be in breach of the law.
- Implement mandatory age-of-sale signage on vaping products.
- Implement sanctions for breaching these rules should also be the same as penalties handed out under tobacco display regulations.

44. CROSS-PARTY MOTION SUBMITTED BY THE LIBERAL DEMOCRATS GROUP AND CONSERVATIVE GROUP - SUPPORT FOR A GREATER MANCHESTER-WIDE TRIAL OF THE BABY-BOX

With the consent of the Council, the Motion set out on the Summons regarding Support for a Greater Manchester-wide Trial of the Baby-box was altered, as set out and published before being moved and seconded.

Following a debate on the matter, <u>the Motion</u>, as altered was put to the vote which was carried unanimously.

RESOLVED: That this Council notes:

- Across Greater Manchester, more than one in every three children grow up in poverty. Three of the 20 local authorities with the highest levels of child poverty nationally, are in Greater Manchester.
- As many as 10 children in every classroom of 30, are not getting the start in life that they deserve.
- The pandemic has compounded this situation, leading to a spike in child poverty rates of approximately 6% during the 'pandemic years' 2020 and 2021.

This Council believes in the power of early intervention and in the positive difference that can be made when health services provide meaningful support to families and children from birth.

The Baby Box scheme is a care package which is delivered to expectant parents, carers and guardians in the early stages of a child's life. It is loaded with essentials such as clothing, reusable nappies, maternity pads, blankets, wraps and slings, as well as books, vouchers and advice for new parents. The box itself doubles as a small cot.

The principle behind the Baby Box is that every child should be offered the best possible start in life.

Finland and Scotland have long since adopted the Baby Box. Each have seen this contributing to a steady and sustained positive impact on child poverty rates, as well as on infant mortality rates and rates of post-natal depression, among other positive health impacts.

The universal nature of the baby box in both countries means that no stigma is placed on families for receiving support.

Whilst a universally implemented Baby Box could deliver positive outcomes for children and families across Greater Manchester, this council recognises the current strain on public sector finance and therefore advocates for a proportionate universal approach to be explored in developing a Greater Manchester-wide trial of the Baby Box.

This Council also acknowledges and values the support already offered to new parents in Trafford by community and voluntary services such as The Little Green Sock Project and our Trafford Community Hubs, as well as the role of businesses in driving positive health outcomes for the people of Greater Manchester. We would seek to engage with such communities when exploring options for a Baby Box scheme.

This Council resolves:

- that the Leader of the Council, the Executive Member for Health and Care and Executive Member for Children and Young People engage with Council Officers and Children's Scrutiny committee to explore the feasibility of introducing a Baby Box scheme in Trafford, comparing this with other assistance already in place, in alignment with our existing strategies to tackle poverty.
- If it is assessed that a Baby Box offer is feasible in Trafford, report our findings to the Mayor of Greater Manchester and the Deputy Mayor for Health, calling for the exploration of sources of funding and options for the delivery of an ethical and sustainable Baby Box trial in Greater Manchester.

45. MOTION SUBMITTED BY THE CONSERVATIVE GROUP - ALTRINCHAM MINOR INJURIES UNIT

The Motion set out on the Summons regarding Altrincham Minor Injuries Unit was moved and seconded.

An Amendment was moved and seconded, as set out and published.

Following a debate on the matter, the Amendment was put to the vote and declared lost.

A second Amendment was moved and seconded, as set out and published.

Following a debate on the matter, the second Amendment was put to the vote and declared lost. The substantive Motion was then put to the vote and declared lost.

Report Title

Review of Polling Districts and Polling Places

<u>Summary</u>

The report sets out proposals to enable the Council to comply with its statutory duty to review all Parliamentary polling districts and polling places and to review all Local Government polling districts and polling places at the same time.

Recommendation(s)

The Council is recommended to: -

(1) Note the outcome of the Local Authority's review of its polling districts and polling places;(2) Agree the proposed relocations of polling places as detailed in the report and set out in Appendix A;

(3) Agree the proposed re-designation of polling districts as detailed in the report and as set out in Appendix B; and

(4) Delegate authority to the Returning Officer to:

4.1 make further necessary changes to polling places/polling stations that may occur before the elections on 2 May 2024. This includes making changes to any polling place, should it become unavailable, prior to the election – thus allowing the polling place to be changed without full Council approval

1. Introduction and Background

- 1.1 Please see attached appendices: Appendix A – Polling Districts and Polling Places Proposals Appendix B – Maps of Wards and Polling Districts Appendix C – List of Wards and Polling Districts Appendix D – Consultation Results
- 1.2 To consider the Council's proposals for the statutory review of polling districts and polling places.
- 1.3 Under the Representation of the People Act 1983, the Council has a duty to divide their area into polling districts, to designate polling places for those polling districts, and to keep their electoral arrangements under review.
- 1.4 The Electoral Administration and Registration Act 2013 introduced compulsory timescales for the completion of statutory reviews of parliamentary polling districts and polling, reflecting the requirements as set out in Fixed Team Parliamentary Act 2011. In accordance with the 2013 Act, the Council's next review must be completed between 1 October 2023 and 31 January 2025.
- 1.5 Key definitions:
- 1.5.1 **Polling District –** A geographical area created by the sub-division of a UK Parliamentary Constituency. All electors within the polling district will attend the same voting place (unless a postal vote is in place)
- 1.5.2 **Polling Place –** The building or area in which a polling station will be provided by the Acting Returning Officer within the polling district (unless special circumstances mean this is not possible)
- 1.5.3 **Polling Station –** The room or area within the polling place where the process of voting takes place during an election

2 The Designation of Polling Districts, Polling Places and Polling Stations

- 2.1 The Council is responsible for the designation of polling districts within the borough. In the determination of polling district boundaries, the Council must ensure that all electors in each area have such reasonable facilities for voting as are practicable in the circumstances.
- 2.2 The Council must also designate a polling place for every polling district. This is usually with the boundary of the polling districts unless there are special circumstances e.g. lack of suitable buildings.
- 2.3 The allocation of polling stations within polling places is not a Council function but is instead it is the responsibility of the (Acting) Returning Officer.
- 2.4 In designating polling places, the Council utilises its powers under the Representation of the People Act 1983 when dividing constituencies into polling districts and in dividing wards into polling districts at local government elections.
- 2.5 Polling districts for local government elections are not automatically part of the statutory review. However, the Electoral Commission advises that polling districts for UK parliamentary and local government elections should always be the same. It therefore follows that any review of parliamentary polling arrangements should be conducted simultaneously with one of local government arrangements, and with those

for any other type of election for which provision is made for the designation of polling districts and polling places.

3. The Use of Schools

- 3.1 Although one of the aims of the review is to ensure accessible polling stations for the electorate, which most of the consultees confirmed, there was also suggestions to move away from the use of schools.
- 3.2 Where a suitable alternative to a school can be found without disadvantage to the electorate, the (Acting) Returning Officer will, subject to the building being suitable, take steps to move away from using the school.
- 3.3 The School Standards and Framework Act 1998 and the associated regulations (The Education (School Day and School Year (England) Regulations 1999 (No 3181)) requires that schools should meet for not less than 380 sessions (190 days) for pupils.
- 3.4 It should be noted that for the purpose of taking the poll in England and Wales, the (Acting) Returning Officer is entitled to use, free of charge, schools maintained or assisted by a local authority as well as those schools that received grants made out of monies provided by Parliament. This includes academies and free schools.
- 3.5 It should also be noted that the use of private premises is not guaranteed, especially at unscheduled elections, and the cost of using private premises as opposed to schools is considerably higher.
- 3.6 Ideally, the Council would have the choice of a range of fully accessible buildings, conveniently located for the electors in the area, however, this is not always the case and there are areas of the borough where schools are the only suitable premises which can accommodate voting.
- 3.7 Electoral Services Officers work with schools to find solutions to enable them to remain open while being used as polling stations. In other cases, alternative premises have been explored and utilised where possible.

4 The Review

- 4.1 Notice of the Review of Polling Districts and Polling Places was published on 9th October 2023.
- 4.2 Information regarding the review was published on the Council website and displayed at Trafford Town Hall reception.
- 4.3 As part of the consultation process, the following were individually contacted:
 - Trafford Council Councillors
 - Graham Brady MP Altrincham and Sale West Constituency
 - Andrew Western MP Stretford and Urmston Constituency
 - Mike Kane MP Wythenshawe and Sale East Constituency
 - Joanne Rooney CBE Acting Returning Officer for Wythenshawe and Sale East Constituency
 - Trafford Planning Department
 - Trafford Partnerships

4.4 Electoral Services Officers carried out visits to polling places during the consultation. The purpose of these visits was to assess the suitability of existing arrangements and identify any viable alternative options.

5.0 Consultation

- 5.1 The first consultation period was held between 9th October 9th November and the second consultation period commenced on 13th November and concluded on 13th December.
- 5.2 During the consultation period, ward Councillors were consulted on the proposals and two drop-in sessions were held to discuss the options.
- 5.3 Once the consultation periods had ended and the (Acting) Returning Officer's proposals had been made, two briefing sessions were held for Members to consult them on the proposed changes.
- 5.4 21 responses were received across both consultation periods.
- 5.5 8 respondents found their polling station accessible and suitable for use as a polling station.
- 5.6 Representations were made to the (Acting) Returning Officer by some ward Councillors.
- 5.7 A summary of all the responses can be found in Appendix D.

6. Proposals

- 6.1 This report sets out the results of the (Acting) Returning Officer's investigations to propose suitable polling districts and polling places.
- 6.2 Full details of the (Acting) Returning Officer's proposals (all wards) with proposed changes can be found in Appendix A. Polling stations can unexpectedly change and/or become unavailable, especially private premises. Some are still being considered at the moment.
- 6.3 The maps of the proposed changes can be found in Appendix B.
- 6.4 In some areas of the borough polling places/districts needed to be changed.
- 6.5 However, in other areas of the borough as no changes have been recommended and the current arrangements will remain.
- 6.6 It is proposed that the names of the polling districts will change to include the number that represents the constituency at the start of the polling district name rather than the end. For example, ALA1 will become 1ALA.

7. Conclusions

7.1 After considering representations on the most appropriate polling districts and polling places, the (Acting) Returning Officer's final proposals have been submitted for approval by the Council.

- 7.3 Should the Council agree the proposals, details of the new polling places will be made available to the public at Trafford Town Hall and on the Council's website.
- 7.4 The following will also be made available for inspection:
 - All correspondence sent to the (Acting) Returning Officer in connection with the review;
 - All correspondence sent to any person whom the authority contacted because they
 had particular expertise in relation to access to premises or facilities for disabled
 people;
 - All representations made by any person in connection with the review;
 - Details of the designation of polling districts and polling places within its area as a result of the review; and

We raised this with officers shortly before the election and Trafford issued a letter to residents in this polling district to clarify the situation—however given the tight timescales it arrived at many homes after polling day. We were given assurances that this situation would be reviewed in due course as such we hope the fol lowing suggestions will be considered as part of this review. Our suggestions; Polling District SMB3 needs to have a polling station located within it. Whilst there may not be a community building available a mobile unit could be located near the shops on Norris Road or our park / car park on Bramhall Close. Currently residents furthest away from Sale Moor Community Centre has a good 40 minute round trip on foot– there is no bus route that covers this. This is the part of the ward with the lowest rates of car ownership, in May we had to organise lifts for several people. Polling District SMA3 – this area includes an estate previously located within Priory ward – Dane Road, Ravenstone Drive. Arnesby Ave, Oulton Ave. Stapleford, Vale Ave. Residents for some years have travelled to Sale Sports Club to cast their vote, short walk, lots of car parking. In May they were asked to go to Sale Methodist Church 40 minute walk round trip, no car parking. We would like resid ents on this estate previ

Ashton upon	Firstly, the information given by the Council on the website seems very unclear. Overall, I have concluded that the present consultation is
Mersey	regarding current polling places, as indicated in The Messenger, Trafford, 26/10/23, but parts of the information seem to say that opinions
Mersey	on proposed changes are being sought rather than on current arrangements. However I cannot find what these changes are or would be,
	so I imagine this could possibly be a reference to the next part of the consultation. Clarity of information would be helpful.
	I have limited mobility. I am responding because for several years, due to the difficulty and time involved in accessing the allocated polling
	station, I have been using a postal vote but taking it to the polling station near me by hand. The allocated polling station was changed
	recently, I think prior to the last local Election, from Fiona Gdns to the United Reformed Church in Whitefields Rd. This is better for me than
	Fiona Gdns which was a bad location due to lack of access except by the main entrance which involved a long walk round and then walking
	down a long drive for someone without transport. If side access had been available (as I understand it is for residents there,) it would have
	been a reasonable although fairly long walk but it was unreasonably long in my view to go to the front entrance. It should be taken into
	account that not everyone has transport available to them. Although the church on Whitefields Rd is nearer, it is still further than the very
	convenient polling station which I am not allowed to use, at St Mary Magdalene Church, cnr. Moss Lane and Harboro Rd.
	When I telephoned and asked about this originally, I understood that the boundary for polling stations lies along the middle of Ashton
	Lane. Consequently as I live the wrong side, I am not allowed to use St Mary Magdalene Church which is just down the road, but required
	to go a lot further. However lestablished that if lused a postal vote I would be allowed to hand it in at any polling station. I prefer to take
	it rather than post it, as one cannot necessarily rely on the post although in most cases the item would arrive. I would not consider I need a
	postal vote, although I have disabilities, for any other reason apart from the difficulty with the allocated polling station. My suggestion for
	change would therefore be more reasonable allocation so that when there is a polling station nearby one is able to use it.
	I cannot comment otherwise on the choice of the United Reformed Church, not having used it, except that it would seem preferable to
	Fiona Gdns as it is at least adjacent to the road. It seems good to give people shorter distances to go especially in the light of climate change
	and trying to encourage less use of vehicles, as many people like to walk to polling stations anyway if they are close. I do not think places
	with long driveways should be used. As well as difficulties for walkers they can cause congestion for car drivers at busy periods. There are
	various primary schools in this area currently not used, although I cannot comment on their general suitability. When I have used primary
	schools they have seemed to work well but specific ones could conceivably have issues. On the face of it I would have thought a school
	would be better than Fiona Gdns if that is still under consideration. There are schools which would be a lot closer for me.
	As I see that the polling stations are reviewed every 5 years by law, I do feel that when someone calls and makes a point like this, there
	should be a record kept of the call to help with decision making. I knew nothing about the review or that any reviews took place until I
	happened to see it in the newspaper and could easily have missed it, and I have probably been using the postal vote for this reason for over
	5 years and I think I may have mentioned it in other calls, but I am not aware any record has ever been taken of this even when I called
	specifically to see if my polling station could be changed. I was not told then that this would ever be reviewed or that there would ever be a
	chance to contribute to such a review.
	As regards St Mary Magdalene Church, it seems to have all features mentioned to be an ideal polling place, as well as being conveniently
	close to me. It is a pity that the boundary seems to have been decided in rather an arbitrary fashion. However using the postal vote in this

	way does work. I commend the change from Fiona Gdns as with my current mobility issues I think that would certainly have been a major problem for me. Unless one does have a postal vote, there is no choice as to the day of voting, so unless the time involved is kept short, people are going to be discouraged from casting their vote if they are otherwise occupied on the day.
Altrincham	An alternative to St Vincent's is tricky. The former vet's on Clarendon Avenue might serve temporarily as it is currently empty. Would the Leisure Centre be an option when it reopens? Tesco has a community room, but I don't know if they would permit use. There is also a room at the Counselling and Family Centre on Mayor's Road, but how suitable it would be I'm not certain. Looking slightly further afield, I'd suggest the Hub on Pownall Road, or Altrincham Football Club. But they may be too far aw ay.

1. Introduction

- 1.1 The Council remains committed to high standards of health, safety and wellbeing for staff, visitors, contractors, elected members and others who may be affected by our activities. This report covers the period 1 April-30 September 2023 and provides:
 - Key health and safety performance information, highlighting proactive and reactive activities undertaken by the Health and Safety Unit (HSU) working with partners
 - Analysis of incident data
 - Activities and initiatives delivered with partners to support our workforce under the '*EPIC You* Health and Wellbeing Strategy'
- 1.4 HSU provides a targeted proactive programme of interventions to manage existing and emerging risks to the workforce and others affected by the Council's work activities. Work for April-September 2023 included:
 - Continuing to promote the 'Your Safety, Your Wellbeing' health and safety initiative to ensure that colleagues safely finish their working day, every day.
 - Conducting service audits of our North Area Libraries and service specific support for our Supported Living teams and Elections team.
 - Completing comprehensive full audits within our Trafford Schools.
 - Continued joint monitoring of our One Trafford Partnership contracted services
 - Driving forward collaborative improvements to safety and security arrangements within our buildings through the Trafford Internal Security Review Group.
 - Providing a range of face to face health and safety training to 85 colleagues in addition to online training.
 - Collaborative delivery of a range of health and wellbeing activities and opportunities to the workforce under the EPIC You Employee Health and Wellbeing Strategy.
- 1.5 Updates are provided to the relevant Corporate Directors and Joint Consultative Committees.

2. **Proactive audits and support in council services and schools**

2.1 **Council service support**

2.1.1 North area library audits

Service audits are an important active monitoring tool to evaluate statutory compliance and identify areas where improvement to health and safety performance is needed.

During April-September 2023, North Area Libraries were audited on a range of health and safety management issues. The libraries firstly completed a selfassessment questionnaire to provide base level information. Site audits were then completed at each location with the area managers. A comprehensive overall audit report was provided which gave:

- An overarching summary of performance across the north library service as a whole
- A supportive action plan to implement improved health and safety arrangements

The South Area Libraries are now completing the same process with HSU

2.1.2 Supported Living themed interventions.

The service has received a variety of support to develop safety and wellbeing arrangements for staff and service users. This has included:

- Themed health and safety meetings which have focused on risk assessments, accident reporting/investigation and managing volatile behaviour.
- The delivery of face to face moving and handling and fire awareness training.
- Individual service user mobility assessments.

2.1.3 Safe delivery of elections

HSU worked closely with Democratic Services throughout April and early May in a key supportive role to ensure the safe delivery of the election arrangements including the polling stations, receipting and main count.

The team had representation at the weekly elections planning meetings. An event safety management plan was developed and coordinated, risk assessments were in place for each aspect of the elections and the service supported the implementation of security and contingency arrangements.

2.1.4 One Trafford Waste and Recycling Service audit

HSU continue to assist the One Trafford Client Team in monitoring the health and safety performance of Amey delivering our contracted services.

Monitoring was supported through two joint 'crew check' operations in Old Trafford/Stretford and Altrincham/Hale. Waste Services crews were observed to ensure they were following safe working practices. As well as observations, the crews were directly engaged with to discuss working arrangements and for them to raise any issues or concerns. Observations made during the two exercises were very positive.

2.1.5 Managing volatile incidents in our buildings

The Trafford Internal Security Review Group (TISRG) continues to work to review and improve the safety and wellbeing of staff from volatile and aggressive behaviour displayed from visitors and service users within our buildings.

To address the wide scope of work now being covered in managing safety and security, the group has been refreshed and incorporates a wider representation from relevant services and partners within our buildings. The group has now made some significant progress in the development of improved safety and security measures as detailed in Table 1 below:

2.2 Schools Support and SLA Delivery

- 2.2.1 Schools continued to be supported through the health and safety SLA's which in addition to an on-site visit included:
 - Unlimited advice and guidance through our duty officer system.
 - Access to school specific guidance on our SLA portal.
 - Access to a range online health and safety training.
- 2.2.2 The school Health and Safety SLA year 2022-23 closed in August with 80 schools having received competent support. Currently, 80 schools have purchased the Health and Safety SLA for 2023-24, including our community schools. The breakdown of schools is shown in table 2.

2.2.3 For the SLA year 2022-23, a total of 72 schools have received an on-site audit. These were mainly focused on a full management audit option or fire risk assessment (FRA) as required. The breakdown of audit types in shown in table 3.

2.2.4 Specific to our Trafford Community Schools, 37 visits were completed. For our main audits, schools receive a compliance score to indicate their performance. Table 4 shows a breakdown of the types of audits and the score received (where applicable). Where schools receive a fair or poor score, they are fully supported by HSU to work through their prioritised action plan and make the required improvements.

3. <u>Health and Wellbeing Support</u>

- 3.1 The wider HR Service in conjunction with partners and staff groups has continued to deliver a range of interventions for our workforce and promote a wealth of support in line with our *EPIC You* Health and Wellbeing Strategy.
- 3.3 Table 5 summarises the themes and interventions that have been delivered during April to September.

4. <u>Accident statistics</u>

4.1 **Overview**

- 4.1.1 Reviewing incidents and accident data remains an important aspect of our reactive health and safety monitoring arrangements. Tables 6 and 7 provide a breakdown of these incidents by service area, directorate, and type of accident.
- 4.1.2 During the six-month period of this report, we have seen an increase in incidents reported compared to the same period in the previous year. A total of 80 incidents were reported in 2023 compared to 68 incidents in 2022.
- 4.1.3 Some considerations of note in relation to the increase are:



- We have been using improved data and reporting from our security teams to ensure we accurately record incidents within our buildings, particularly around violent and aggressive occurrences.
- We have worked to encourage managers and staff to report incidents of verbal abuse or threats through a 'Don't accept it, Report it' initiative.
- We have continued to promote incident reporting and our online form with schools to ensure incidents are appropriately recorded and submitted to HSU.

4.2 Types of accidents

- 4.2.1 Violence and aggression accounts for most incidents mainly in relation to front line services and schools managing challenging behaviour. An overall upward trend was noted from 43 incidents reported in 2022 to 56 incidents in 2023. The increased incidents noted will in part be due to the improved reporting as detailed in point 4.1.2, but do provide an ongoing area of focus to ensure management strategies proactively reduce this risk and related incidents to staff.
- 4.2.2 Physical assault (including a wide range of physical incidents due to aggressive behaviour) accounted for 44 incidents compared to 35 in 2022. Most of these incidents related to children with challenging behaviour. Schools reported an increase of 11 incidents (35 compared to 24 in 2022). Trafford Transport Provision (TTCU) reported 7 incidents, as reported the previous year. HSU continue to work closely with schools and TTCU on managing and reporting such incidents.
- 4.2.2 There were 12 reported incidents of verbal assault, threats or intimidation compared to 8 reported in 2022. An increase of reports is noted from our Customer Service Team, who we have worked with to ensure that volatile behaviour from the public/service users accessing our buildings is recorded. This data has been vital in supporting the progression of improved physical security work at Trafford Town Hall and Sale Waterside via the Trafford Internal Security Review Group as detailed in section 2.1.5.



4.2.3 Slips and trips accidents accounted for 11 incidents. These involved a variety of circumstances and were not related. Only one report was submitted for moving and handling injuries. A comprehensive moving and handling assessment/training programme continues to be delivered by HSU to support this risk area.

4.3 Rate of reportable injuries to staff

4.3.1 There were four incidents that required a RIDDOR (Reporting of Injuries, Diseases and Dangerous Occurrences Regulations) report to the Health and Safety Executive. These incidents are shown in Table 8

5. Continued delivery of health and safety support services

5.1 Internal Audit: Health and Safety Unit

- 5.1.1 The Council's Audit and Assurance Service completed a review of the Health and Safety Unit as part of their Internal Audit Plan. The findings showed 'Substantial Assurance' in the delivery of the Service with areas reviewed operating in a sound and effective manner.
- 5.1.2 The Health and Safety Unit are progressing the recommendations, including updating current data on team structures/functions to support a refreshed risk profile of Council services and a renewed delivery of a proactive audit programme by the team.

5.2 Your Safety, Your Wellbeing

- 5.2.1 This health and safety initiative has continued to be an integral message as part of our health and safety delivery programme including:
 - A dedicated <u>intranet resource page</u> with bite size guides.
 - Regular communications on key risk and wellbeing issues.
- 5.2.3 A 'team focus' included the work of Care at Home, who made some practical changes to working patterns and reviewed DSE/workstation arrangements to support the health and wellbeing of the team.

5.3 Training

The HSU has continued to work with the Learning and Development Team to directly deliver or procure the following training for the workforce. Details of the training provided are shown in table 9.

5.4 **Requests for service**

HSU have continued to respond to a high level of requests for advice/support and other complaints, incidents or enquiries relating to health and safety at work issues.

5.5 **Display screen equipment (DSE) assessments**

A total of 12 complex DSE (computer) workstation assessments have been carried out by the HSU for employees. These included supporting colleagues working from home and those with more complex health needs.

5.6 **Events consultation**

HSU act an internal consultee for any organised events taking place on Council land. They also provide advice and guidance for events organised by the Council and attend multi-agency safety advisory groups as required. This includes the review of risk assessments and event safety plans for an event to be managed and run safely. A total of 51 events were reviewed during this 6-month period which included community fetes, sporting events, and outdoor productions.

5.7 Moving and handling support

5.7.1 The Moving and Handling Lead continues to deliver a range of support to our Adults and Children's Services to provide staff with the competence and training in moving people safely. This protects both our staff and service users.

5.7.2 As detailed in Table 9, a programme of moving and handling training includes:

- Induction and updates for Ascot House and Care at Home staff.
- Awareness training for all Supported Living staff (includes fire safety awareness delivered in conjunction with the Fire Lead)
- Complex moving and handling assessments as outlined in table 10.

5.8 Fire safety

- 5.8.1 The Health and Safety Advisor (Fire Lead) has continued to deliver a range of fire support to services and schools to ensure we meet our duties under relevant fire legislation.
- 5.8.2 Fire safety evacuation communications have been provided through the year on the arrangements in place.
- 5.8.3 Fire evacuations drills were completed at both Trafford Town Hall and Sale Waterside to test the fire arrangements in place at our main administrative buildings.
- 5.8.4 The Fire Lead completed 24 fire risk assessments at school premises.

6. <u>Conclusion</u>

- 6.1 The report has highlighted a range of health, safety and wellbeing work delivered as part of the HSU work programme. The delivery of proactive audits will continue be a focus both through the school SLA arrangements and also the prioritised service audit programme. The 'Your Safety, Your Wellbeing' health and safety initiative will remain an integral part of promoting positive health and safety culture across the organisation.
- 6.2 Managing violence and aggression is key risk area for the Council. In addition to supporting effective management, reporting and investigation of incidents across services and schools, the Trafford Internal Security Review Group will continue to progress safety and security arrangements within our buildings including the significant physical improvements detailed.
- 6.3 A comprehensive summary and update of the corporate safety and wellbeing programme will be provided in the end of year report.
