The premises has become the location for Manchester United home supporters to congregate before home games at Old Trafford.

The preference of these supporters is to express their support for the team by singing and chanting in the external areas of the pub.

To service the crowds the premises has operated a series of TEN successfully during the 2017/2018 football season to permit the retail sale of alcohol in external areas disseminated from temporary bars.

The operation of such events has been co-ordinated and in consultation with GMP. The operation of TEN in connection with these events has been a success and the Applicant now seeks to vary their premises licence to reflect the use of the external areas, primarily of match days.

In addition the Applicant seeks to draw forward the opening hour of the premises to 9am on Weekends.

The Operating Schedule has been reviewed with the Authorities and some alterations are proposed below which involve the removal and replacement of some existing conditions and the addition of new measures, as detailed below.

A revised licensing plan (4326/001 Rev A) is attached. No structural alterations are proposed. The purpose of the amended plan is to describe the external trading areas which are proposed to be licensed through this application (hatched red).

A copy plan of the premises is enclosed. The plan identifies the licensed area edged in red. Proposed external areas for the retail sale of alcohol are hatched red on the accompanying revised plan 4326/001 Rev A.

For completeness, we enclose a copy of our notice being displayed on site. According to our calculations, the consultation period is due to expire on 20/08/2018. If you have any queries regarding this, please contact us upon receipt.

b) The prevention of crime and disorder

No further risks have been identified which need to be addressed, save as below:

1. Licensable activity in the external areas of the premises, hatched red on deposited plans shall be limited to the retail sale of alcohol for consumption on the premises only.
2. Whenever Manchester United's senior male first team play a competitive football match at Old Trafford, the retail sale of alcohol in the external areas of the premises hatched red on deposited plans shall be subject to the terms of a risk assessed management plan. This plan shall be made available to the responsible authorities upon request.
3. A CCTV system shall be maintained and operated at the premises with cameras positioned both Internal and externally. Recorded CCTV will be maintained and stored for a period of twenty-eight days and shall be produced to the Police or Licensing Authority upon request. CCTV will be in operation at any time a person is in the premises, save for reasonable periods of maintenance or repair. Where CCTV is recorded onto a hard drive system, any DVDs subsequently produced will be in a format so it can be played back on a standard PC or DVD player. Any person left in charge of the premises must be trained in the use of any such CCTV equipment, and be able to produce CCTV images to an officer from a responsible authority upon request.
4. SIA registered door staff shall be employed at the premises in accordance with a risk assessment, to be carried out by the DPS. When employed, door staff will wear high visibility jackets.
5. When employed, a register of those door staff employed shall be maintained at the premises and shall include:
 - i. The number of door staff on duty;
 - ii. The identity of each member of door staff;
 - iii. The times the door staff are on duty.
6. Open containers of alcohol shall not be removed from the premises, save for consumption in any delineated external area.
7. A refusals book will be maintained at the premises, and made available to an officer of a responsible authority upon request.
8. An incident log (which may be electronically recorded) shall be kept at the premises for at least six months, and made available on request to the Police or an authorised officer of the licensing authority, which will record the following incidents including pertinent details:
 - i. All crimes reported to the venue, or by the venue to the Police
 - ii. All ejections of patrons
 - iii. Any incidents of disorder
 - iv. Any faults in the CCTV system
 - v. Any visit by a relevant authority or emergency service
9. The Designated Premises Supervisor shall ensure that a written notice of authority is kept at the premises for all staff who sell alcohol. The notice shall be made available for inspection upon request of the police or an authorised officer of the licensing authority and all staff selling alcohol must be in possession of identification to enable to verify their identity against the notice.


1. A "Challenge 21" Policy shall be implemented in full and appropriate identification sought from any person who appears to be under the age of 21. The only acceptable forms of identification shall be photographic driving licences, passports, HM Forces cards, of a form of identification with the "PASS" hologram.
2. Staff training will include a Challenge 21 Policy and its operation. In particular, staff shall be trained to take such action as is necessary to prevent the sale of alcohol to persons over the age of 18 where those customers are engaged in the distribution of alcohol to persons under the age of 18. The training must be given to a new member of staff before they commence employment and all staff must receive refresher training every year.
3. Notices advising what forms of ID are acceptable must be displayed.
4. Notices must be displayed in prominent positions indicating that the challenge 21 policy is in force.

Notes for Guidance

This application cannot be used to vary the licence so as to extend the period for which the licence has effect or to vary substantially the premises to which it relates. If you wish to make that type of change to the premises licence, you should make a new premises licence application under section 17 of the Licensing Act 2003.

1. You do not have to pay a fee if the only purpose of the variation for which you are applying is to avoid becoming liable for the late night levy

 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
 - Recorded Music: no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
 - Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
 - Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
