# 1.0 Background

- 1.1 The report provides a summary of performance against the Council's Annual Delivery Plan 2012/13 and supporting management information for the period 1<sup>st</sup> October 2012 to 31<sup>st</sup> December 2012 (Quarter 3).
- 1.2 This covers the Council's six Corporate Priorities:
  - A Cleaner, Greener Borough
  - Fighting Crime
  - Improving Health and Wellbeing of Residents
  - Better Roads and Pavements
  - Preserving and Improving Educational Excellence
  - Low Council Tax and Value For Money
- 1.3 The report shows that over ¾ of the Council's indicators (reported monthly or quarterly) are still on target to be achieved, after the first nine months (three quarters) of 2012/13.
- 1.4 There are now 49 indicators, of the total 79 indicators in the ADP, which are on target (green), compared to 46 in second quarter. This includes four of the five annually-reported indicators that have been reported in third quarter.
- 1.5 The number of indicators that are currently more than 10% outside target (red status) has decreased, from 5 to 3, since second quarter. However, there are more indicators that are outside the declared target for the year to date (14 compared to 11 in second quarter).
- 1.6 Where performance targets have not been met exception reports, completed by the relevant Heads of Service, are attached to the report.
