52. APPLICATIONS FOR PERMISSION TO DEVELOP ETC.

(a) <u>Permission granted subject to standard conditions prescribed by statute, if any, and</u> to any other conditions now determined

Application No., Name of Applicant, Address or Site Description

86323/FUL/15 – Cartwright Group – Cartwright Group, Atlantic Street, Altrincham. Roof modifications including locally raising roof level between existing ridges and extension of existing canopy; enclosure of existing yard to create covered internal fabrication area and associated modifications to elevations. 86493/FUL/15 – United Utilities – Sewage Works, Rivers Lane, Davyhulme.

86699/HHA/15 – Mr. & Mrs. Horridge – 35 Dorrington Road, Sale. Application for proposed inlet works. Erection of 30 no. buildings and provision of new site entrance and landscaping works, all associated with Permitted Development works to improve the existing wastewater treatment process to allow compliance with final effluent consent requirements.

Demolition of existing garage and rear additions. Erection of two storey side/rear extension and single storey side extension to eastern side.

Application for variation of condition 11 on permission 82725/FULL/2014 planning (erection of new two storey school building incorporating new carpark (including the erection of floodlighting columns), cycle & scooter parking, internal access road with drop off area and formation of new vehicular access with associated security barriers. Provision of new multi-use games area (MUGA) and all weather pitch with retention and realignment of existing 2 x grass pitches, cricket wickets and running track area and provision of new junior grass pitch. Provision of new bin storage area, relocation of existing

before and after school building and relocation of ancillary storage structures/storage containers. Associated landscaping throughout including provision of new security fencing. Demolition of existing school building.). To allow 107 cycle spaces instead of 210.

53. APPLICATION FOR RETROSPECTIVE PLANNING PERMISSION 86768/HHA/15 – MR. COOKE – 6 LESLIE GROVE, TIMPERLEY

The Interim Head of Planning and Development submitted a report concerning an application for retrospective planning permission for the erection of an outbuilding.

It was moved and seconded that planning permission be refused.

The motion was put to the vote and declared carried.

RESOLVED: That retrospective planning permission be refused for the following reasons:-

The proposed outbuilding, by reason of its size, scale, height, massing and external appearance in close proximity to adjacent properties, would result in an overdominant form of development that would be visually intrusive and detrimental to the amenities of occupiers of neighbouring houses. The proposed development would therefore be contrary to Policy L7 of the Trafford Core Strategy and the Council's adopted Supplementary Planning Document 4: A Guide for Designing House Extensions and Alterations.
