1. Background

- 1.1 The subject of this application is the premises located at 218 Church Road, Flixton M41 9DX which are to be known as The Hideaway (formerly the Barmy Olive). The property is not currently licensed.
- 2. Application for the Grant of a Premises Licence
- 2.1 On 12th September 2014, the Licensing Section received an application (Appendix A) from The Hideaway by Sponge Sisters Limited for the grant of a premises licence for the premises at 218 Church Road, Flixton, M41 9DX.
- 2.2 The application requests the licensable activities of:

Sale of Alcohol (On & Off) the premises from:

Sunday to Thursday

10:00 to 21:00

Friday to Saturday

10:00 to 23:00

Recorded Music (Indoors) from:

Sunday to Thursday

10:00 to 21:00

Friday to Saturday

10:00 to 23:00

- 2.3 The applicant has complied with all requirements under the application process including advertising the application in a newspaper, advertising by way of public notice at the premises and submitting a copy of the complete application to all Responsible Authorities. The application is deemed to be correctly submitted.
- 3. Representations
- Representations against the application have been received from local residents (Appendix B1 – B9).
- 3.2 A representation has been received from the Council's Pollution Team recommending the addition of the following condition should the licence be granted (Appendix C):

"Noise from music and associated sources (including DJs amplified voices) must not be audible to such an extent that it constitutes a nuisance at any noise sensitive properties."

The applicant has agreed to the inclusion of this condition.

- 3.2 The Members will be required to determine the relevance of the representations. When considering the relevance of the representations the Licensing Sub-Committee must apply three rules:
 - the representation must be from a responsible authority or any other i.

it must not be repetitious, vexatious or frivolous; and ii.

it must relate to one or more of the licensing objectives. iii.

Licensing Objectives 4.

- The licensing objectives are: 4.1
 - the prevention of crime and disorder;

public safety;

- the prevention of public nuisance; and
- the protection of children from harm
- The Committee should have regard to the Council's own Licensing Policy 4.1 relating to the licensing objectives and to the Secretary of State's Guidance. (Appendices D & E).

Options 5.

- The Sub-Committee to take such steps as they consider necessary for 5.1 the promotion of the Licensing Objectives in accordance with the provisions of subsection 18(4) of the Licensing Act 2003. The steps specified are:
 - 5.1.1 To grant the licence subject to
 - operating with the consistent Conditions accompanying the application modified to such extent as the authority considers necessary for the promotion of the licensing objectives, and;



- 5.1.2 to exclude from the scope of the licence any of the licensable activities to which the application relates;
- 5.1.3 to refuse to specify a person in the licence as the premises supervisor;
- **5.1.4** to reject the application.
- The Sub-Committee is advised that any findings on any issues of fact 5.2 should be on the balance of probability and any decision should be based on the individual merits of the application.

The Sub-Committee, in arriving at its decision, must have regard to relevant provisions of national guidance and its own statement of licensing policy and reasons should be given for any departure.

- All staff will be advised of the licensing laws in writing before they are allowed to serve alcohol.
- All staff will be trained on the premises' specific policies and records will be kept as to when training took place.

b) The prevention of crime and disorder

- The premises has a burglar alarm fitted which will be activated when the premises are empty.
- All rear access doors to the property are kept locked to prevent intruders.
- The rear of the building has external lighting which is unobtrusive to the neighbours.
- We will have effective security policies which will be formulated in conjunction with the police and shared with all staff members.
- We will follow the Challenge 25 scheme and train staff on how to challenge people, a records will be kept of any challenges made.

c) Fublic safety

- We will carry out regular fire extinguisher checks.
- All equipment will be fully maintained.
- Staff will be fully trained in fire evacuation procedures.
- A fully stocked first aid kit is kept within easy reach at the premises.
- The premises has a fire detection system in place, fire break points and smoke alarms.
- The premises has three clearly marked fire exits.
- The premises will have an accident book.

d) The prevention of public nuisance

• The premises will have signs asking customers to leave in a quiet manner and to respect the neighbourhood.







I write concerning the Club Premises Licence application (Ref: LA0383/14) by the Sponge Sisters regarding The Hideaway, 218 Church Road, Flixton, Manchester, M41 9DX.

It is my opinion as a resident of Church Road, living in a nearby property, that such an application should not be granted.

The reasons for my objection include:

- 1. The proximity of residential property, including a domestic residence immediately next door with the associated noise disturbance with the extended hours of opening and the sale of alcohol.
- 2. There is a total lack of any parking facilities at all for the property, which is on a busy B road, adjacent to a pedestrian (zebra) crossing. There is already a problem with illegal parking on forbidden zones including yellow lines and on zig zag areas adjacent to the crossing when people frequent the existing businesses in the area. Granting licence to another business will only serve to make such a problem worse, with the problem being over an extended day.
- 3. There is already a litter problem on Church Road associated with the existing take away businesses. Extending the existing opening hours with the associated increase in trade will also compound this problem.

On 28th September 2014 at 14.00hrs a woman (her name is jo) knocked on the door of my home and started to rant at me regarding local residents that had been objecting to the application for a licence, submitted to the licensing section of Trafford Council to allow the sale of alcohol and the playing of recorded music, at the premises now called The Hideaway, it was most disturbing, because I had not objected to the granting of any Licence. The woman said she was advised by a member of the licensing team (Janet Taylor) to speak to the local residence and get them to withdraw their objections so that the licence would be granted, she was also advised to apply for the late licence even thought she didn't want to open late, this is unacceptable. I have seen this woman and her partner knocking on the neighbours doors, I also know that she has spoken to my landlord trying to persuade him not to resubmit his objection. When I didn't accept what she saying the woman's demeanour became aggressive and I felt threatened by her, she retorted "the licence would be granted anyway" and i should get myself a solicitor. I mind my own business at home and I object to being confronted in this manner. In my experience once a licence is issued to those inexperienced with the night time economy the misery of crime, noise and nuisance to local residents and others is far more difficult to deal with. The application may also be a means to enhance the future use of the premises if granted, in my opinion the premises would be suited as they firstly proclaimed a quiet afternoon tea and cake shop.

The grounds for my objection are as follows-:

- 1. Licensing and Human Rights
 - Right to -: liberty and security
 - Right to -: respect for private and family life
 - Protocol 1 of article 1: Protection of property -: Every legal person is entitled to the peaceful enjoyment of his possession page 36

- 2. Licensing Objectives
 - · Prevention of crime and disorder
 - Public safety
 - Prevention of public nuisance
- 3. The Local Government (Miscellaneous Provisions) Act 1976
 - Local Authorities to require the provision of sanitary appliances and associated facilities for use by the public (especially where food and drink is consumed on the premises).
 - In the interests of good hygiene, where food is prepared on the premises, it is preferable that staff WCs be accessible by employees only.

4. The Health Act 2006

· Smoke free Premises and Places.

Where people are not allowed to smoke in doors, they smoke outside this smoke then becomes harmful passive smoke inhaled by anybody in close proximity.

I have taken the trouble to research some of the many reports issued which highlight the need for the police and local authorities to take a hard stance in preventing alcohol being the common denominator for abuse, crime, nuisance and recently on the streets of Urmston the brutal murder of a young man.

Please see below some extracts that highlight the commitment and necessary steps needed to be taken.

North West Public Health Observatory

• The recently published White Paper, Healthy Lives, Healthy People, sets out the strategy for public health in England and highlights the significant impact of alcohol on society. According to the National Audit Office, over 10 million adults in England drink more alcohol than the recommended daily limit, with the House of Commons Health Committee reporting that 2.6 million of them are drinking more than twice this. The risks of alcohol misuse are well established and place a huge burden on the NHS at an estimated cost of around £2.7 billion a year. The number of hospital admissions attributable to alcohol misuse was 1.1 million in 2009/10, a 100% increase since 2002/03. Alcohol misuse also contributes to 1.2 million incidents of violent crime a year, 40% of domestic violence cases and 6% of all road casualties.

Health and social care information centre. (hscic)

- The Public Health Responsibility Deal was formally launched in March 2011. It challenges businesses and other organisations to play their role in creating an environment that supports people to make informed, balanced, healthier choices.
- Around 125 companies are signed up to alcohol pledges that support the overall commitment to help people drink within the guidelines.
- Industry has already taken action, making pledges in a range of areas.
- This includes a pledge to give consumers a wider choice of lower strength products to help take one billion units out of the market by 2015, over 30 companies are signed up; and a pledge that 80% of bottles and cans will have health and alcohol unit information clearly labelled by the end of 2013 with 92 companies signed up.

• The focus going forward will be to deliver the existing pledges; however, we will strengthen these while focusing on areas that will make the biggest difference such as the industry's pledge to remove one billion units of alcohol from the market by 2015. This would be a drop of around 2% of units of alcohol sold. It is estimated that in a decade, this will result in many hundreds fewer alcohol-related deaths; many thousands fewer hospital admissions and alcohol-related crimes, as well as substantial savings to health services and crime costs each year.

The Greater Manchester Alcohol Strategy 2014-2017

 Alcohol is everybody's business. It is a cross- cutting issue that concerns the health and wellbeing of our residents, the safety of our communities, and the future success of our town centres and their night-time economies.

If Trafford Council is really committed to the Greater Manchester Alcohol Strategy 2014-17 the health and well-being of residents and the safety of communities then the granting of this licence will be refused. The proximity of this area is already well served for dinning out, take away meals and alcohol, by: The Roebuck, Peter Pan, Rainbow and two off license.



The Rainbow (214) is a well established business open six nights a week. Tuesday they are closed, on this day I can open my windows without my home and personal effects being polluted with the obnoxious cooking smells of fish, chicken and garlic, the extraction fan is located directly adjacent to my bedroom and bathroom windows only feet away. All my windows are closed tightly at all other times unfortunately this doesn't stop the constant whirling noise generated by the extraction fan motor this has to be tolerated from about one o'clock in the afternoon until closing time after 2300hrs and later at weekends. Then I get the cleaning up noise the bashing of the bush and mop on skirting boards the constant trips outside to the outside storage facility. During the course of any open evening there will be the constant flow of customers on foot, in cars and motorbikes often stood outside talking, shouting and smoking or sat in their cars playing their favourite music at full blast often parked on the restricted zig zag crossing or blocking my right of way and service entrance to the rear of the premises. Finally all this settles down sometime after midnight then I'm just left with the ringing in my ears (I suffer from tinitus). On nice days in the afternoon I'm unable to enjoy the peacefulness of an outside area.

The Barmy Olive 218 Church Road was relatively new when I moved to and has become more established over the years attracting more and more customers particularly at the weekends, tables and chairs are set out to the front of the premises. The proprietors arriving at 5.30 every morning with the banging of car doors and then all the smells and noises you would expect from a busy kitchen, polluting and resonating thought the real estate. Unfortunately there is nowhere to park at the Barmy Olive so customers again park on the restricted zig zag crossing directly in front of the premises causing great danger to children, families and the elderly, who may be trying to safely cross a busy road, the customers resort to blocking my access and any other emergency vehicles that would require access. On one occasion I had to contact the police so that I could exit the premises the premise the premises the premise the premise the premise the premise that the premise the premise that t

had to be somewhere important, on an another occasion I was verbally abused and threatened when I informed a customer that it was private parking the customers are sat out to the front of the premises this generates a loud hub hub of coming and going, cooking smells and smoking smells all of this disturbing my weekend peace.

My nature is not to complain but to tolerate with little fuss, the premises were only built to tolerate domestic noise and not any kind of acoustic music the real estate was built for residential purposes only, to grant a licence anytime after 6 o'clock in the evening would be an infringement of my human rights, for me to enjoy some kind of relaxation in the evening before any early start I may have the next day. Due to recent traumatic events I'm unable to find full time permanent employment, I take medication for anxiety and depression which my doctor described as severe, I also require medication to sleep at night. My tolerance is at its limit and any further aggravation will be detriment to my health and well-being. Moving is not an option because I live near my children.



The application proposes that alcohol will be sold for consumption between the hour of 10am and 9pm and 10am and 11pm at the weekend seven days a week. APPENDIX D

Secretary of State's Guidance

PUBLIC NUISANCE

- 2.32 The 2003 Act requires licensing authorities (following receipt of relevant representations) and responsible authorities, through representations, to make judgements about what constitutes public nuisance and what is necessary to prevent it in terms of conditions attached to specific premises licences and club premises certificates. It is therefore important that in considering the promotion of this licensing objective, licensing authorities and responsible authorities focus on impacts of the licensable activities at the specific premises on persons living and working (including doing business) in the vicinity that are disproportionate and unreasonable. The issues will mainly concern noise nuisance, light pollution, noxious smells and litter.
- 2.33 Public nuisance is given a statutory meaning in many pieces of legislation. It is however not narrowly defined in the 2003 Act and retains its broad common law meaning. It is important to remember that the prevention of public nuisance could therefore include low-level nuisance perhaps affecting a few people living locally as well as major disturbance affecting the whole community. It may also include in appropriate circumstances the reduction of the living and working amenity and environment of interested parties (as defined in the 2003 Act) in the vicinity of licensed premises.²
- 2.34 Conditions relating to noise nuisance will normally concern steps necessary to control the levels of noise emanating from premises. This might be achieved by a simple measure such as ensuring that doors and windows are kept closed after a particular time in the evening to more sophisticated measures like the installation of acoustic curtains or rubber speaker mounts. Any conditions necessary to promote the prevention of public nuisance should be tailored to the style and characteristics of the specific premises. Licensing authorities should be aware of the need to avoid unnecessary or disproportionate measures that could deter events that are valuable to the community, such as live music. Noise limiters, for example, are very expensive to purchase and install and are likely to be a considerable burden for smaller venues.
- 2.35 As with all conditions, it will be clear that conditions relating to noise nuisance may not be necessary in certain circumstances where the provisions of the Environmental Protection Act 1990, the Noise Act 1996, or the Clean Neighbourhoods and Environment Act 2005 adequately protect those living in the vicinity of the premises. But as stated earlier in this Guidance, the

approach of licensing authorities and responsible authorities should be one of prevention and when their powers are engaged, licensing authorities should be aware of the fact that other legislation may not adequately cover concerns raised in relevant representations and additional conditions may be necessary.

- 2.36 Where applications have given rise to representations, any necessary and appropriate conditions should normally focus on the most sensitive periods. For example, music noise from premises usually occurs from mid-evening until either late evening or early morning when residents in adjacent properties may be attempting to go to sleep or are sleeping. In certain circumstances, conditions relating to noise in the immediate vicinity of the premises may also prove necessary to address any disturbance anticipated as customers enter and leave.
- 2.37 Measures to control light pollution will also require careful thought. Bright lighting outside premises considered necessary to prevent crime and disorder may itself give rise to light pollution for some neighbours. Applicants, licensing authorities and responsible authorities will need to balance these issues.
- 2.38 In the context of preventing public nuisance, it is again essential that conditions are focused on measures within the direct control of the licence holder or club. Conditions relating to public nuisance caused by the anti-social behaviour of customers once they are beyond the control of the licence holder, club or premises management cannot be justified and will not serve to promote the licensing objectives.
- 2.39 Beyond the vicinity of the premises, these are matters for personal responsibility of individuals under the law. An individual who engages in antisocial behaviour is accountable in their own right. However, it would be perfectly reasonable for a licensing authority to impose a condition, following relevant representations, that requires the licence holder or club to place signs at the exits from the building encouraging patrons to be quiet until they leave the area and to respect the rights of people living nearby to a peaceful night.
- 2.40 The cumulative effects of litter in the vicinity of premises carrying on licensable activities can cause public nuisance. For example, it may be appropriate and necessary for a condition of a licence to require premises serving customers from take-aways and fast food outlets from 11.00pm to provide litter bins in the vicinity of the premises in order to prevent the accumulation of litter. Such conditions may be necessary and appropriate in circumstances where customers late at night may have been consuming alcohol and be inclined to carelessness and anti-social behaviour.

APPENDIX E

Trafford Council - Licensing Policy 2011-2014

7.0 LICENCE OBJECTIVE - THE PREVENTION OF PUBLIC NUISANCE

7.1 Licensed premises have a significant potential to impact adversely on communities through public nuisances which can arise from their operation.

The Council recognises the need to prevent public nuisance to residents, visitors and other businesses from the potential consequence of the operation of licensed premises, whilst balancing the rights of licensed premises to develop their business potential.

- 7.2 Public nuisance in this context includes such issues as noise and disturbance, light pollution, odour, vermin and pest infestations, accumulations of refuse and litter, and anti-social behaviour, where these matters impact on those living, working or otherwise engaged in normal activity in an area.
- 7.3 The Council, however, recognises that licensing law is not a mechanism for the general control of anti-social behaviour by individuals once they are away from the premises and therefore beyond the direct control of the individual, club or business holding the licence.
- 7.4 Applicants will be expected to demonstrate in their operating schedule that suitable and sufficient measures have been identified and will be implemented and maintained with the intention of preventing public nuisance.
- 7.5 In considering applications, the Council will expect to see evidence that the applicant has identified matters that impact on the likelihood of public nuisance and that these matters have been addressed in the operating schedule. Such measures may include:
 - Measures taken or proposed to be taken to prevent noise and vibration escaping from the premises or the immediate vicinity of the premises and including any outside areas (including smoking areas) bearing in mind the location of premises and proximity to residential and other noise sensitive premises (e.g. hospitals, hospices and places of worship); This would include music, ventilation equipment noise and human voices, whether or not amplified;
 - Measures taken or proposed for management and supervision of the premises and associated open areas to minimise unreasonable disturbance by customers and staff arriving or departing from the premises and delivery of goods and services.
 - Control of opening hours for all or part (e.g. garden areas) of the premises

- Measures taken to control light to ensure that it does not stray outside the boundary of the premises such as to give rise to problems to residents in the vicinity
- Steps taken to lessen the impact of parking in the local vicinity
- Measures taken to prevent someone who has consumed excess alcohol from entering the premises and to manage individuals on the premises who have consumed excess alcohol
- Management arrangements for collection and disposal of litter and refuse, and the control of pests
- Arrangements for ensuring that adequate and suitably maintained sanitary provision and washing facilities are provided for the number of people expected to attend any premises or events
- A 'wind down time' after the last service of alcohol, during which time the venue may offer for sale non-alcohol beverages
- A 'last admission time' policy
- Management arrangements for any proposed use of bonfires, fireworks and other pyrotechnics.
- 7.6 The extent to which the above matters need to be addressed will be dependent on the nature of the area where the premises are situated, the type of premises concerned, the licensable activities to be provided, operational procedures and the needs of the local community. In general, however, the Council will expect more comprehensive measures to be in place at late night entertainment venues or in premises with a history of public nuisance issues.
- 7.7 The Council will have regard to representations from the responsible authorities to determine if measures proposed are sufficient to reduce the risk of public nuisance. Where representations indicate that any matter has not been addressed sufficiently to prevent public nuisance the applicant will be expected to demonstrate that the issues can be satisfactorily addressed before the Council will grant an application for a licence or a variation.
- 7.8 Where appropriate the applicant will be expected to propose practical steps to prevent disturbance to local residents and to have regard to the "Good Practice Guide on the Control of Noise from Pubs and Clubs" produced by the Institute of Acoustics. Where noise has been identified as a potential problem by the applicant or Council officers, then the Council would expect the applicant to detail the measures proposed to address this issue within the operating schedule. Noise could relate not only to music but also from air handling equipment or from patrons. There are a number of practical ways in which sound leakage can be addressed, such as:

- Keeping doors and windows closed and providing adequate mechanical ventilation or, if necessary, air conditioning
- Reducing sound levels and installing a sound limiting device to prevent sound exceeding the appropriate level
- Installing soundproofing measures to contain sound and vibration.
- 7.9 In premises where patrons leave the premises particularly late at night or early in the morning, the Council will expect the applicant to have included in the operating schedule practical steps for reducing noise disturbance, such as:
 - Erecting prominent notices at the exits to premises asking customers to leave quietly and not to slam car doors, and to respect the rights of nearby residents
 - At appropriate times making loudspeaker announcements to the same effect
 - Instructing door staff to ask customers leaving the premises to leave the area quietly
 - Reducing the volume of music towards the end of the evening and where appropriate playing quieter, more soothing music as the evening winds down
 - Banning from the premises people who regularly leave in a noisy manner
 - The supervision of any queues formed late in the evening so as to keep noise and disturbance to a minimum.
- 7.10 Where relevant representations have been received, conditions may be imposed which include restrictions on the times when music or other licensable activities may take place and may include technical restrictions on sound levels at the premises.
- 7.11 In considering an application, the Council will take into account previous noise and nuisance complaints, and the ability/willingness of the licensee to deal with such complaints.
