#### 1. Background

1.1 Premises Licence PL000667 (Appendix B) – for Hale Country Club, Clay Lane, Hale is currently held by Hale Country Club Limited, 47 Clay Lane, Timperley, WA15 7AF.

#### 2. Application for the Grant of a Premises Licence

- 2.1 On 20<sup>th</sup> September 2017 the Licensing Section received an application (**Appendix A**) from Eversheds Sutherland, Solicitors acting for Hale Country Club Limited for the grant of a variation to the existing premises licence.
- 2.2 The current licence permits the following licensable activities on the premises:

Playing of recorded music	10.00 to 24.00	Mon to Sun
Late night refreshment (indoors)	23.00 to 24.00	Mon to Sun
Sale of alcohol (On and Off)	10.00 to 24.00	Mon to Sun

2.3 The application requests a variation to the licence to add the following licensable activities:

Live music	10.00 to 24.00	Mon to Sun
Performance of films	10.00 to 24.00	Mon to Sun
Performance of dance and similar entertainment	10.00 to 24.00	Mon to Sun

- 2.4 The application also requests that all the above activities be extended outside the premises to include the external area shown on the attached plan at Appendix A. The licence would permit the provision of licensable activities within that external area on no more than 10 occasions.
- 2.5 The application also requests an amendment to the wording of condition 3 annex 3 to the licence.

The current wording of condition 3 is:

All external doors and windows shall be kept closed when regulated entertainment is being provided except in the event of an emergency.

The proposed wording of the replacement condition is:

All external doors and windows shall be kept closed when regulated entertainment is being provided inside the premises except in the event of an emergency.

2.6 The applicant has complied with all requirements under the application process including advertising the application in a newspaper, advertising by way of public notice at the premises and submitting a copy of the complete application to all Responsible Authorities. The application is deemed to be correctly submitted.

#### 3. Representations

3.1 On the 13<sup>th</sup> October 2017 the Licensing Section received a representation against the application from the Council's Environmental Pollution Team on the grounds of prevention of public nuisance. See attached Appendix C.

#### 4. Licensing Policy and Guidance

4.1 The Committee are respectfully referred to the Council's own Licensing Policy relating to the Licensing Act 2003 objectives and to the Secretary of State's Guidance. (Copy available at meeting)

#### 5. Options

- 5.1 The Sub-Committee to take such steps as they consider necessary for the promotion of the Licensing Objectives in accordance with the provisions of subsection 18 (4) of the Licensing Act 2003. The steps specified are:
  - **5.1.1** To grant the licence subject to-
    - Conditions consistent with the operating schedule accompanying the application modified to such extent as the authority considers necessary for the promotion of the licensing objectives, and;
    - Any mandatory conditions which must be included under the Licensing Act 2003
  - **5.1.2** to exclude from the scope of the licence any of the licensable activities to which the application relates;
  - **5.1.3** to refuse to specify a person in the licence as the premises supervisor;
  - **5.1.4** to reject the application.
- 5.2 The Sub-Committee is advised that any findings on any issues of fact should be on the balance of probability and any decision should be based on the individual merits of the application.
- 5.3 The Sub-Committee, in arriving at its decision, must have regard to relevant provisions of national guidance and its own statement of licensing policy and reasons should be given for any departure.

- 4. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 5. For the purposes of the condition set out in paragraph 1:
  - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
  - (b) "permitted price" is the price found by applying the formula

$$P = D + (D \times V)$$

#### Where

- (i) P is the permitted price
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol

and

- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence
  - (i) the holder of the premises licence
  - (ii) the designated premises supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

- 6. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 7. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

#### **ADDITIONAL MANDATORY CONDITIONS (1st October 2014)**

- 8. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises
  - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purposes of encouraging the sale or supply of alcohol for consumption on the premises:
    - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to:
      - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
      - (ii) drink as much alcohol as possible (whether within a time limit or otherwise)
    - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective
    - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective
    - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner
    - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of

- 9 The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 10 (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:
    - (a) a holographic mark

or

- (b) an ultraviolet feature
- 11. The responsible person must ensure that:
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
    - (i) beer or cider: ½ pint
    - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - (iii) still wine in a glass: 125 ml; and
  - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
  - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available

#### Annex 2 - Conditions Consistent with the Operating Schedule

- 1. Staff shall receive appropriate and adequate training with regard to the sale of alcohol to those under age and those who are intoxicated.
- 2. Escape routes and exits shall be kept unobstructed, in good order and free from trip hazards.

3. Anyone who appears to be under the age of 18 and who is attempting to buy alcohol shall be required to produce 'proof of age' before such sale is made.

Annex 3 – Conditions Attached After a Hearing of the Licensing Committee

- 1. Use of beer gardens or outside areas as outlined in red on the enclosed plan should not be permitted beyond the 23:00 hours.
- 2. Noise from music and associated sources (including DJs and amplified voices) must not be audible to such an extent that it constitutes a nuisance at any noise sensitive properties.
- 3. All external doors and windows shall be kept closed when regulated entertainment is being provided except in the event of an emergency.
- 4. There shall be placed at all exits from premises in a place where they can be seen and easily read by the public (or member and their guests) notices requiring customers to leave the premises and the area quietly.
- 5. No fireworks or other pyrotechnics shall be used other than with the prior consent of the Licensing Authority.

The Application to Vary Premises Licence (PL 000667) under the Licensing Act 2003 for the above premises has been reviewed.

The application seeks to:

- 1. Add licensable activities to permit within the boundary of the premises the provision of Live Music, exhibition of Films, Performance of dance and similar entertainment between 10.00am and Midnight.
- 2. Approve an extension of the licence boundary to include the external area as identified in the application to permit the provision of licensable activities within that area on no more than 10 occasions in a calendar year.
- 3. Amend condition 3 of Annex 3.
- 4. Include new conditions to apply in respect of outside events.

There are a number of conditions on the current premises licence PL 00067 which are aimed at the prevention of public nuisance to residents who live within the vicinity of the site.

There has been a history of noise complaints relating to external events at this and other similar premises in the Borough, in particular, where marquees have been used. Indeed, a noise abatement notice was required to be served under the provisions of the Environmental Protection Act 1990 in 2008 on the site adjacent to Hale Country Club due to the significant noise and disturbance caused to local residents by a live music event being held on the site.

The Pollution Section objected to a similar application on the Hale Country Club site in 2011 and does not consider that noise from such external regulated entertainment events can be adequately controlled so as to prevent public nuisance. Certainly, amplified music being played in an external area with minimal mitigation and exacerbated by the playing of low frequency bass beat music; can cause serious impact and intrusion particularly during the spring / summer months when it is not unreasonable for local residents to open their windows for ventilation purposes.

Therefore, the Pollution section objects to the above variation on the grounds of public nuisance.
