Additional Conditions

CCTV signs be clearly placed in the outside area and bar area where they can be easily seen and read.

Signs to be placed to notify that any drinks or food shall <u>not</u> be consumed in the outside area after 21:00.

That smoking by customers in the outside area is restricted to the patio, as per the agreed attached plan, after 21:00.

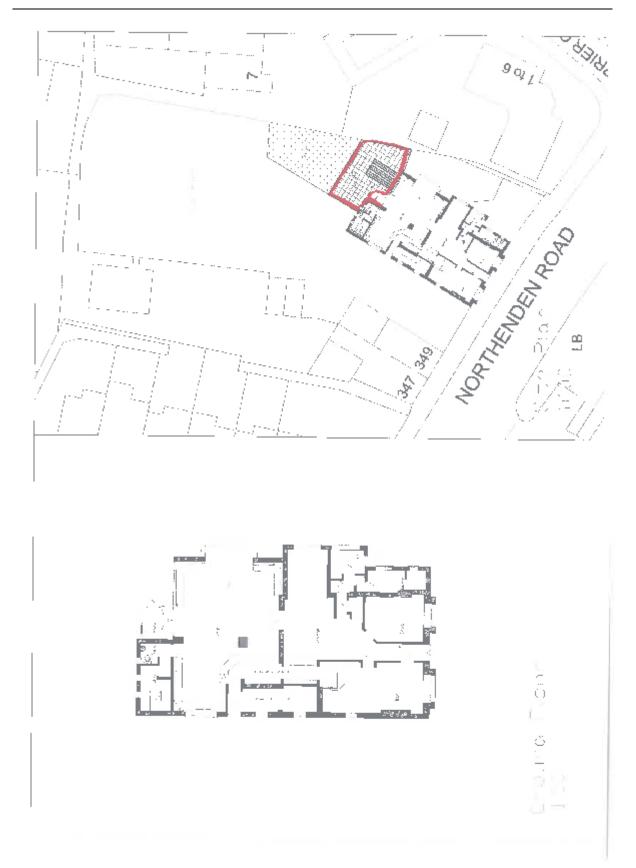
LICENSING SUB-COMMITTEE'S REASONS FOR REACHING ITS DECISION
