Report Title

OBJECTION FROM GREATER MANCHESTER POLICE TO A TEMPORARY EVENT NOTICE ISSUED FOR UNIT 1, WHARFSIDE, TRAFFORD WHARF ROAD, TRAFFORD PARK, M17 1EX

Summary

To consider whether or not to accept the objections from Greater Manchester Police and to decide whether to issue a counter notice under section 105 of the Licensing Act 2003.

Recommendation(s)

Having regard to the objection notice, consider whether it is necessary to accept the objection, and if the authority does accept the objection, to give the premises user a counter notice under section 105 of the Licensing Act 2003.

1.0 BACKGROUND

- 1.1 Part 5 of the Licensing Act 2003 provides a system of permitted temporary activities, under which licensable activities can be carried out on a temporary basis (for a period not exceeding 168 hours) without the need for a premises licence or a club premises certificate.
- 1.2 These activities can take place on any premises by the authority of a Temporary Event Notice (TEN) given by an individual, a 'premises user', to the relevant Licensing Authority.
- 1.3 No permission is required from the Licensing Authority and only the Police and Environmental Health may intervene with a view to preventing such an event going ahead or to modify the arrangements for it.
- **1.4** A Temporary Event Notice must be given to the authority at least 10 working days before the event and a copy of the notice must also be given to the Police and Environmental Health.
- 1.5 Where the Police or Environmental Health are of the view that allowing the event to proceed would undermine the licensing objectives, they must, within three working days of receiving the TEN, give an objection notice to the premises user and the licensing authority, giving reasons for their decision.
- 1.6 If the Police or Environmental Health object to a TEN, the licensing authority must hold a hearing to determine whether or not it accepts the objections. Where the authority accepts the objections, it must issue a counter notice to the premises user in which case the event cannot proceed.

2.0 TEMPORARY EVENT NOTICE

On the 19 August 2021, the Premise User, Mr Greg Mcavoy served a Temporary Event Notice on the Licensing Authority for premises known as Unit 1, Wharfside, Trafford Wharf Road, Trafford Park, M17 1EX, a copy of which is attached as **Appendix A**.

2.1 Details of Temporary Event Notice:

Date: 11 September 2021

Times: 11:00 – 23:00

Location: Premise is adjacent to Old Trafford tram stop, the car park area will

be used where an outdoor canopy will be erected

Activities: Sale of Alcohol (On & Off) and Recorded Music

2.2 On 20 August 2021, An objection to the notice under the prevention of crime and disorder licensing objective was received from Greater Manchester Police. A copy of which is attached at **Appendix B**.

3.0 OPTIONS

- 3.1 The TEN can be modified by changing the details of the parts of the premises that are to be used for the event, the description of the nature of the intended activities or their duration.
- 3.2 The 2003 Act provides that only the Licensing Authority can impose conditions to a TEN from the existing conditions on the premises licence or club premises certificate at the venue. There is not a premises licence in place, which means conditions cannot be added.
- 3.3 The Sub-Committee is requested to consider the objection notice, and consider whether it is necessary for the promotion of the licensing objectives to accept the objection; and if the Licensing Authority does accept the objections, to issue the premises user a counter notice under section 105 of the Licensing Act 2003.

Your Representation

Please accept this as formal notification of the Greater Manchester Police objection to the Temporary Events Notice in relation to the premises, Unit 1 Wharfside, Trafford Wharf Road, Trafford Park, Manchester M17 1EX on the grounds of Prevention of Crime and Disorder and the Prevention of Public Safety,

The notice is seeking to allow the premises to operate and include the sale of alcohol for a maximum of 499 people on Saturday 11th September 2021 a day where Manchester United vs Newcastle United football match is occurring at Manchester United Football Ground, Old Trafford. The notice requests alcohol to be consumed on and off the premises.

On 24th May 2002 a Designated Public Space Order was granted to Trafford which was a provision for combatting alcohol related disorder in a designated public place. This legislation was replaced by the Anti-Social Behaviour, Crime and Policing Act 2014 which introduced Public Spaces Protection Orders (20th October 2014). The transition period allowed for the DPSO to stay as it was for three further years, at which point it converted to a Public Space Protection Order. On 15th October 2020, following a public consultation, the order was extended for a further three year period until 15th October 2023

This order was obtained to prevent alcohol related issues / street drinking and allows a constable to dispose of anything surrendered to him in such a manner as he considers appropriate. A person who fails without reasonable excuse to comply with a requirement imposed on him commits an offence and is liable on conviction to a fine.

In the likely event that a customer leaves the premises and is seen by a constable to be carrying alcohol, this is likely to cause disorder when the constable requests the surrender of that alcohol

The applicant has not satisfactorily demonstrated how they will deal with the potential issue of customers who may attempt to leave the premises with an open vessel into an area where a Public Space Protection Order exists. The applicant has requested off sales. It is a possibility those leaving this venue with alcohol are attending the football game and will therefore be in breach of the Public Space Protection Order

The applicant has failed to demonstrate the following points.

 How they will deal with customers who are intoxicated, disorderly or threatening and are attempting to be served alcohol from within the premises when there has been no confirmation that sufficient Sia door staff will be employed to maintain order within the premises at all times.

- In what vessels alcohol will be served. In the event alcohol is consumed on the premises or removed from the premises in open glass / cans, this is likely to affect public safety should that vessel be used as a weapon in a violent situation.
- How will the venue manage the 499 capacity? Will the venue operate as a ticket event, how will the venue know when they have reached capacity.
- Who will be permitted into this venue? Will the venue accommodate home and away supporters with the potential of disorder occurring if the two supporting teams are within the same venue?
- How will they prevent alcohol being sold or consumed by under 18's?
- Will CCTV be in operation recording throughout the day to capture incidents if they occur

The Government introduced Temporary Events to make a provision for small scale one off events, or situations where Premises Licences do not meet the need of a particular function, however Greater Manchester Police conduct a robust policing operation on match day events at Old Trafford to ensure the day passes peacefully with as little disruption as possible to the community and business in the Trafford District

The lack of information on this notice leads GMP to believe that they have not anticipated any problems or how they would deal with those problems if they occurred.

Greater Manchester Police therefore request that this notice is refused.
