Civic Quarter Heat Network - Approval to Accept Green Heat Network Fund Grant

- (1) That the contents of the report, be noted.
- (2) That the Executive approves accepting the grant if Trafford Council's application is successful, and moving to the commercialisation phase of work, noting that a final decision to proceed will be taken once this phase has completed.
- (3) That the Corporate Director of Place, in consultation with the Director of Finance and the Director of Legal and Governance, be delegated authority to accept the Green Heat Network Fund grant if awarded at the level submitted.
- (4) That the Corporate Director of Place, following consultation with finance, legal and procurement, be delegated authority to carry out a procurement exercise to identify commercialisation advisers and a third-party delivery partner, and take all other necessary steps to develop the project prior to approval of a Joint Development Agreement.
- (5) That a further report be made to the Executive to seek approval of the Joint Development Agreement.

### REASONS FOR THE DECISION

A key rationale for the heat network is carbon savings, especially with the scope for expanding the network beyond the Civic Quarter. In addition, a significant benefit of the scheme is that supplying heat from a central low carbon source will greatly lower the strain on the electricity grid compared to having individual electric heating in buildings.

Another significant benefit is the potential for future expansion. The Trafford Civic Quarter sits within one of a number of identified heat network zones in Greater Manchester. There is considerable scope for expansion by connecting the Civic Quarter network to other nearby networks that could also be developed, such as Trafford Wharfside or into Trafford Park. The scheme could even be part of a much greater movement of heat from large sources in the west, such as Carrington Power Station and Davyhulme Water Treatment Works, through Trafford and on in to central Manchester. From discussions with potential heat network delivery partners, we know that there is considerable interest in this scheme because of the expansion potential.

Other benefits are that the construction of the network will provide green jobs. There is also a presentational benefit to having such a flagship scheme as part of the Civic Quarter development.

This approach will allow the Council and partners to focus efforts on securing additional capital funding to implement the proposals within the TEP study, whilst capturing and communicating site management within a dedicated management plan that places an emphasis on resource-efficient, low-cost interventions with added capacity via environmental partners plus community groups and volunteers.

The new Operating Agreement reflects the outcomes of the SOPM and puts in place new fit for purpose governance and contractual arrangements to ensure effective monitoring and compliance of the Leisure Provider in the delivery of the Councils strategic priorities.

Council Tax Support Scheme 2025-26 – Proposed Scheme Following Consultation

- (1) That the outcomes of the consultation process and the Equality Impact Assessment both of which have supported and informed the final recommendations, be noted.
- (2) That the proposals contained in the report to change the Council's Council Tax Support working age scheme from 1 April 2025, be approved.

## REASONS FOR THE DECISION

The changes to the Council's Council Tax Support Scheme are proposed so that the scheme is easier to understand and administer and is a simplified claims process for working age residents in receipt of welfare benefits who have been moving, and will continue to now move at pace, on to Universal Credit.

### ALTERNATIVE OPTIONS CONSIDERED AND REJECTED AT THE MEETING/BY MEMBERS

The Council could have considered not making changes to the CTS Scheme however this would mean that the scheme would remain complex to administer, difficult to understand the calculations, not align to Universal Credit and not be able to benefit from digital automation which will speed up processing of new claims and changes in circumstances.

The Council considered a number of different options before consulting on the proposed option. The Council has carefully considered the feedback gathered throughout the consultation period and have made changes to reflect some of the main concerns raised as explained in part 4 of the report.

Overall the Income-banded scheme, with the changes made following consultation, offers the most advantages to both residents and the Council as it will be easier for those receiving UC to understand, a simpler means test and lower administrative costs, with a Discretionary Council Tax Support Scheme in place to ensure any residents who require additional support can apply to request this as well as some transactional protection for large families in 2025-26.
