## **Background**

Section 249 of the Local Government Act 1972 provides that the title of Honorary Alderman may be conferred by the Council on persons who have, in its opinion, rendered eminent service to the Council as past Members of this Council, (or a predecessor Council), but who are no longer Councillors. The title is to be conferred by a resolution passed by not less than two thirds of the Members voting on it at a meeting of the Council specially convened for the purpose.

Any Member of Council may nominate an ex-Councillor for the role of Honorary Alderman. The appointment of Honorary Alderman is to confer recognition on previous Councillors who, over a period of time, have made a significant contribution to the Council in particular and public service. They should meet the following criteria in that they:-

- No longer hold the position of Councillor;
- Must have served for a minimum of 20 years on the Council;
- Must have rendered eminent services during their time on the Council;
- Must have made a significant contribution to the Council and the people it represents; and
- are no longer politically active.

Conferring the title of Honorary Alderman entitles the recipient to be invited to attend Council meetings in a nonparticipating capacity and to attend and take part in other civic ceremonies such as Civic Sundays and Remembrance Sundays and other appropriate civic events.

Councillor Tom Ross, Leader of Trafford Council and Councillor Nathan Evans, the Conservative Group Leader on the Council have respectively proposed that former Councillors Walsh and Myers be conferred the status of Honorary Alderman and have submitted the following in support of their nominations:

## **MR. LAURENCE WALSH**

Former Councillor Laurence Walsh served the Gorse Hill community as a Talbot Ward and then a Gorse Hill Ward representative for 24 years. He has been a strong voice for his community throughout and a keen volunteer in the local community and has supported many community projects over the years such as working with young people, the homeless, “Fun day’s in Gorse Hill Park” and “Litter Picks” in Gorse Hill Ward.

Laurence has served on a number of internal committees in his time on the Council, in particular as Chair of the Planning Committee, along with being appointed to a range of outside bodies.

Laurence is a former Mayor of Trafford and without doubt given his enormous contribution to our Borough I feel he meets the criteria necessary to be awarded Alderman Status.

## **MR. PATRICK MYERS**

Former Councillor Patrick Myers was elected to Trafford Council in 1991 representing Hale Ward for 8 years until he stood down to concentrate on managing his Optical Practice. During his tenure, Patrick served as Chair of the Finance Committee and of the Licensing Panel.

He returned to the Council in 2008 representing Hale Barns Ward until his retirement in 2023. Patrick served as Executive Member for Finance and Governance and as Deputy Leader of the Council.

Patrick is especially interested in education and in 1991, he was elected to serve as a governor at Well Green Primary School, where for the last 27 years he has been the chair of governors.

Beyond Trafford, Patrick is a Liveryman of the Worshipful Company of Spectacle Makers and holds the Freedom of the City of London.

As a Ward Councillor, Patrick has always considered the interests of the people of Hale and Hale Barns, supporting residents’ casework. Together with ward colleagues he was actively involved with community groups and played a leading part in community events.
