APPLICATION FOR THE GRANT OF A NEW PREMISES LICENCE UNDER S17 LICENSING ACT 2003 AT WALTON COTTAGE EDUCATION TRUST, 597 STRETFORD ROAD, OLD TRAFFORD, MANCHESTER M16 9BX

Summary

Under S18(4) of the Licensing Act 2003, Members are requested to determine an application for a new premises licence in respect of Walton Cottage Education Trust, 597 Stretford Road, Old Trafford, Manchester M16 9BX having regard to representations received and the requirement to promote the four licensing objectives.

Recommendation(s)

The following options are open to the Licensing Sub-Committee;

- (i) To grant the application in full and on the terms and conditions contained within the application to include any applicable mandatory conditions.
- (ii) To grant the application as above, modified to such an extent as considered appropriate to satisfy any relevant representations and promote the licensing objectives; or
- (iii) To reject the application.

1.0 APPLICATION

- **1.1** A premises licence is required in respect of any premises where it is intended to conduct one or more of the four licensable activities, these being:
 - The sale of alcohol
 - The supply of alcohol (in respect of a club)
 - Regulated entertainment
 - The provision of late night refreshment

This application was submitted by: Walton Cottage Education Trust in respect of 597 Stretford Road, Old Trafford, Manchester M16 9BX

1.2 The applicant has applied for the following hours:

Live Music - Indoors

Recorded Music - Indoors

Alcohol - On

1.3 The application has been properly made. However, the blue notices and newspaper advertisement incorrectly advertised what was being applied for. The management team agreed that the newspaper advertisement could be accepted, but that the blue notices needed to be amended, and the consultation period re-started. The application including consent of DPS and plan, has been attached as **Appendix A**.

2.0 BACKGROUND AND HISTORY OF PREMISES

2.1 The applicant has described the premises as: 'Walton Cottage Trust is a registered Charity. People will attend via invitation only or as friends of Walton Cottage Education Trust e.g. birthday parties/small celebrations/members events/charity.'

3.0 OPERATING SCHEDULE

- **3.1** The operating schedule is completed by the applicant and contains additional measures to illustrate how they propose to promote the four licensing objectives as required by provision of the Licensing Act 2003. They are listed below and will be attached as conditions to any licence as may be granted:
 - 1. All staff shall be suitably trained for their job function for the premises. The training shall be written into a programme ongoing and under constant review and shall be made available to a relevant responsible authority when called upon.
 - 2. All staff shall be trained in their responsibilities under the Licensing Act 2003 and in regards to the terms and conditions of this licence. Such training should include the prevention of sales of alcohol to underage persons, and the challenge 25 scheme in operation at the premises.
 - Records pertaining to such training shall be kept / be accessible at the
 premises at all times, shall be updated every 6 months and shall be made
 immediately available for inspection at the premises to council and / or police
 officers on request.
 - 4. Alcohol sales will be predominantly for prebooked invited guests.
 - 5. A CCTV system shall be installed to cover all entry and exit points enabling frontal identification of every person entering in any light condition.
 - 6. The CCTV system shall continually record and cover areas where alcohol is kept for selection and purchase by the public, whilst the premises is open for licensable activities. It shall operate during all times when customers remain on the premises.

- 7. All recordings shall be stored for a minimum period of 31 days with correct date and time stamping and shall be made available immediately upon the request of Police or an authorized officer of the council throughout the preceding 31 day period.
- 8. A staff member from the premises who is conversant with the operation of the CCTV system, shall be on the premises at all times when the premises are open to the public.
- 9. This staff member must be able to show a Police or authorized council officer recent data or footage with the absolute minimum of delay when requested.
- 10. CCTV shall be downloaded on request of the Police or authorized officer of the council.
- 11. Appropriate signage advising customers of CCTV being in operation, shall be prominently displayed in the premises.
- 12. The premises shall upload a zero-tolerance policy in relation to illegal drugs.
- 13. A premises daily register shall be kept at the premises. This register shall be maintained and kept for a rolling period of 12 months. The register shall record all incidents which may have occurred which are relevant to the supply of alcohol and the promotion of the licensing objectives. Such incidents shall include, but not be limited to, complaints made to the premises alleging nuisance or anti-social behavior by persons attending or leaving the premises and all refusals to sell alcohol.
- 14. The register shall be readily available for inspection by an authorized person upon reasonable request.
- 15. The premises licence holder shall not sell super strength beer, lager or cider with an alcohol content of 6.5% ABV (alcohol by volume) or greater. This restriction shall not apply in respect of the specialist branded, premium priced, products for example craft ales, local or micro brewery specialist products, boxed gifts or national celebratory/commemorative beer, lager or cider with an alcohol content of 6.5% ABV or greater.
- 16. All exit routes and public areas shall be kept unobstructed, shall have nonslippery and even surfaces, shall be free of trip hazards and shall be clearly signed.
- 17. The premises licence holder shall ensure that a suitable fire risk assessment and emergency plan in in place at all times.

- 18. Regular checks and maintenance shall be carried out on all equipment, electrical installations, emergency lighting and fire alarms and equipment to ensure their continued safe operation. A written record of these checks shall be kept and made available to an authorized officer of the licensing authority.
- 19. Empty glasses and bottles shall be removed from public areas quickly and efficiently.
- 20. An adequate and appropriate supply of first aid equipment and materials shall be available on the premises.
- 21. Disposal of Waste bottles into external receptacles where the noise shall be audible to neighbouring properties shall not occur between 19:00 hours and 07:00 hours on the following day.
- 22. No deliveries to the premises from commercial vehicle shall take place between 19:00 and 06:00 on the following day.
- 23. No person shall be allowed to leave the licensed area whilst in the possession of any open drinking vessel or open glass bottle, whether empty or containing any beverage.
- 24. The premises licence holder shall ensure that any patrons drinking and/or smoking outside the premises do so in an orderly manner and ensure that there is no public nuisance.
- 25. Signage requesting customers to be respectful of others when entering or leaving the premises shall be installed in a prominent position by the premises' exit.
- 26. A Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are the following recognized photographic identification cards: a driving licence, a passport, a military identification card or a Proof of Age card carrying a 'PASS' logo.
- 27. Notices advertising that the premises operates a "Challenge 25" scheme shall be displayed in a clear and prominent position.
- 28. All occasions when persons have been refused service shall be recorded in the premises daily register.
- 29. All children under the age of 12 years shall be accompanied by an adult whilst on the premises after 7.00pm.

- 30. The premises licence holder or Designated Premises Supervisor shall ensure that all management and staff who are not personal licence holders are fully trained and briefed on the four licensing objectives and Challenge 25 and they are adhered to.
- **3.2** The below conditions have been proposed by the applicant during the consultation period:
 - To reduce the hours to 12 (midnight) for the license on Friday and Saturday (inc Late night refreshments and recorded music).
 - Also to remove live music from the application.
 - They have also offered to check every hour up to the park area to assess the volume and close windows if necessary when regulated entertainment is taking place.

4.0 CONSULTATION

- 4.1 The responsible authorities included in the consultation are; Greater Manchester Police, Greater Manchester Fire & Rescue, Environmental Health & Pollution Control, Building Control, Health and Safety Team, Home Office Immigration Enforcement, Planning Department, Safeguarding Children Team, Trading Standards and Public Health.
- **4.2** Of those consultees identified in paragraph 4.1, a representation was received from the Environmental Health team. This is attached as **Appendix C.**
- 4.3 In response to the public consultation, the Licensing Authority received 38 objections to the grant of the premises licence. These are attached as **Appendix D.**
- **4.4** A copy of the report and the representations received have been sent to the applicant.
- 4.5 Those that have made a representation have been informed of the time and date of the Licensing Sub-Committee meeting and have been informed of their right to attend.

5.0 LEGAL CONSIDERATIONS

5.1 Conditions may only be attached to a Premises Licence where they are deemed appropriate for the promotion of the licensing objectives. They must be proportionate and not duplicate any existing provisions contained in other legislation. The justification behind a refusal or the attachment of conditions must be given to the applicant.

- 5.2 The Sub-Committee is advised that any findings on any issues of fact should be on the balance of probabilities and any decision should be based on the individual merits of the application.
- 5.3 The Sub-Committee, in arriving at its decision; must have regard to relevant provisions of national guidance and its own statement of licensing policy and reasons should be given for any departure.
- **5.4** There is a right of appeal to the Magistrates Court within 21 days from the date the Applicant is notified of the decision of the Licensing Sub-Committee.



Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

All staff shall be suitably trained for their job function for the premises. The training shall be written into a programme ongoing and under constant review and shall be made available to a relevant responsible authority when called upon.

All staff shall be trained in their responsibilities under the Licensing Act 2003 and in regards to the terms and conditions of this licence. Such training should include the prevention of sales of alcohol to underage persons, and the challenge 25 scheme in operation at the premises.

Records pertaining to such training shall be kept / be accessible at the premises at all times, shall be updated every 6 months and shall be made immediately available for inspection at the premises to council and / or police officers on request.

Alcohol sales will be predominantly for prebooked invited guests.

b) The prevention of crime and disorder

A CCTV system shall be installed to cover all entry and exit points enabling frontal identification of every person entering in any light condition.

The CCTV system shall continually record and cover areas where alcohol is kept for selection and purchase by the public, whilst the premises is open for licensable activities. It shall operate during all times when customers remain on the premises.

All recordings shall be stored for a minimum period of 31 days with correct date and time stamping and shall be made available immediately upon the request of Police or an authorized officer of the council throughout the preceding 31 day period.

A staff member from the premises who is conversant with the operation of the CCTV system, shall be on the premises at all times when the premises are open to the public.

This staff member must be able to show a Police or authorized council officer recent data or footage with the absolute minimum of delay when requested.

CCTV shall be downloaded on request of the Police or authorized officer of the council.

Appropriate signage advising customers of CCTV being in operation, shall be prominently displayed in the premises.

The premises shall upload a zero-tolerance policy in relation to illegal drugs.

A premises daily register shall be kept at the premises. This register shall be maintained and kept for a rolling period of 12 months.

The register shall record all incidents which may have occurred which are relevant to the supply of alcohol and the promotion of the licensing objectives. Such incidents shall include, but not be limited to, complaints made to the premises alleging nuisance or anti-social behavior by persons attending or leaving the premises and all refusals to sell alcohol.

The register shall be readily available for inspection by an authorized person upon reasonable request.

The premises licence holder shall not sell super strength beer, lager or cider with an alcohol content of 6.5% ABV (alcohol by volume) or greater. This restriction shall not apply in respect of the specialist branded, premium priced, products - for example craft ales, local or microbrewery specialist products, boxed gifts or national celebratory/commemorative beer, lager or cider with an alcohol content of 6.5% ABV or greater.

c) Public safety

All exit routes and public areas shall be kept unobstructed, shall have non-slippery and even surfaces, shall be free of trip hazards and shall be clearly signed.

The premises licence holder shall ensure that a suitable fire risk assessment and emergency plan in place at all times.

Regular checks and maintenance shall be carried out on all equipment, electrical installations, emergency lighting and fire alarms and equipment to ensure their continued safe operation. A written record of these checks shall be kept and made available to an authorized officer of the licensing authority.

Empty glasses and bottles shall be removed from public areas quickly and efficiently.

An adequate and appropriate supply of first aid equipment and materials shall be available on the premises.

d) The prevention of public nuisance

Disposal of Waste bottles into external receptacles where the noise shall be audible to neighbouring properties shall not occur between 19:00 hours and 07:00 hours on the following day.

No deliveries to the premises from commercial vehicle shall take place between 19:00 and 06:00 on the following day.

No person shall be allowed to leave the licensed area whilst in the possession of any open drinking vessel or open glass bottle, whether empty or containing any beverage.

The premises licence holder shall ensure that any patrons drinking and/or smoking outside the premises do so in an orderly manner and ensure that there is no public nuisance.

Signage requesting customers to be respectful of others when entering or leaving the premises shall be installed in a prominent position by the premises' exit.

My Team Leader emailed the applicant's Licensing Agent, Mr Bartlett, on 13 September 2024 to raise concerns about possible impact on residential properties from noise and general disturbance, and requested a noise management plan for the venue, documenting how noise would be controlled during events. Mr Bartlett replied on 30 September 2024 to propose to reduce the hours to 12 midnight for the license on Friday and Saturday (inc Late night

refreshments and recorded music, to remove live music from the application, and to confirm that the applicant would check every hour up to the park area to assess the volume and close windows if necessary, when regulated entertainment is taking place. I replied on 02 October 2024 to agree the proposal to remove Live Music from the application but disagreed that the remainder of the proposal would be sufficient to address the matter, highlighting the lack of detailed information on how the premises will be operated and managed, and the sensitivities of the location to noise impact, especially during the night hours. I proposed a further reduction in the hours for regulated entertainment, and a more rigorous level of control to be applied, and presented a list of changes and conditions I could agree. I received an acknowledgement from Mr Bartlett on 03 October 2024 but no confirmation of agreement or

otherwise to my proposal. I have attached: - a copy of the email correspondence with Mr Bartlett. Hi Stephen,

I've discussed the proposal with my Team Leader Paul Fletcher. Thanks for your suggestions, and live music being taken out of the Licence is helpful. However, we remain concerned about the lack of detailed information on how the premises will be operated and managed, and the sensitivities of the location to noise impact, especially during the night hours.

The proposal to monitor noise and close windows when necessary, may not be sufficient by itself to protect residents from nuisance, bearing in mind the amplification levels that would be required to facilitate musical entertainment.

The building has not been designed as an entertainment venue. NB. I cannot see any planning history to confirm the permitted use of the building as proposed.

Noise breakout could be audible outside near to the residents, even with closed windows to the building.

In particular, the 2nd floor function room directly connects with the rear fenestrated façade, close to residential positions. Being elevated, without screening, and directly adjacent to bedroom windows of nearby properties, there is a significant risk of nuisance noise breakout through structural weaknesses.

Hence I am looking to agree a further reduction in the hours for regulated entertainment, and a more rigorous level of control to be applied.

The impact of noise from people leaving and using the car park must also be considered, hence a period has been factored in to ensure that the premises and surroundings return to quietude at an appropriate time.

I am proposing the following changes, and conditions to the Licence:

- Remove live music from the application agreed
- Regulated entertainment (recorded music, indoors) to only be provided to 23:30 on the ground floor on a Friday and Saturday.
- Regulated entertainment (recorded music, indoors) to not take place at any time on the 1st and 2nd floors (deregulated entertainment provisions would apply to 23:00 under the alcohol on-licence).
- Sale of alcohol to terminate at 23:30 (ground floor) and 23:00 (1st and 2nd floors) on a Friday and Saturday.
- Late night refreshment (indoors) to be removed from the application, except to 23:30 on a Friday and Saturday (ground floor only).
- Music must only be played through fixed in-house speaker systems fitted with a noise limiting device

The building is not appropriately placed to hold such a license and will have a huge negative impact on our community and our future.

Having a late night alcohol licensed live music venue so close to residential properties, many of which have young families living in them (including my own) is only going to bring more potential hazards and increase the chances of children being harmed. These include, increased litter, lack of consistent sleep due to noise pollution, broken glass and smoking paraphernalia being left outside and nearby the venue, antisocial behaviour and aggressive behaviour which could spill onto our streets.

It's a poorly thought out idea which clearly hasn't grasped the residential and community location which the building resides in. Nothing of this nature is around the area (There is a long established pub which only opens until 11.30 weekends with no live music ever), and anything close to it, are not in such a heavily populated residential location as this application. It would not be appropriate or welcomed from the vast majority of local residents and we oppose it strongly.

With 30+ Manchester United football matches per season, cricket, marathon/half marathon, concerts at the cricket ground, the (already considerable) issues around parking will be exacerbated.

LOTS is very worried that the licensing application will have a detrimental impact on the surrounding area for the following reasons: The building has a car park for only 6 vehicles at the rear of the property. This is insufficient for this venue. Vehicles have to drive down a private road to access the car park and would not be able to park on some of the surrounding roads as they are private. There is also double yellow lines on Carver Street and Stretford Road. On a match day Vehichles may decide to park on the land either side of the building, on the pavement, in the cycle lane, or on the road. Furthermore, there is already a shortage of space for the number of vehicles owned by residents. This proposal would only compound this problem further. If people arrive by taxi there is no drop off area. They may drive across the cylce way and onto the pavement like taxis do for the flats at Westpoint at 501 Stretford Road. On a match day Vehichles may decide to park on the land either side of the building, on the pavement, in the cycle lane, or on the road Furthermore, there is already a shortage of space for the number of vehicles owned by residents. This proposal would only compound this problem further. If people arrive by taxi there is no drop off area. They may drive across the cylce way and onto the pavement like taxis do for the flats at Westpoint at 501 Stretford Road. We would also like to ask what soundproofing measures have been taken at the building to contain the noise that will come from live music? It is our understanding that this would take place on the top floor of the building. Will the windows be kept closed? In Old Trafford, noise from drunken football supporters is already audible from the 'shed' that is outside the Tollgate pub on Manchester United match days. In the application it states 'Walton Cottage Trust is a registered Charity. People will attend via invitation only or as friends of Walton Cottage Education Trust e.g. birthday parties/small celebrations/members events/charity'. It is not clear how any 'invitation' will occur. We are not aware that the Trust has 'members' as there are only three Trustees. The venue is already being advertised for weddings etc even before the license has been considered.

We note that the Walton Cottage Education Trust is a charity for the benefit of children and families, but to operate as a music venue, and open on a Saturday and Sunday selling alcohol seems to go against the objects of the charity. An application for a nursery and then wellbeing centre was rejected because of the insufficient parking on site. We believe that the impact of this application (afternoons and night time) goes well beyond any parking issues that were cited as reasons for refusing the nursery or wellbeing centre.

I am the current volunteer Chair of a community group called Love Old Trafford (LOTS). I would like to submit a representation for the above licensing

application on behalf of the group. LOTS has delivered environmental projects over the last 13 years. This includes organised litter picks, Old Trafford Open Gardens, Friends of Hullard Park, Apiary in Hullard Park, campaigning against the use of glysophate, and planting of tree pits. Throughout this time we have worked closely with Trafford Council. Our most recent, and most ambitious project to date is 'OT Community Goes Wild' on a piece of council owned land on either side of 597 Stretford Road. This land had been used as illegal vehicle parking on match days, causing a considerable amount of environmental damage. Whilst Trafford Council was able to use their limited resources to issue parking tickets this did not deter parking. Trafford Council did not have the funds to install any measures on the land to prevent parking. In 2023 LOTS was successful in applying for nearly £40,000 of the Green Spaces Fund which is part of the Mayor's Greater Manchester Environment Fund. The primary objective of this project is to increase biodiversity and encourage use by local residents at the site. Volunteers have deliberately let the grass grow, planted shrubs and bulbs, installed raised planters, sown wildflower seeds, and litter picked the site. Volunteers have contributed a considerable amount of their time.



There is no adequate parking or access route to the building from the rear or front. There is already a precedence set from a previous application that parking to the front of the property is not viable. Cars will be forced to either drive through a private access road to reach the rear (carver close) or park on Stanley road. Although the building may have right of access through carver close, this would have been considered on its previous usage, and not to accommodate a heavy stream of taxis and other vehicles at opening/closing hours. I believe that this large increase in vehicles using the road at certain times has the potential to create safety issues as this is a densely populated residential area with many young children. It can be seen that Trafford council already understands the link between public safety and vehicle usage by their investment in traffic calming measures such as the speed bumps placed in the local area and the closing of both ends of Stanley road with bollards to reduce traffic along this road.

The local area is almost entirely residential. The building itself is surrounded by houses and flats, and there is a clearly defined commercial zone, which this building will be separate from. Any establishment that serves alcohol cannot pretend that there is not inevitable that there will be incidence of public nuisance created by customers that have consumed too much. whether it could be noise, vandalism and highly likely to be public urination. Being in a residential area this unavoidable nuisance will be highly damaging to the local area. Additionally this license also is to request for live music, I cannot see how it could be seen as appropriate to have live music in a residential area, especially one that is comprised of many young families. The residents of both carver close and Stanley close will most certainly be able to hear the music for an area that is relatively quite in the evenings this will almost certainly cause disruption and noise

As stated in "public safety" Trafford council already invests money into reducing the potential for harm to the public from vehicle traffic, and children are usually more at risk from being harmed by vehicle traffic.

As stated previously, across the entire old Trafford area there are clearly segregated zones for use of commercial properties, this is a long standing observation that should be maintained. If someone want to open and operate such a business it should be done in the areas of old Trafford where it will not cause such and impact on local residence and violate a long standing observation on the way in which this community is "zoned"

- Crime & Disorder: (How users of the late night music bar and/or football fans/people attending concerts could cause disorder and vandalism). Walton Cottage Education Trust building is extremely close to local residents, which will cause a lot of disruption, especially for families with babies and young children.
- Public Safety: (There is no right of way to the car park for users as it is a private road at the rear of the property which means they will park on already congested local roads. In addition, there is no 'drop' off point or collect area for taxis at the front of the building as it's on a built up road junction with a raised traffic control system that includes a cycle lane. A previous planning application by 597 Stretford Road to convert their 'garden' area at the front of the building as a disabled parking space was refused due to the complexity of the Stretford Road/Chester Road junction.)
- Public Nuisance: (Again, users of the bar could spill out onto the road area and misuse and cause disruption to the local residential area. 



Historically, living next to Stretford Road we have witnessed both crime and disorder from revellers that have attended existing local events e.g. concerts at LCCC, Manchester United and Victoria Warehouse in various aspects of anti-social behaviour. Should Walton Cottage obtain an alcohol/late music licence in such close proximity to a primarily residential area I feel its patrons could cause similar issues similar to those listed below: • DURING DISPERSAL OF PATRONS: • Anti-social behaviour when leaving the premises under the

using the estate walls for toileting may also cause intrusive odours. • Patrons leaving the premises at the front of the building may congregate and fall out onto the busy road junction causing traffic issues. • Noise levels will increase if there is no security staff to encourage disbursement. • Vandalism of the local area and its amenities.

o There is no right of way to the car park of 597 Stretford Road for users as it can only be accessed via a private road at the rear of the property and not available for public access. Therefore, patrons will have to park on already heavily congested local roads where parking on pavements already causes an issue for pedestrians, parking on corners that blocks clear visibility to proceed, and emergency services would struggle to access with inconsiderate double parking, o There is no 'pick up or drop off point for taxis at the front of the building as it's on a built-up road junction with a raised traffic control system that includes a cycle lane. Double yellow lines currently exist on Stretford Road and the closest side road within the residential area (Carver Street) is one way for vehicles to egress onto Stretford Road. This would mean taxis etc. would have to drive down other residential roads to be facing the correct way to pick up passengers from 597. o A previous planning application was applied for by Walton Cottage Trust to construct a 'dropped kerb' to facilitate the conversion of the 'garden' area at the front of the building as a disabled parking space. However, this was refused due to the complexity of the Stretford Road/Chester Road junction. (Please see your planning application No 106477/FUL/21) o Revellers may walk into the path of cyclists/pedestrians and twoway traffic if the pavement becomes congested.

o Should an alcohol and music licence be granted as specified in their application, it indicates that they will be open later than other local hostelries and have a licence to play music later than concerts etc. It is not acceptable to open such a venue in a quiet residential area and which will cause huge disruption and disquiet to residents of Carver Close. and in addition, noise issues to Carver/Stanley Close residents, and the Victoria Flats on Stanley Road. (Incidentally, the residents of Carver Close have to maintain and fund any damage to Carver Close of which users of 597 will contribute to its wear and tear without having to contribute to its upkeep), o Noise pollution from music being emitted from the premises and even more so if they open windows for ventilation. Local residents have the right to live peacefully and not feel they cannot open their own windows for ventilation knowing they will be overpowered by music coming from the building irrespective of what hours they decide to open. Their suggestion of checking noise levels as far as the park concerns me even more as this implies that music may be heard from there. Therefore, living 8 metres away from the building we will be completely overpowered by extreme levels. o Noise Pollution Patrons may cause a nuisance to the local residential area with elevated levels of noise. This will particularly disturb the immediate local residents in which there are several families and elderly people and will affect their wellbeing, mental health and induce vulnerability. Furthermore, even though the alcohol and music may stop at the end of the evening it is more than likely there will be additional noise created by patrons leaving the premises up to an hour after the

alcohol/music has ceased. o Noise pollution when bottles/cans are discarded into commercial bins at the back of the property and their removal from site would have to be walked off and down Carver Close (private road) and left for the refuse collectors to collect from Stanley Road, which may cause a nuisance to pedestrians/cars alike. o Pest control issues may arise due to storage of waste at the back of 597 Stretford Road which may also emit intrusive odours, o Light pollution from illumination of the rooms within the building. As our home is eight metres in distance from 597 Stretford Road and we share a boundary wall, their lights cause our gardens and rooms (especially bedrooms) within our property to be affected. Carver Close, Stanley Close and the Victoria flats which surrounds 597 are all affected by their use of lighting. o Traffic issues. Again, patrons of the bar could spill out onto the busy road junction at the front of the property. o Traffic Issues. 597 Stretford Road cannot be accessed by refuse collectors due Carver Close being a narrow private road. Therefore, alcohol deliveries will also not be able to access the property without causing much inconvenience to the residents Traffic Issues and Vandalism. The grass verges by the side of 597 Stretford Road have been converted into a nature reserve to encourage local wildlife by a local volunteer group which could potentially be damaged. This was adapted to prevent football fans parking their cars and churning up the grass verges and, causing damage to the Stanley Close/Court boundary walls. In addition, cars were accessing the verges and going over the cycle lanes and pavements that have no vehicular access. This again may be used in a comparable manner by patrons of the venue.

There are families with young babies/children residing in Carver Close, Stanley Close and the Victoria flats which are within a 10/15 metre distance at the back of 597 Stretford Road. The licence application states that the Walton Cottage wishes to open from 9.00am until 1.30am on some nights, 7 days a week. The noise generated from live/recorded music and potential anti-social behaviour from users, could, affect children and adults alike who live in residential housing within the immediate vicinity of the building. This may affect and disturb their peace, wellbeing, and their quality of life with no respite. . Children who live and play on Carver Close may injure themselves on dropped waste/glass when their commercial bins are emptied. • As Walton Cottage Education Trust continue to advertise on their website that they have creche/12-seater children's room facility for hire within the building (also indicated by images), I fail to understand how you can safely have children using the same building that is being used as a live music venue. • Walton Cottage advertises that the creche area is on the first floor, the dance floor is on the ground floor and the event room/bar-cafe is on the second floor. Therefore, there are potential safeguarding issues if children are using the same facilities of the building particularly the corridors, toilets etc where unknown substances may be left by patrons of the music venue. Furthermore, any broken glass or waste children may come into contact with could be harmful.

I am extremely concerned that Walton Cottage Education Trust are applying to Trafford Council for a late alcohol and music licence to open a 'live'

music venue which may be open until 1.30am possibly several nights a week. They also intend to open from 9.00am (sell alcohol from 12.00pm) seven days a week which will have an enormous impact particularly on my family home being the closest and most overlooked by 597 and the Stanley Close & Stanley Court estate and local community. 597 Stretford Road is bounded on three sides by residential housing and on the fourth side by the extremely busy Chester Road & Stretford Road junction. Opening up the building to become a licensed venue with live and recorded music in such close proximity to this primarily residential area could be significantly detrimental and affect the privacy, mental health, and quality of life of local residents due to noise, light pollution, and antisocial behaviour until the early hours. I personally am looking at this application two-fold. In the first instance, I reside at Stanley Close, Old Trafford. M16 9DT and have done so for 34 years. Our home is one of the closest properties (approx. 8.7 metres) and shares a boundary wall with 597 Stretford Road. (Please see attached image to ascertain the close proximity). When the building was used as office space prior to Walton Cottage taking over, it had little impact on our homelife apart from their burglar alarm occasionally going off. However, since Walton Cottage have taken possession, we have been inconvenienced on numerous occasions e.g. by their alarm being activated and they are adept at leaving multiple internal lights on overnight and over-sensitive security lights are constantly being activated throughout the night. As a result, we experience significant light pollution as they illuminate our bedrooms which are at the back of our property and facing their building, all of which affects our sleep considerably. Should they be open in the evenings and at times until 1.30am the lights as we already know will cause an issue and, in addition, the noise pollution aspect, the output of live and recorded music would significantly have a huge impact on our ability to sleep particularly as my daughter works shifts for the NHS and I work at a local school. The anxiety this would cause would severely impact our health and mental well-being. Furthermore, at the rear of 597 where the houses and Victoria flats surround it we find that noise is amplified as it echoes and bounces off the walls of all the buildings whereby you can hear conversation clearly let alone music being played. My health is unfortunately poor and have asthma amongst other issues, I have my window open during the night to enable me to have fresh air to aid my breathing and again, the noise levels that a music bar would induce, as a result, will affect me more so. I am sure we have a right to be able to rest and relax in our home, but such a venture would completely overwhelm our day to day living. In addition, we already feel overlooked by onlookers from the building and do not feel comfortable using our own garden at times. My daughter has already applied privacy film on her bedroom window to protect her privacy and we feel we have to adjust our patio window blind to prevent onlookers from 597 seeing into our home. Therefore, the potential of having a large capacity of people able to look over us would at very least invade our privacy even further and make us feel extremely uncomfortable and vulnerable. As I mentioned previously, I would appreciate that you to also consider the bigger picture that the impact of a licensed music venue would have on the local community. I am a co-

director of Stretford Management Co Ltd which oversees the management of Stanley Court and Stanley Close which is a private estate with a private road. It is one of the closest estates to 597 Stretford Road and I have served the residents in this capacity for 30 years plus. We have to fund and maintain our estate through residential service charges which includes our own street lighting, grounds maintenance and repairs with no financial input or support from Trafford Council. We experience anti-social behaviour and damage to our estate from inconsiderate people who attend local events i.e. damage to our boundary wall/railings, littering and used as a toilet facility. We also endure unauthorised car parking on our estate as the local roads are already heavily congested and become impassable when something is taking place locally. Again, we do not receive any support from Trafford Council or the Police when this happens. I can only anticipate we may experience more of this nature and fear the patrons of 597 may do the same particularly traffic/noise related issues when patrons are being dispersed at closure of the venue. Upon speaking to several leaseholders and residents of the estate and in the local community, they are extremely concerned about the impact of a licenced property in such close proximity to their properties. Allowing this to open as a late-night music venue would certainly have a detrimental effect to our quiet estate and community. In addition, the noise and light pollution in the local area and in particular from Stretford Road has increased in recent years due to the West Point building becoming residential flats. Anti-social behaviour has already increased late at night when its residents are returning from evenings out. In addition, we are also facing the prospect of another multi-storey residential block being built next to West Point on Stretford Road which will no doubt have an impact on us also both in anti-social behaviour and parking issues. Patrons of the music venue could exacerbate the car park issues in the vicinity due to no available area at the front of 597 to drop and collect users in taxis. Walton Cottage applied for a dropped kerb in 2021 (planning application 106477/FUL/21) at the front of 597 to enable disabled parking but this was rejected as it is on such a busy built-up junction that has traffic lights and the pavement/road being built up with cycle lanes etc. May I also point out that at the rear of 597, their car park can only be accessed via Carver Close which is another private road and isn't open to unauthorised users. Walton Cottage has no legal agreement in place with the five residents' properties to use it and therefore, nor do their prospective patrons. Furthermore, we already have three licensed pubs/bars within a 5-minute walking distance of this location which are not enclosed entirely by residential housing as we are and do not feel we need another in such a built-up residential area. Walton Cottage Education Trust states on their website that they are a charity that concentrates on education and training. I and local residents are equally perplexed that if they are a charity for those purposes within 597, how does opening a late-night music venue which sells alcohol fit into this remit. On a personal level, I already feel extreme anguish about the prospect of this change of use. The enormity of the impact it may have on our day-to-day life has already caused many sleepless nights and distress. My neighbours and I would appreciate your support or intervention

with this matter to prevent it from going ahead. On a completely different concern entirely that raises an environmental issue is that we have a colony of bats that roost in the area that are seen at dusk flying over our gardens. The Bat Conservation Trust advise that excessive noise/vibration and artificial lighting can be extremely disturbing to their habitat and foraging pathways and can have a serious impact on their survival and growth rates. As bats and natural roosts are becoming scarce they are protected by law as and should be considered during planning application processes. The opening hours that 597 Stretford Road have stated means that the light and noise pollution that the building will emit could very well affect the bat colony that roosts close by. 

So how can the residential homes that share its boundaries and garden walls with the premise be protected from this? Simply, it can't. Trespassing through private roads, public urination, vandalism, loud violent and antisocial behaviour outside its premise to allow vaping and smoking, littering of alcohol and drugs, dispersal and refused entry disorder are to name a few with their potential victims being residing or public members. Disorder at licenced venues can only be well controlled without the disruption to neighbouring residents, businesses and traffic when the dwelling shares enough car parking To prevent crime and disorder: land for the safe dispersal and de-escalation of

such land. Without this, it is pushing the disorder into the residential areas and public roads which creates vulnerability to the public and strain on the emergency services. The presence of emergency services responding to any antisocial behaviour alone would have a huge detrimental affect to the area as not only would this disrupt the quiet and private residential streets surrounding the premise back access, but the disorder would be extended onto a major 3-way traffic junction which in turn will also create public and traffic safety issues. Already we bare the brunt of antisocial behaviour from event goers and as we now reside on the outskirts of the red routes, this has pushed traffic and disorder into our neighbouring streets even more so and without the added support of policing.

As stated above and in correlation to public nuisance, the location of this premises falls on top of a busy 3-way junction. The Bee Network introduced the Stretford Road Cycleway to protect cyclists from motor traffic, as there is no designated space for vehicles to pull up safely outside the premise, this means service users will be dropped off / picked up outside the premise on double yellow lines, on top of a traffic light junction, in-between the cycleway bollards, cutting off the cyclists path, creating junction congestion, and build up as vehicles will be unable to overtake, altogether creating public nuisance for residing residents in noise and vehicular pollution as well as creating danger to life to all road users. As the building overlooks its neighbouring residential homes, this lack of personal privacy also becomes a public safety concern and threat.

The noise, light and vibration of music emitted from this building will cause major disruption to our community, especially as the positioning of the buildings creates an echo which amplifies even a conversation to the point you can hear every word. This disruption will not only count for the hours in which they want to operate, but the time of dispersal onto our streets, waste collection, and the opening and closing of the building. This will all seep into hours that have not been highlighted in the application, which only prolongs the disruption to us as their neighbours for each and every day of the week. Please see the attached photos of the occupied building during night hours below and how this light pollution causes major distress when trying to sleep, nevermind noise to accompany it. This sort of nuisance along with the disorder in which they disperse late at night and in the early hours of the morning will have a detrimental effect to the health and wellbeing to not only its local vicinity, but the wider community also. Waste Disposal and Lingering Smells - Sanitary clinical waste, recycling, food and alcohol all require appropriate disposal for a premise that wants to entertain and sell alcohol. This means containing this waste within their car park, creating another eyesore to their already massive storage sheds, the smell that it would create and the pests this would attract, all less than 10 metres away from my home. It would require disposal to access a private road (Carver Close, USRN number: 41002471 as documented by gov.uk findmystreet.co.uk), this waste could potentially

fall onto the road causing environmental concerns, ie fallen food that attracts pests, broken glass that could injure children playing on their own street and then there is damage to the street from these vehicles. All of which seems very unfair to a road that maintain and pay for it themselves, even Trafford Councils own bin lorries do not go up this road. Measures to minimise these risks cannot be put into place in this scenario as waste collection cannot be collected from access to the front of the property. Parking and No Stopping/Waiting- This will also be a nuisance. Stanley Road is the only public road available near the vicinity for service users to park on, but this road is massively congested by apartment blocks within the area that do not facilitate their own parking. The issues I highlighted in my last representation when Walton Cottage applied for a dropped kerb for vehicle access to the front of the property all apply here. Since that last representation, the area has become significantly worse and we are facing other daunting prospects of other high rise apartment blocks going up in the area. Because of its overcrowding, this forces vehicles to park on the pavements which are then blocked for pedestrian use. The area has become completely unsafe with illegal parking and yet no policing has been enforced to stop this from happening. Coming out of junctions where you cannot see what is coming has become the norm, cars are being damaged and there would be no chance of any emergency service gaining access.

The lack of privacy in our own homes to the immediate area where children reside means there will always be safety concerns due to everyday occupancy of the building of all hours and with constant overlooking. Their protection also includes the effects to their wellbeing and mental health, especially when their sleep is disrupted by nuisance, and public disorder. It is not just young children we speak of here, there is also the safeguarding concern for the large student population we have within the vicinity as well as the vulnerable young people within the sheltered accommodation/hostel we have on the end of Stanley Road. The safety and wellbeing of all should count but as a community, how are we supposed to protect children and each other from the risks of alcohol consumed behaviour each and every day, all day within our residential neighbourhood?! Protecting children starts at home, a place they can feel safe, and yet this will be compromised when the threat of a licensed business is on their doorstep. The community has already come together and shown me that this application is a huge unwelcome and concern to their families. Licensed businesses are all very well in the right area where children do not reside or are restricted too (ie high street or town centres) but not when they are metres away from their homes

The anxiety this has created among our community has already had an instrumental affect to our lives and I cannot express enough the detrimental effect this would have on our mental health should this license be accepted, as it already has. I personally work 12+ hour shifts in healthcare. I come home to rest, like we

all do, and to be able to go to bed at night and sleep. Yet I face debilitating effects of everything mentioned above less than 10 metres away from my window. I cannot see how this establishments plan could not affect our lives, our safety, or our homes. This building has only ever been office space up until 2020 when the class of buildings changed. When used as offices, it never caused any upset to the neighbours or the larger community as its operating business hours were respectful, pollution was limited and the use of the private road (Carver Close) was agreed for business day working hours only. None of this was revised when the class of the building changed and yet as this is a residential area, I only feel it is right that this community should get a say, and that Carver Close get the protection they deserve for a road they maintain privately themselves. As for the premise itself, I do not understand how a 'creche' can sit in the middle floor between two function rooms, a function room with dance floor on the ground floor, and a large function event room on the second floor. When the application for business use changed, their plans were to have a creche on the bottom floor, mental health services on the first floor and community café on the second floor. So why has a dance sprung floor been put in when that does not fit into any of the categories above? It seems these were never intended purposes of use and it completely goes against the use of class as this license application falls in the sui generis class not Class E parts b,e,f,q in which they claim to be running. It is here that I plea with the council that you come and look at this building and revise how it can be used effectively without disruption to the community and to provide a business that is fit for purpose. With only the placement of two posters put up on lamp posts, word of this application spread and our community has come together in its representations and petitions, and it is here that I hope you listen to our pleas and support us as this has affected an entire community.

By chance it has come to local residents' attention that the office block adjacent to the Carver Close and Stanley Court/Close estates is in the process of obtaining an alcohol and music licence. The property is 597 Stretford Road and can be located on the map below.



Walton Cottage Education Trust who took over the rental of the property in 2021 was initially to open a creche, well-being service and community café which so far hasn't transpired. The building was originally an office block and the class of usage was changed for the new intended purposes to allow such businesses as listed.

However, they are now applying to Trafford Council for a late alcohol and music licence to open up as a 'live' music venue which may be open until 1.30am potentially several days a week. They also will be open 7 days a week. This could have an enormous impact on our communities within the local area.

To have an alcohol licence they have to be in a different category of class system named 'Sui-generis' which may mean they could use the property for multi types of business and that allows bars or pubs to sell alcohol and have live and recorded music. They are currently in Class E and assume they will also be required to apply for planning permission should they get approval for an alcohol licence.

The impact that opening up as a licenced music venue could have a severe effect on our right to privacy and quality of life due to regular late-night noise/light pollution. Anti-social behaviour until the early hours from their users would also certainly have a detrimental effect to our generally quiet community.

As many of the estates in the immediate vicinity are private roads which already have issues of unauthorised vehicles parking, the patrons of the venue may further exacerbate the problem of parking on Stanley Road, Henry Street and Carver Street. These roads have already become extremely congested due to the West Point residential block using the local roads and, in addition, when the new residential block is built which will have 310 apartments with ten parking spots next to the West Point apartments, the roads will be affected even more.

Changing 597 Stretford Road to a late-night music venue does not have an accessible car parking facility, will also add to the traffic congestion making it much worse. In addition, where the building is located on Stretford Road there is nowhere to pull up outside the property on such a busy built-up junction which has cycle lanes, raised pavements and traffic lights etc. therefore, taxi's picking up and dropping off users of the club will also cause an issue on the neighbouring streets.

Observation of their sporadic opening hours (as listed below) suggest they are trying to cater for when local events are taking place which may cause further anti-social behaviour, noise and vandalism issues.

It would be advantageous if the local community could stand together to object to this proposal adhering to the 4 main licensing objectives that Trafford Council Licensing Department as below:
