LICENSING SUB-COMMITTEE DECISION

The Sub-Committee decided that the representations from local residents were from interested parties living in the vicinity of the premises.

To grant a premises licence as follows:

Licensable Activities

Supply of Alcohol (off the premises):

Friday	22.30 pm - 00.00 am
Saturday	00.00 am – 07.00 am 22.30 pm – 00.00 am
Sunday	00.00 am – 07.00 am 22.00 pm – 00.00 am
Monday	00.00 am – 04.00 am

Bank Holidays / Festive periods

If any days throughout the Christmas, New Year and Easter periods or public bank holidays, fall outside the licensing days and hours as applied for, then the following will apply:

23 rd December to 3 rd January	22.30 pm – 07.00 am
Thursday prior to Good Friday	22.30 pm – 07.00 am
All Bank Holidays	22.30 pm – 04.00 am

Conditions

Mandatory Conditions under section 19 and 19A of the Licensing Act 2003 where the licence authorises the supply of alcohol off the premises.

Sale of alcohol directly from the premises is strictly prohibited.

To restrict the delivery of goods to the unit from suppliers to any time between the hours of 08:00 and 20:00 on any day of the week.

To enter and exit Crossford Court via the entrance closest to the A56 to minimise the number of premises affected by vehicular movements associated with the operation.

To restrict the transference of waste from the unit into the waste bins at the rear of Unit 2 to any time between the hours of 08:00 and 20:00 on any day of the week

LICENSING SUB-COMMITTEE'S REASONS FOR REACHING ITS DECISION

The Sub-Committee considered the Licensing Act 2003 and regulations, the Guidance and the Council's Licensing Policy, the application and all representations made.

The Sub-Committee considered the written representations received from local residents.

The Sub-Committee noted the absence of any other representations about this application.

The Sub-Committee carefully considered the resident's concerns regarding the potential for noise nuisance and balanced those concerns with the interests of the applicant and the licensing objectives.
