#### **Report Title**

#### **REVIEW OF CONSTITUTION – CONSULTATION ON PROPOSED CHANGES**

#### **Summary**

The purpose of this report is to outline a number of changes to the Constitution following a full review. The changes will be submitted to the Annual Meeting of the Council on the 22<sup>nd</sup> May 2013 for consideration and adoption.

The Standards Committee is asked to comment on the proposed changes in accordance with Article 15 prior to their submission to this meeting.

#### Recommendation(s)

The Council will be recommended to approve the following:

- 1) That the amendments to Parts 1, 2, 4 and 5 of the Constitution be approved.
- 2) That Council notes that Executive functions not covered by the Officers' Scheme of Delegation are delegated by the Leader of the Council as follows:
  - (a) functions are delegated to all individual Executive Members in accordance with the Scheme of Delegation set out in Part 3 of the Constitution;
  - (b) all other functions are delegated to the Executive.
- 3) That the Scheme of Delegation to Officers as set in Part 3 of the Constitution be confirmed.
- 4) That the Acting Director of Legal and Democratic Services be authorised to amend the Constitution of the Council in accordance with and as a consequence of this report.

The Standards Committee is requested to consider the changes and make any comments prior to their submission to the Council meeting.

#### **Background**

It is the duty of the Council's Monitoring Officer to review the Constitution from time to time and to propose amendments to the Council. Generally amendments are proposed at the Council's Annual General Meeting to reflect any changes which are proposed to the schemes of delegation for both Members and Officers, together with any further amendments which may be considered to be necessary for the efficient and effective management of the Council and Council services.

Article 15 of the Constitution requires that any proposed changes to the Constitution should be referred to the Executive, Standards Committee and Standards Committee for comment prior to consideration by the Council at the Annual Meeting on 22<sup>nd</sup> May 2013.

#### **Review of the Constitution**

The current Constitution has been in place for some time and has been updated as and when new legislation and regulations have come into force.

However, it was felt necessary to carry out a full review this year to ensure that all changes have been made and to ensure that working practices are still relevant for the efficient operation of the Council.

Parts 1, 2, 3, 4 and 5 of the Constitution have been reviewed and any recommended changes have been published on the Council's website. Changes are highlighted clearly but a summary of the changes that have been made is set out below.

#### **Summary of Changes**
