9. **APPLICATION FOR THE GRANT OF A PREMISES LICENCE - URMSTON FREEMASONS HALL, 15 WESTBOURNE ROAD, URMSTON, MANCHESTER M41 0XJ**

LICENSING SUB-COMMITTEE DECISION

The Sub-Committee decided that the representations received were relevant representations.

To grant a premises licence as follows:

Licensable Activities

Supply of Alcohol (on the premises):

Monday to Sunday 10.00 a.m. to 01.00 a.m.

Regulated Entertainment (Indoors) for Live & Recorded music:

Monday to Sunday 09.00 a.m. to 00.30 a.m.

Non-Standard Timings for all Licensable Activities

From the start of permitted hours on New Year's Eve to the end of permitted hours on New Year's Day.

An extra hour on the date when British Summer Time commences.

Mandatory Conditions

Mandatory Conditions under section 19 and 19A of the Licensing Act 2003 where the licence authorises the supply of alcohol on the premises.

Additional Conditions

PPN3

Noise from music and associated sources (including DJ's and amplified voices) must not be audible to such an extent that it constitutes a nuisance at any noise sensitive properties.

PPN4

All external doors and windows shall be kept closed when regulated entertainment is being provided except in the event of an emergency.

PPN6

There shall be placed at all exits from the premises in a place where they can be seen and easily read by the public, (or members and their guests) notices requiring customers to leave the premises and the area quietly.

PPN8

A Noise limiter device or system shall be installed on the premises and used to the satisfaction of the Licensing Authority and with prior agreement of the Licensing Authority on the settings to be used on the device.
