Reference the above licensing application.

My name is Diane Smith and I own 848 Chester Road. The premises are used for a ground floor hair dressing salon and first floor apartment.

We strongly object to the above referenced application on the following grounds.

My tenants in both salon and the apartment have been suffering from the use of 846 Chester Road as a bar for a long period of time. For example during home football matches played by Manchester United the staff of the hair dressing salon are verbally abused by drunken fans. This also applies to the elderly clientele. They also drink on our premises and put their drinks on the staff cars. There are times when the hair dressing staff are frightened to go out their cars for fear of abuse from drunken customers of 846.

Prior to our initial complaint our tenant in the apartment had difficulty sleeping due to noise from the the drunken customers at the back of 846. Often he had to clear up sick at his back door. This also applies to the local residence who have previously complained to 846 about noise from customer and loud music.

Surely this is not an ideal location for a bar with music and late night opening. We we would be very grateful if you could acknowledge our complaint.

The prevention of public nuisance. The protection of children from harm The bar itself is a good addition to the community however, the noise from its customers is too loud and the owners do nothing about it. The beer garden is in use until the early hours, way past last orders and there is no consideration for the neighbours. On darker evenings, it is intimidating to walk anywhere near the place as the crowds are rowdy both inside and out. On a weekend, particularly on a match day, the customers are packed into the beer garden at the front and it's impossible coming out of Wesley Street to see down Chester Road if there is any traffic coming, which on a few occasions has almost caused a crash. Customers park on double yellow lines which means turning into Wesley Street has become dangerous. The bins are constantly overflowing and there are cigarette butts all over the street. By allowing the place to stay open longer will only cause more chaos and it's not something that neighbours with young families will accept.
Any other notes or points that you would like to be considered:	The whole place is mis managed with no care or consideration for locals. Customers have been offered drugs by other customers, the staff don't seem to care.

Most of the staff brag that they get paid cash in hand, particularly the girl who sells the crisps and sweets. That money goes straight into their pockets. Also, the place has several card machines, one is linked to the owners personal account – he's happy to tell everyone all about it.
The garage has been converted into a bar and kitchen but never seen any planning applications for change of use.
There is no disabled access and the disabled toilet was ripped out and replaced with two toilets that are far too small.
They have fruit machines but no gambling licence
They serve food but none of the staff have food hygiene certificates
They close for private after hours events with no warning to locals
They use a company car for personal use as they don't do deliveries
The owner brags that he keeps the cash to avoid paying VAT
They show football and other sport but don't have the right licenses with Sky or BT

The protection of children from harm The noise produced by the bar is astronomical as it is, they have a regular karaoke singer on inside who already sings well into the early hours and can be heard throughout the area. This "fan zone" will make matters worse as the patrons already play their own music on phones when in the back area and sing football chants, this will be even later than the licence being applied for as they already stay open later than licensed; the row adjacent has a new born baby and toddlers amongst the residents! The football fans that stray off Chester road already urinate in the alleys, there will be an increase of this for sure if they are drinking here. The customers laughing, shouting and sometimes fighting as they leave is disruptive already and there are bottles and glasses left around the streets that people finish on their way home. There is a nursery on Wesley street so the resulting detritus presents a risk of injury to the children. The structure itself looks like a shanty town with road work fencing and stripy warning tape all over it, not to mention the bins on display everywhere, total eyesore. As they mainly open only on match
	days any mess is just left until they next open as passersby sit on the benches and leave uneaten food and wrappers which attract vermin and the shed on the side of the building with a toilet in it can't be legal?!

	We have recently had a spate of weapons being dumped on residents property with knives and guns recently being found and handed in to police, whilst this may be unrelated to the fans if there were altercations with them and locals these items may be utilised and cause further incidents
