## 59. URGENT BUSINESS – MANCHESTER AIRPORT GROUP PLC

[Note: The Mayor allowed consideration of this matter as an item of urgent business since details of the matter had not been made available to the Council until a late stage and it was being asked for a decision as a shareholder before 24 December 2012.]

Further to Minute No. 74 of the Meeting held on 14<sup>th</sup> March 2012, the Leader of the Council and the Acting Chief Executive submitted a report updating the Council on the proposals to restructure Manchester Airport Group PLC and the associated decisions which were sought to enable the proposals to be progressed.

The Chief Executive, Acting Director of Transformation and Resources and Acting Director of Legal and Democratic Services provided a further explanation of the proposals and their financial implications and Members of the Council were then able to express their views on the matter.

RESOLVED: That, being broadly supportive of the proposals, the Council notes the decisions that the Executive is expected to take on behalf of Trafford at its meeting later that evening.
