c) Contracts Any contract which is made between <ul style="list-style-type: none"> • me or my spouse or partner*, or • a firm in which either of us is a partner, or • a body corporate of which either of us is a director, or • a body in the securities of which either of us has a beneficial interest and the Council— (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.

² "Securities" means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
