Report Title

Polling District and Polling Places Review

Summary

The report sets out proposals to enable the Council to comply with its statutory duty to review all Parliamentary polling districts and polling places and to review all local government polling districts and polling places at the same time.

Recommendations

- 1. That the Review Proposals for polling districts and polling places, as set out in Appendix B to this report, be approved by Council.**
- 2. That authority is delegated to the (Acting) Returning Officer in consultation with the Group Leaders to identify and approve the use of alternative suitable buildings that could be used as a polling place, if necessary and in the event that any approved polling places become unavailable for use on the date of the election.**

1. Introduction and purpose of Report

- 1.1 To consider the Council's proposals for the statutory review of polling districts and polling places.

2. Background

- 2.1 Under the Representation of the People Act 1983, the Council has a duty to divide their area into polling districts, to designate polling places for those polling districts, and to keep their electoral arrangements under review.
- 2.2 The Electoral Administration and Registration Act 2013, introduced compulsory timescales for the completion of statutory reviews of parliamentary polling districts and polling, reflecting the requirements as set out in Fixed Team Parliamentary Act 2011. The Council completed its last review between October 2013 and January 2015 and therefore, in accordance with the 2013 Act, the Council's next review must be completed between 1 October 2018 and 31 January 2020.

3. The Designation of Polling Districts, Polling Places and Polling Stations

- 3.1 The Council is responsible for the designation of polling districts within the borough. In the determination of polling district boundaries the Council must ensure that all electors in each area have such reasonable facilities for voting as are practicable in the circumstances.
- 3.2 The Council must also designate a polling place for every polling district. This is usually with the boundary of the polling districts unless there are special circumstances e.g. lack of suitable buildings.
- 3.3 In designating polling places, the Council must seek to ensure that:
- all the electors in the constituency have such reasonable facilities for voting as are practicable in the circumstances; and
- so far as is reasonable and practicable, the polling places they are responsible for are accessible to all electors, including those who are disabled, and when considering the designation of a polling place, must have regard to the accessibility needs of disabled persons.
- 3.4 The allocation of polling stations within polling places is not a Council function but is instead it is the responsibility of the (Acting) Returning Officer.
- 3.5 The polling station is the actual area where the voting takes place i.e. the room or area where electors cast their vote. The (Acting) Returning Officer is responsible for the designation of the polling station which must be in the polling place agreed by the Council.
- 3.6 In designating polling places, the Council utilises its powers under the Representation of the People Act 1983 when dividing constituencies into polling districts and also in dividing wards into polling districts at local government elections. Polling districts for local government elections are not automatically part of the statutory review. However the Electoral Commission advises that polling districts for UK parliamentary and local government elections should always be the same. It therefore follows that any review of parliamentary polling arrangements should be conducted simultaneously with one of local government arrangements, and with those for any other type of election for which provision is made for the designation of polling districts and polling places, for example, the Combined Authority Mayoral Election.

4. The Review

- 4.1 Notice of the review of polling districts and polling places was given on 3 July 2019 and information about the review, including details of the current polling stations were published on the Council's website, all Trafford Libraries and at Trafford Town Hall Reception.

As part of the public consultation process, the following were individually contacted:

- All Trafford Councillors
- Graham Brady MP Altrincham and Sale West Constituency

- Kate Green MP Stretford and Urmston Constituency
- Mike Kane MP Wythenshawe and Sale East Constituency
- Joanne Roney CBE the (acting Returning Officer for Wythenshawe and Sale East Constituency)
- Disabled Groups
- Trafford Partnerships
- Trafford Planning Department

Interested persons or organisations were invited to submit comments and suggestions.

- 3.3 Election Officers undertook visits to polling places during the consultation. The purpose of these visits was to assess the suitability of existing arrangements and identify alternatives where required.

4. The (Acting) Returning Officers Recommendations

- 4.1 During the consultation process throughout July and August 2019 a total of nine comments and representations were received by the Council. The comments and representations received are contained at Appendix A to this report.
- 4.2 The comments and representations received indicated that most of the arrangements were felt to be satisfactory and some concerned amendment to some of the existing polling places in particular, with a view to reducing the number of schools that are used as polling places.
- 4.3 Having carefully reviewed the comments and representations received, the (Acting) Returning Officer has proposed a small number of changes polling stations in particular, to address requests to reduce the number of schools that we use as polling places.
- 4.4 The (Acting) Returning Officer sought to identify suitable buildings for use as polling places, taking into consideration the following factors:
- Location and accessibility to electors within the polling district
 - Size – can it accommodate more than one polling station if required
 - Accessibility – is the building accessible to all those entitled to vote at the polling station
 - Availability – is the building readily available in the event of an unscheduled election
 - Facilities available in the venue including parking, heating, lighting, toilet facilities and security
 - Public buildings -the election rules allow the Returning Officer the free use of buildings maintained by the council including schools maintained by the authority and free schools. These will be identified in the first instance.
 - Private buildings – in the absence of suitable public owned buildings, churches, clubs and other private sector buildings conveniently located and accessible to electors are considered for designation as the polling place

- Mobiles – in the absence of any suitable public or private building in or adjacent to the polling district a mobile will be considered for designation as a polling place. Given the difficulties of heating, lighting, security, comfort of staff and electors, the negative reaction from residents living close to the site of a mobile and the significantly higher cost of locating a mobile polling station, these are considered only as a last resort.

4.5 The attached Appendix B sets out the (Acting) Returning Officer’s review proposals in full. The proposed changes to polling stations are specifically detailed at paragraph 4.11 below.

4.6 A summary of the (Acting) Returning Officer’s proposals:

- We currently use a total of 27 schools and as a result of the review we have identified alternatives polling stations for 12 school which means that, should the proposals be approved by Council, we could release at total of 12 schools ;
- Out of the remaining 15 schools we will be continuing to use, 10 are able to stay open on polling day and only 5 schools will be required to close on the day of elections.

4.7 In drawing up proposals for alternative polling stations the Returning Officer has followed the guidance of the Electoral Commission in respect of arrangements for voters.

4.8 The proposals have been considered by Group Leaders and the Elections Working Group.

4.9 The Council is requested to consider the proposals detailed in Appendix B and to approve the proposals incorporating any changes considered appropriate in order to fulfil the Council’s statutory duties in respect of relevant legislation.

4.10 To mitigate risks of disruption to the election process, the Council is also recommended to authorise the Chief Executive as (Acting) Returning Officer in consultation with the Group Leaders to identify alternative polling places to be used, if necessary, for any other polling stations unavailable on the date of the election.

4.11 It is proposed that the arrangements as set out in Appendix B are approved. Most of the arrangements remain unchanged but the table below sets out the (Acting) Returning Officer’s proposed changes to polling stations:

APPENDIX A: POLLING DISTRICT AND POLLING PLACES REVIEW 2019

No.	Polling Station	Comment
1	Urmston Primary School	The continued use of Urmston Primary School as a polling station is inappropriate and causes considerable disruption to the school, parents and pupils especially when there is a viable alternate solution. My proposal is that the meeting area of Urmston Library is used as the polling station for polling district 2URC. The separate meeting area meets all of the criteria outlined in your supporting information. There is a large car park close by, disabled access, adequate toilet facilities, including for the disabled. The suggested area would be separate from the library meaning that the library would not need to be disrupted and the suggested polling station is within the 2URC polling district. The other Urmston polling stations, 2URA, 2URB and 2URD are all in buildings that meet the requirements and do not disrupt any school functions and therefore it is inappropriate to continue to use Urmston Primary School as a polling station. -
2	Willows Primary School	The closure of the school for a Polling Station is unnecessary, disruptive and hugely costly for parents in terms of childcare and loss of holidays. I have been made aware of the reasons why the school is used, however there are other suitable alternatives to provide the necessary provision or utilise the external grounds of the school would allow such facilities, with relevant WC's that would allow some of all of the school to remain open. -
3	Willows Primary School	I would like a review of the Willows Timperley being used as a polling station. On polling day (2 this academic year) the whole school closes. In a culture where as parents are fined for taking children on 'holiday' for 1 days absence it baffles me that it is ok for children to miss this vital education for polling day. The frustration the 2 polling days causes for many of the willows parents was huge this year as the majority of us are working parents. As a working teacher (at a school that remains open on polling day) and with no alternative childcare meant that not only did my son miss out on days where he needed to be in school (baring in mind these are weeks before the phonics screening test) but my whole class were left with no class teacher as I had to stay at home with my child instead. Using schools as polling stations is having a detrimental effect on children's education and adding more pressure and financial strain on parents. If being off school wasn't affecting children's education we wouldn't be fined for taking children on holiday would we? As a parent it is very worrying that my child has not received the 190 days expected education this academic year. I'd like to suggest a few options for alternatives: -A porter caning being in place in the ward similar to the one used in Hall Ave or new haven home on moss lane. This may also help elderly resident who can vote more easily with less travel. -

4	Willows Primary School	I am getting in touch having read about the Polling station review taking place in Trafford. My two children attend Willows Primary School on Victoria Rd in Timperley. As this building is used for polling my children have had many days off school. This academic year there have been 2 polling days and my eldest daughter, who has been at the school for 5 years, has had a day off every year since starting school. This clearly has an impact on their learning, and it is also very difficult for working parents. I work as a teacher but the school where I work is not used for polling, and obviously as a teacher I cannot take a day off work. It would perhaps be acceptable if polling days took place every 3-4 years but as they are much more frequent than that it really is detrimental to learning. Surely there must be an alternative building that can be used in the locality? Church hall, sports club, playgroup, etc. - Sarah Joseph
5	Willows Primary School	Please, please, please can you stop using the Willows school in timperley. They have to close the whole school and it is so difficult for working parents. Especially in Trafford where I have three children in three different schools due to the grammar school system. This means I need to cover even more days off with the different holidays and inset days. There are surely other buildings that could be used in timperley village which would not have such a detrimental impact on family life. The larkhill, the Methodist church could be possible? As with most people at the Willows I use the fantastic after school and holiday club, but this is not available on election days either. It must also impact on their business, although you do have a pay for a portion of your sessions, even if then paying for childcare elsewhere. I would really appreciate your consideration of less disruptive options.
6		Please stop using local schools as polling stations. Parents aren't allowed to take their children out of school during term time without a fine but the council has no issue in repeatedly closing the schools for elections. It seems totally hypocritical and wrong.

7	Elmridge Primary School	<p>I am vice-chair of the local governing body for Elmridge Primary School in the Hale Barns ward.</p> <p>The staff at the school office have given me your details as the point of contact for polling stations and I am trying to ascertain how we get the school's position as the default polling station for the ward reviewed?</p> <p>The numbers continue to drop whilst the disruption to the school and the children's education is substantial. We feel as a governing body that there are far more suitable resources that could be used for a polling station in the ward with significantly less disruption to the local community.</p> <p>I look forward to hearing from you.</p> <p>Kind regards</p>
8	Davyhulme West	<p>are happy with where the polling stations are based in Davyhulme West.</p> <p>Best wishes</p>
9	Joanne Roney OBE ,Chief Executive, Manchester Council	<p>As the (Acting) Returning Officer for the Wythenshawe and Sale East Constituency, I have no specific comments to make about the polling districts or polling places.</p> <p>However, for the next Parliamentary General Election, which is scheduled to take place on 5 May 2022, and would be combined with local polls, I anticipate significant public interest and turnout to be high. I would therefore request that the polling places in Brooklands, Priory and Sale Moor wards have the capacity to accommodate double polling stations, where the number of electors in person is over 2,000. This request applies equally if circumstances lead to an 'early' Parliamentary General Election taking place before 2022.</p> <p>In both 2015 and 2017, Polling Station Inspectors (PSIs) from Manchester worked closely with PSIs from Trafford to provide effective management and oversight of polling stations on the ground, within the relevant wards, as part of wider command and control arrangements. A similar approach will be in put in place for the next Parliamentary General Election.</p>
