4. APPLICATION FOR GRANT OF A PREMISES LICENCE - THE HIDEAWAY, 218 CHURCH ROAD, FLIXTON

Monday to Thursday	8.00 to 21.00
Friday to Saturday	8.00 to 23.00

Additional Condition

Noise from Music and associated sources (Including DJs amplified voices)
Must not be audible to such an extent that it constitutes a nuisance at any noise sensitive properties.

No serving of alcohol outside the premises after 21.00
Outside table and Chairs to be stacked by 21.30
