Alcohol shall only be sold or supplied in plastic containers in the period prior to the commencement and duration of any football league or cup match played at the ground.

After 9.30 p.m. the tannoy system will not be used for music and only for public announcements.

LICENSING SUB-COMMITTEE'S REASONS FOR REACHING ITS DECISION

1. The Sub-Committee carefully considered the resident's concerns including the proximity of the premises to a residential area and the potential for noise nuisance and balanced those concerns with the interests of the applicant and the licensing objectives.
