1. Background

- 1.1 Premises Licence PL0393 (Appendix B) for Zuma (formerly Gastronomy) currently held by Mrs Filiz Smith, 33 The Uplands, Bishopton Drive, Macclesfield, SK11 8WG.
- 1.2 The premises were previously operated as a Deli and Café. The new licence holder wishes to operate the premises as a sushi restaurant.

2. Application to Vary the Premises Licence

- 2.1 On 9th January 2018 the Licensing Section received an application (**Appendix A**) from Mrs Filiz Smith for a variation to the hours of the existing premises licence.
- 2.2 The current licence permits the following licensable activities on the ground floor of the premises:

Sale of alcohol (On and Off)

08:30 to 17:00

Mon to Sun

2.3 The application requests a variation to the licence to extend the hours for the sale of alcohol:

Sale of alcohol (On and Off)

12:00 to 23:00

Mon to Sun

2.4 The applicant has complied with all requirements under the application process including advertising the application in a newspaper, advertising by way of public notice at the premises and submitting a copy of the complete application to all Responsible Authorities. The application is deemed to be correctly submitted.

3. Representations

3.1 The Licensing Section has received representations against the application from local residents on the grounds of prevention of public nuisance. See attached **Appendix D(1) – D(4)**.

4. Licensing Policy and Guidance

4.1 The Committee are respectfully referred to the Council's own Licensing Policy relating to the Licensing Act 2003 objectives and to the Secretary of State's Guidance. (Copy available at meeting)

5. Options

- 5.1.1 To grant the licence subject to-
 - Conditions consistent with the operating schedule accompanying the application modified to such extent as the authority considers necessary for the promotion of the licensing objectives, and;
 - Any mandatory conditions which must be included under the Licensing Act 2003
- 5.1.2 to exclude from the scope of the licence any of the licensable activities to which the application relates;
- 5.1.3 to refuse to specify a person in the licence as the premises supervisor;
- 5.1.4 to reject the application.
- 5.2 The Sub-Committee is advised that any findings on any issues of fact should be on the balance of probability and any decision should be based on the individual merits of the application.
- 5.3 The Sub-Committee, in arriving at its decision, must have regard to relevant provisions of national guidance and its own statement of licensing policy and reasons should be given for any departure.

Annex 1 - Mandatory Conditions

The following conditions must be read in conjunction with plan referenced PL000393

- 1. No supply of alcohol may be made under the premises licence:
 - (a) At a time when there is no designated premises supervisor in respect of the premises, or
 - (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3. Where the premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each such individual must be licensed by the Security Industry Authority.

ADDITIONAL MANDATORY CONDITIONS (28th May 2014)

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1:
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
 - (b) "permitted price" is the price found by applying the formula

 $P = D + (D \times V)$

Where

- (i) P is the permitted price
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol

and

- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence
 - (i) the holder of the premises licence
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

ADDITIONAL MANDATORY CONDITIONS (1st October 2014)

5. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises

- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purposes of encouraging the sale or supply of alcohol for consumption on the premises:
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to:
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise)
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner
 - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability)
- 6. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 7. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:

(a) a holographic mark

or

- (b) an ultraviolet feature
- 8. The responsible person must ensure that:
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
 - (i) beer or cider: ½ pint
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available


Annex 2 - Conditions Consistent with the Operating Schedule

- 1. Alcohol will only be served with food, to a limited number of customers.
- 2. Alcohol will not be served to persons who appear to be intoxicated.
- 3. Contact will be made with other licensed prem ises to share information.
- 4. Anyone appearing to to be underage will be required to produce identification.
- 5. A clear proof of age policy will be in place for all staff selling alcohol.

we note with concern the licensing application made in respect of 191 Ashley Road [formerly Gastronomy, now planned to be 'Zumu'] by Filiz Smith.

Hale does not require further bars, or any establishments that open late into the night and promote, encourage and increase late-night drinking.

This is a residential area - Zumu itself backs onto private housing - which is already beset by anti-social behaviour connected in large part, if not exclusively, with the excess consumption of alcohol during the day and into the early hours of the morning.

It is bad enough that most, if not all, eateries in Hale have transformed over the past years to focus predominantly on bar activity, with the provision of food merely incidental to drinking.

It has already been a lot quieter on this street - Westgate - since the closure (albeit presumably temporary) of the Cote restaurant.

It is a matter of regret that the Elk [formerly Moose] - which is located just one premises away from the proposed Zumu - was granted a license to serve alcohol. Even in the afternoon, when the weather permits, drinkers congregate on the pavement outside, which is littered subsequently with cigarette butts, chewing gum, other rubbish, often broken glass, which is not limited to that area.

In summary, we strongly oppose the application on the grounds that there will be increased anti-social behaviour connected with alcohol consumption (until 23.00); increased late-night traffic, associated with extension of opening hours increased anti-social behaviour associated with the excess consumption of alcohol; increased littering of public highway and side-streets; increase in general nuisance, especially to those living close by.

This is simply not a desirable or suitable addition to the high street; it is not a necessary amenity, nor does it provide services not already offered in abundance. This would increase the nuisance of anti-social and other negative behaviours in the middle of what is a residential area.

We oppose the application strongly.
