### Report Title

**APPLICATION TO VARY A PREMISES LICENCE UNDER S34 OF THE LICENSING ACT 2003 AT SILVER BLADES ICE RINK, STATION SITE, OAKFIELD ROAD/MOSS LANE, ALTRINCHAM, CHESHIRE WA14 1BA**

### Summary

Under S35 of the Licensing Act 2003, Members are requested to determine an application for a full variation to a premises licence in respect of Silver Blades Ice Rink, Station Site, Oakfield Road/Moss Lane, Altrincham, WA14 1BA having regard to the representations received and the requirement to promote the four licensing objectives.

### Recommendation(s)

Having regard to the representations, the Licensing Sub-Committee may take such steps (if any) as it considers appropriate for the promotion of the licensing objectives.

The steps are;

- (i) to modify the conditions of the licence;
- (ii) to reject the whole or part of the application;

For this purpose the conditions of the licence are modified if any condition is altered or omitted, or any new condition is added.

## **1.0 APPLICATION**

**1.1** A premises licence is required in respect of any premises where it is intended to conduct one or more of the four licensable activities, these being:

- The sale of alcohol
- The supply of alcohol (in respect of a club)
- Regulated entertainment
- The provision of late night refreshment

This application was submitted by Vernon Neil on behalf of Silver Blades Ice rink company (Altrincham) Limited.

- 1.3** The application has been properly made and all procedures correctly followed. The application and plan has been attached as **Appendix A**. Photograph of the blue notice in situation and newspaper advert are attached as **Appendix B**.

### **3.0 BACKGROUND AND HISTORY OF PREMISES**

- 3.1** The premises has been licenced since 23 February 2007 with no changes to the licence holder.

The premises licence holder applied on 24 May 2019 for a restricted variation to the licensable hours for a boxing event on 19 July 2019 and to permanently add the licensable activity of boxing to the authorisations of the premises licence until 23:00hrs. This licence was granted and is attached as **Appendix C**.

- 3.3** The current premises licence authorises the following:

Films (Indoors)

Monday – Sunday 06:00 – 23:00

Indoor Sporting Events

Monday - Sunday 06:00 – 23:00

Boxing or Wrestling Entertainments (Indoors)

Monday - Sunday 06:00 – 23:00

Live Music (Indoors)

Recorded Music (Indoors)

Monday - Sunday 06:00 – 23:00

Performance of Dance (Indoors)

Monday - Sunday 06:00 – 23:00

Anything of a similar description (Indoors)

Monday - Sunday 06:00 – 23:00

Supply of Alcohol (On & Off)

Monday - Sunday – 10:00 – 23:00

Opening Hours

Monday - Sunday 06:00 - 00:30

### **4.0 OPERATING SCHEDULE**

- 4.1 The operating schedule is completed by the applicant and contains additional measures to illustrate how they propose to promote the four licensing objectives as required by provision of the Licensing Act 2003.

The measures proposed in the application match the existing licence conditions from the most recent full variation application. The current Premises Licence is attached as **Appendix C**.

Additional measures were agreed with the Environmental Health Officer during the consultation period. This is attached as **Appendix D** and further detailed below:

- To amend our application to a one off variation to our licence for 1 day only for Friday 13<sup>th</sup> December 2019, extending all our licensing objectives for this day for an hour until 00:00.
- Change the closing time from 00:30 to 00:00 - We are comfortable that midnight allows for enough of a safety buffer. The TV show is scheduled to finish at 11pm so the extra hour is a safety net for any unforeseen circumstances to the event schedule.
- Noise / environmental - In addition to the security plan submitted for the previous show. We also have additional stewards in the car park in front of the building this time. To help manager the traffic and the public arriving / leaving the venue. These are there to control any noise pollution, particularly one exit and remind all attendees to respect our neighbours.
- Letter Drop - We will be conducting a letter drop in the area to let all the local neighbours know about the event. On this we will now include a dedicated hotline and have someone man the phone throughout the event. This will be for neighbours to have direct contact with the organisers for any issues / concerns they have. So that we can communicate our plans and/or react to solve them.
- Travel - Being so close to the train station and tram station, any people traveling in to Manchester have access to the train station on our doorstep to leave the area. These trains run until 00:37 so will be operating around our event egress.

- Noise from music and associated sources (including DJ's and amplified voices) must not be audible to such an extent that it constitutes a nuisance at any noise sensitive properties.
- Acoustic consultants shall be employed to monitor noise relating to the event and associated activities to comply with the above condition.
- A noise management plan shall be submitted for approval, 14 days prior to the event to demonstrate how noise associated with the event will be managed (to include proposals for monitoring noise relating to the event, noise from

traffic/public arriving at/leaving the venue, measure to address noise from plant and vehicles relating to the event set up, letter drop to local residents, action phone line in the event of complaints including plans for corrective action, noise from staff and any other noise associated with the event).

- All external doors and windows shall be kept closed when regulated entertainment is being provided except in the event of an emergency.
- There shall be placed at all exits from the premises in a place where they can be seen and easily read by the public, (or member and their guests) notices requiring customers to leave the premises and the area quietly. (Note, this may also include a reference to vehicles).

The application operating schedule is therefore amended to include the above conditions. Should the licence be granted, the above conditions will only apply to the Boxing Event on 13 December 2019.

## **5.0 STATEMENT OF LICENSING POLICY**

**5.1** The following extracts from the Council's statement of licensing policy are brought to the general attention of members:

**5.2** (1.8) Every application considered by the Council under this policy will be considered on its merits, and regard will be given to the Guidance issued under Section 182 of the Licensing Act 2003 and any supporting regulations..

**5.3** (1.9) Nothing in the policy will undermine the right of any person to make representations on an application or seek a review of a licence or certificate where provision has been made for them to do so in the Act. Appropriate weight will be given to all relevant representations. This will not include those that are frivolous, vexatious or repetitious.

**5.4** (1.12) The licensing process can only seek to control those measures within the control of the licensee, and 'in the vicinity' of a premises. The conditions attached to various authorisations will, therefore, be consistent with operating schedules and will mainly focus on:

- Matters within the control of individual licensees and others who are granted any relevant authorisations;
- The premises and places being used for licensable activities and their vicinity; and
- The direct impact of the activities taking place at the licensed premises on members of the public living, working or engaged in normal activity in the area concerned.

**5.5** (5.6) When considering applications for later closing times in respect of premises licences, where relevant representations have been made, the Council will take the following into consideration in accordance with Government Guidance:

- Whether the premises is located in a predominately commercial area
- The nature of the proposed activities to be provided at the premises
- Whether there are any arrangements to ensure adequate availability of taxis and private hire vehicles and appropriate places for picking up and setting down passengers
- Whether there is an appropriate amount of car parking, readily accessible to the premises, and in places where the parking and use of vehicles will not cause demonstrable adverse impact to local residents
- Whether operating schedule indicates that the applicant is taking appropriate steps to comply with the licensing objective of preventing public nuisance
- Whether the licensed activity, particularly if located in areas of the highest levels of recorded crime, may result in a reduction or increase in crime and anti-social behaviour
- Whether the licensed activities are likely to cause adverse impact especially on local residents, and whether, if there is a potential to cause adverse impact, appropriate measures will be put in place to prevent it
- Whether there will be any increase in the cumulative adverse impact from these or similar activities, on an adjacent residential area
- Any representations from a responsible authority or interested party that identify the premises as a focus for disorder and disturbance.

**5.6** (5.8) As far as premises in residential areas are concerned, these may be subject to stricter controls with regard to opening hours to ensure that disturbance to local residents is minimised. The Council considers that it is self-evident that the risk of disturbance to local residents is greater when licensable activities continue late at night and into the early hours of the morning. For example the risk of residents' sleep being disturbed by patrons leaving licensed premises is obviously greater at 2 a.m. than at 11 p.m. It is, therefore, the policy of the Council to strike a fair balance between the benefits to a community of a licensed venue and the risk of disturbance to local residents. In predominantly residential areas, therefore, it may not be appropriate to allow closing times later than midnight. It may be acceptable to open later on a limited number of occasions, for example up to 15 times a year. This would allow licensees to extend opening beyond midnight for special occasions such as New Year. However, every application will be determined on its merits, and applicants wishing to operate beyond midnight will need to demonstrate to the satisfaction of the Council, in their operating schedule, that there will be no significant disturbance to members of the public living, working or otherwise engaged in normal activity around the premises concerned. This policy is aimed at the fulfilment of the licensing objective of "prevention of public nuisance".

**5.7** (6.4) Applicants will be expected to demonstrate in their operating schedule that suitable and sufficient measures have been identified and will be implemented and maintained with the intention of preventing crime and disorder. Such measures may include:

- The capability of the person who is in charge of the premises during trading hours or when Regulated Entertainment is provided to effectively and responsibly manage and supervise the premises, including associated open areas
- The steps taken or to be taken to ensure that appropriate instruction, training and supervision is given to those employed or engaged in the



premises to prevent incidents of crime and disorder, and where appropriate any relevant qualifications.

- The measures taken or to be taken to raise staff awareness and discourage and prevent the use or supply of illegal drugs on the premises
- The features currently in place or planned for physical security at the premises, such as lighting outside the premises
- Policies adopted to meet appropriate best practice in accordance with existing guidance (e.g. Home Office: Selling Alcohol Responsibly, Safer Clubbing, the National Alcohol Harm Reduction Strategy Toolkit and other recognised codes of practice, e.g. British Beer and Pub Association Partnerships Initiative.
- Any appropriate additional measures taken or to be taken for the prevention of violence or public disorder.

**5.8** (6.7) Where additional measures have been identified as likely to have an impact on the prevention of crime and disorder at any premises, the Council would expect applicants to detail such measures to be taken in their operating schedules. Such measures may include:

- Provision of effective CCTV with recording facilities both within and outside certain premises
- Crime prevention design, including adequate lighting and supervision of car parks
- Metal detection and search facilities
- Procedures for risk assessing promotions and events such as 'happy hours' for the potential to cause crime and disorder, and plans for minimising such risks
- Measures to prevent the use or supply of illegal drugs
- Employment of Security Industry Authority licensed door supervisors and other appropriately trained staff
- Participation in an appropriate Pubwatch Scheme or other similar scheme
- Promotion of safe drinking
- The control of glass and the provision of plastic containers or toughened glass
- Use of radio net system (where available)
- Provisions for dealing with prostitution or indecency
- Provisions for discouraging drinking in public places in the vicinity of the premises
- Policies on dress and music
- Appropriate additional staff training.

**5.9** (6.8) All premises applying for licensing beyond 00:00hrs must demonstrate that its customers will be capable of leaving the area without causing a disruption to local residents or impact upon crime and disorder. For example, where appropriate and relevant an assessment of the availability of late night transport, and the likely flow of pedestrian traffic away from the premises, could be included in the operating schedule.

**5.10** (6.10) Where either prescribed and/or premises-related conditions have not been adhered to in the past, the Council will expect applicants to have

considered and taken action to rectify those issues. Applications are likely to be refused where there are significant outstanding issues.

- 5.11** (7.5) In considering applications, the Council will expect to see evidence that the applicant has identified matters that impact on the likelihood of public nuisance and that these matters have been addressed in the operating schedule. Such measures may include:
- Measures taken or proposed to be taken to prevent noise and vibration escaping from the premises or in the immediate vicinity of the premises and including any outside areas (including smoking areas) bearing in mind the location of premises and proximity to residential and other noise sensitive premises (e.g. hospitals, hospices and places of worship); This would include music, ventilation equipment noise and human voices, whether or not amplified;
  - Measures taken or proposed for management and supervision of the premises and associated open areas to minimise unreasonable disturbance by customers and staff arriving or departing from the premises and delivery of goods and services.
  - Control of opening hours for all or part (e.g. garden areas) of the premises
  - Measures taken to control light to ensure that it does not stray outside the boundary of the premises such as to give rise to problems to residents in the vicinity
  - Steps taken to lessen the impact of parking in the local vicinity
  - Measures taken to prevent someone who has consumed excess alcohol from entering the premises and to manage individuals on the premises who have consumed excess alcohol
  - Management arrangements for collection and disposal of litter and refuse, and the control of pests
  - Arrangements for ensuring that adequate and suitably maintained sanitary provision and washing facilities are provided for the number of people expected to attend any premises or events
  - A 'wind down time' after the last service of alcohol, during which time the venue may offer for sale non-alcohol beverages
  - A 'last admission time' policy
  - Management arrangements for any proposed use of bonfires, fireworks and other pyrotechnics.
- 5.12** (11.7) Standardised conditions will be avoided, although 'pools of conditions' will be used from which necessary and proportionate conditions may be drawn in particular circumstances.
- 5.13** (11.8) Conditions attached to licenses and certificates will be tailored as appropriate to reflect the individual style and characteristics of the premises and events concerned.
- 5.14** (11.9) Conditions will not be imposed which are beyond the responsibility or control of the licence holder.
- 5.15** (14.1) "Cumulative impact" means the potential impact on the promotion of the licensing objectives of a significant number of licensed premises concentrated in one area. For example, the potential impact on crime and disorder or public nuisance on a Town Centre of a large concentration of licensed premises in

that part of the local authority licensing area. In certain circumstances the number, type and density of premises selling alcohol for consumption on the premises may be such that there are serious problems of nuisance and disorder arising or beginning to arise outside or some distance from licensed premises. It is possible that the impact on surrounding areas of the behavior of the customers of all premises taken together is greater in these circumstances than the usual impact from customers of individual premises.

**5.16** (14.4) When such a special saturation policy is adopted, each application will still be considered properly and on their own individual merit, and licences and certificates that are unlikely to add to the cumulative impact on the licensing objectives will be granted. Following receipt of representations in respect of a new application for or a variation of a licence or certificate, the Council will consider whether it would be justified in departing from the special policy in the light of the individual circumstances of the case. The impact can be expected to be different for premises with different styles and characteristics. It will be for the Council to show that the grant of the application would undermine the promotion of one of the licensing objectives and if it would, that necessary conditions would be ineffective in preventing the problems involved.

**5.17** (14.5) In considering such applications the Committee will have particular regard to:

- The occupancy figure for the proposed premises.
- The proximity of the premises to others in the Area licensed for similar activities and the occupancy figures for those other premises.
- Whether the proposed premises will act as a replacement for others in the Area that no longer have a licence.
- The proposed methods of management outlined in the applicant's operational plan.
- The proposed hours of operation.
- Transport provision for the Area.

## **6.0 CONSULTATION**

**6.1** The responsible authorities included in consultation are; Licensing, Greater Manchester Police, Greater Manchester Fire & Rescue, Environmental Health & Pollution Control, Building Control, Health and Safety Team, Home Office Immigration Enforcement, Planning Department, Safeguarding Children Team, Trading Standards and Public Health.

**6.2** Of those consultees identified in paragraph 6.1, one representation was received from the Environmental Health Pollution Control Authority. Measures were agreed during the consultation period and the representation was satisfied, see **Appendix D**.

**6.3** A representation has been submitted by an Other Person. This representation is concerned with crime and disorder and public nuisance. See **Appendix E**.

**6.4** A copy of the report and all representations received have been sent to the applicant.

**6.5** Those that have made representations have been informed of the time and date of the Licensing Sub-Committee meeting and have been informed of their right to attend.

## **7.0 LEGAL CONSIDERATIONS**

**7.1** Conditions may only be attached to a Premises Licence where they are deemed appropriate for the promotion of the licensing objectives. They must be proportionate and not duplicate any existing provisions contained in other legislation. The justification behind a refusal or the attachment of conditions must be given to the applicant.

**7.2** The Sub-Committee is advised that any findings on any issues of fact should be on the balance of probabilities and any decision should be based on the individual merits of the application.

**7.3** The Sub-Committee, in arriving at its decision; must have regard to relevant provisions of national guidance and its own statement of licensing policy and reasons should be given for any departure.

**7.4** There is a right of appeal to the Magistrates Court within 21 days from the date the Applicant is notified of the decision of the Licensing Sub-Committee.

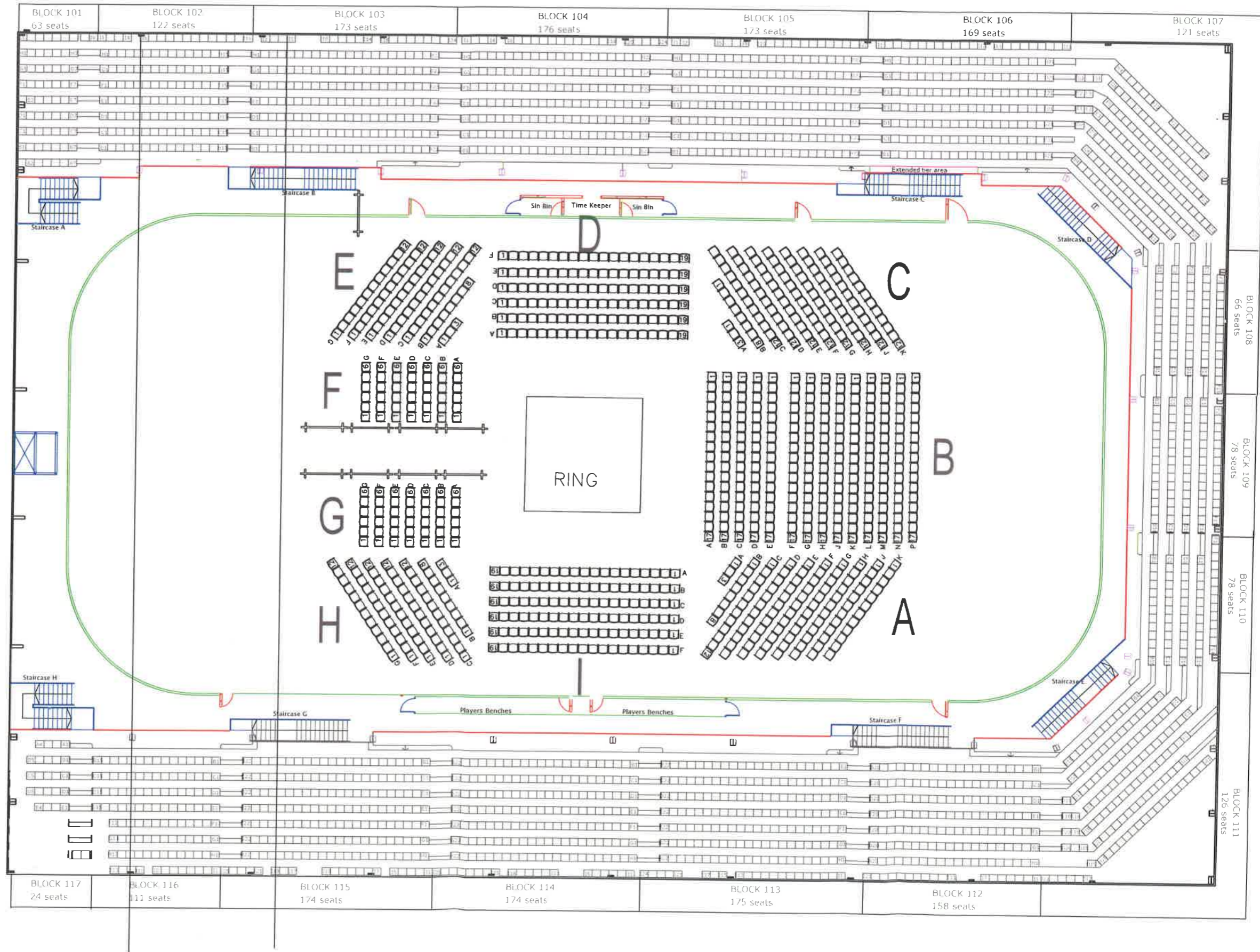

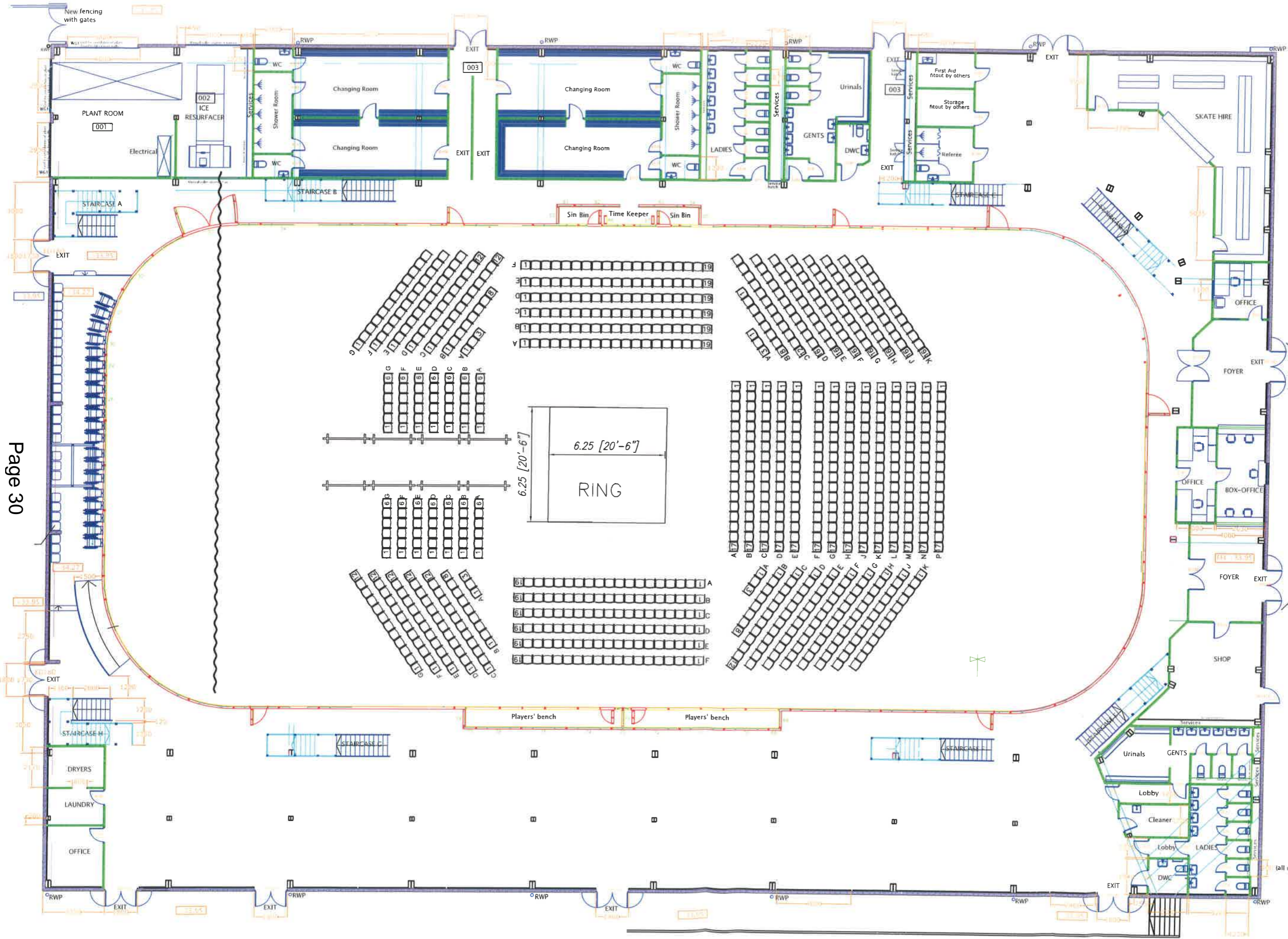

#### MANDATORY CONDITIONS

1. No supply of alcohol may be made under the premises licence:
  - (a) At a time when there is no designated premises supervisor in respect of the premises, or
  - (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended
2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.



3. Where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.
4. Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendation made by that body.
5. Where
  - (a) the film classification body is not specified in the licence, or
  - (b) the relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question

Admission of children must be restricted in accordance with any recommendation made by that licensing authority.

6. In this section

“children” means persons aged under 18;

and

“film classification body” means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).

7. Where the premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each such individual must be licensed by the Security Industry Authority.

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence

(i) the holder of the premises licence

(ii) the designated premises supervisor (if any) in respect of such a licence, or

(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

**ADDITIONAL MANDATORY CONDITIONS (1<sup>st</sup> October 2014)**

5. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purposes of encouraging the sale or supply of alcohol for consumption on the premises:

(a) games or other activities which require or encourage, or are designed to



require or encourage, individuals to:

- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
  - (ii) drink as much alcohol as possible (whether within a time limit or otherwise)
  - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective
  - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective
  - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner
  - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability)
6. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
7. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:
- (a) a holographic mark
- or
- (b) an ultraviolet feature
8. The responsible person must ensure that:



- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
- (i) beer or cider: ½ pint
  - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - (iii) still wine in a glass: 125 ml; and
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available

#### Annex 2 – Conditions Consistent with the Operating Schedule

1. The premises licence holder will adopt appropriate policies and procedures, including the carrying out and implementation of all necessary and appropriate risk assessments, and train staff in all aspects of regulatory compliance.
2. The premises licence holder will install and operate a CCTV system with cameras located in various positions inside the ice stadium to ensure there is adequate surveillance of the public areas with continuous recording during operational times. Digital recordings will be retained for a minimum period of 31 days and made available to the police on reasonable request.
3. Patrons will be required to enter the stadium via the main reception and there will be a turnstile entrance to the arena including the spectator areas.
4. The premises are purpose built as an ice stadium and will comply with current building regulations.
5. Signage will be placed in suitable locations at the entrance to the ice stadium to advise patrons to respect residents living nearby and to leave quietly.
6. The premises licence holder will encourage a close relationship with local residents and any complaints will be acted upon and reported back to the individual making the complaint within a reasonable time.
7. Children under the age of 18 years will frequent the premises.
8. Individuals who seek to obtain alcohol under the age of 18 years or adults who supply alcohol to individuals under that age will be barred from the premises and signage to this effect will be placed in the bar area.



9. A Stewarding Plan shall be submitted to the Licensing Authority prior to any regulated activity taking place at the venue. The Stewarding Plan shall identify the numbers of chief stewards and stewards, their specific roles and responsibilities.

10. Stewards shall not be engaged in any ancillary duties that would hinder the prompt discharge of their duties and responsibilities as set out in the Stewarding Plan in the event of an emergency or entail their absence from the floor or area of the auditorium where they are on duty.

11. Any Stewards shall be readily identifiable to any member of the public attending the regulated activity.

12. There shall be in place arrangements for the safe evacuation in the case of an emergency or other reason of disabled persons attending the premises. Details of those arrangements shall be recorded in writing and all staff employed on the premises shall be aware of those arrangements and receive the necessary training to implement such arrangements.

13. All disabled persons on the premises shall be made aware of the evacuation arrangements.

14. There shall be maintained on the premises at all times an adequate and appropriate supply of first aid equipment and materials.

15. At all times when the public are present, at least one person who holds a current recognised first aid certificate or award shall be present on the premises. Where more than one such person is present their duties shall be clearly defined.

**THE FOLLOWING CONDITIONS MUST ALL BE FULLY MET PRIOR TO THE HOLDING OF THE FIRST EVENT IN THE BUILDING:-**

16. A satisfactory NICEIC or ECA periodic emergency lighting report will be supplied by the premises licence holder.

17. The premises licence holder shall provide adequate external wayfinding lighting into the building and from the emergency exits.

18. A satisfactory NICEIC or ECA periodic electrical installation report will be supplied by the premises licence holder.

19. A satisfactory CORGI certificate of inspection in respect of any gas boiler, calorifier or appliance will be supplied by the premises licence holder.

20. A satisfactory certificate of inspection for fire fighting equipment will be supplied by the premises licence holder.

21. The premises licence holder shall furnish the Licensing Authority with written confirmation from the insurers of the building (both public and employer's liability) that notwithstanding the fact that the building work has not been completed, full cover extends to any matches held



before all the building work is complete.

22. The premises licence holder shall furnish the Licensing Authority a written risk assessment for the venue which will take into account general risks and specific risks that are presented by the temporary site conditions and which will be reviewed and updated prior to each event to take into account any changes in the temporary site conditions which may arise between events.

23. The premises licence holder shall furnish the Licensing Authority with contact details of catering which will be provided at the venue and their location in the venue.

24. The premises shall be provided with a dequate lavatory accommodation which shall at all times when the premises are in use be kept clean, ventilated, disinfected and supplied with hot and cold water, soap, toilet tissue, hand drying and sanitary towel disposal facilities as appropriate. If the female toilet provision can not be met, then the premises licence holder shall provide at least 10 female toilets if BS4645-1-2006 standard cannot be met.

25. The premises licence holder shall provide the licensing authority with operating conditions to ensure that the event operates safely. This shall include the following:

- a. Details of spectator numbers.
- b. Details of which areas are to be occupied
- c. Details of closed areas.
- d. Access points.

26. All exits and escape routes to those exits (including external escape routes) from the premises shall be provided with non-slip even surfaces and shall be maintained in good repair, correct working order and kept free from all obstructions. External escape routes shall also be kept free from ice and snow.

27. The nosings on all steps and landings shall be highlighted by painting them in contrasting colours or other similar means and subsequently maintained so that they are clearly visible.

28. All doors or gates both inside and outside the premises which are on an escape route shall be fitted only with approved fasteners and shall at all times be properly maintained, free from obstruction and be capable of being opened easily and fully so that they do not restrict the public leaving the premises and shall open in the direction of the escape route.

29. Where a door on an escape route opens against the direction of exit travel, it shall be locked in the open position by a tamper-proof fastening when the public uses the premises and there shall be a clearly visible notice in capital letters which contains the following words, "THIS DOOR SHALL BE KEPT LOCKED IN THE OPEN POSITION WHEN THE PREMISES ARE OCCUPIED" displayed in a clearly visible position next to the door.

30. All exit doors and gates from premises or enclosure(s) surrounding it shall be capable of being opened by any person without the use of a key, card, code or other similar means and be kept free from all fastening devices when the premises are open to the public.

31. All exit routes and doors on such routes shall be checked on every occasion before the

premises is used for purposes of a licensable activity and at regular occasions when the premises are open to the public to ensure that they are free from defect, obstruction, trip hazards and surfaces are not slippery. A record of such inspections, any defects discovered and the remedial action taken shall be made in writing in a logbook kept for that purpose. That logbook shall be made available for inspection on demand to an Authorised Officer of the Council, a Fire Officer or a Police Constable.

32. The method of opening any exit door or gate from the premises or enclosure(s) surrounding it shall be clearly displayed immediately above or below the fastening in white block lettering on a green background in letters not less than 50 mm high.

33. Where any automatic self-closing fire-resisting doors activated by a fire alarm or fire detection system are fitted within the premises they shall not be prevented from closing by any device and shall be marked to both sides of the doors so that they are clearly visible and positioned at or about eye level with the words "FIRE DOOR KEEP CLEAR" in block letters not less than 50mm high when the premises are open to the public.

34. Where a fire-resisting door is fitted within the premises and that door is required to be kept closed at all times then the door shall be clearly marked on both sides with a sign bearing the words "FIRE DOOR KEEP CLOSED" in block letters not less than 50mm high and clearly visible when the premises are open to the public.

35. The premises licence holder shall provide the Licensing Authority with a certificate of adequacy or equivalent documentation relating to the strength and lateral loading to all staircase balustrades and balustrades (inclusive of the translucent screens) guarding all floor edges and spectator seating areas.

36. The premises licence holder shall ensure that concrete hard standings are immediately outside each emergency escape required.

37. The premises licence holder shall ensure that the sheeting of the external wall guarding the edge of the upper seating area is completed.

38. The premises licence holder shall provide additional emergency lighting required on the staircase adjacent to the freezer unit.

39. The premises licence holder shall provide additional emergency lighting required at ground floor level on the main thoroughfare adjacent to the pitch.

40. The premises licence holder shall amend the Management Plan to provide for the:-

1. Stewarding of the underseating area.
2. The location of the Steward supervisor in close proximity to the Public Address system.
3. Authorisation of all emergency instructions by the person identified within the plan as having overall control during all events.

41. The premises licence holder shall ensure that the construction compound under the disused/unfinished side and the temporary staircase should be secured with heras fencing to





prevent unauthorised public access.

42. The premises licence holder shall ensure that the area around the external perimeter should be made good and level to facilitate emergency evacuation. It is noted that it is proposed that a 1.8m wide concrete apron around the external perimeter will be provided prior to the first event proposed to be held in the building.

43. The premises licence holder shall ensure that additional emergency lighting luminaires are provided to the foot of staircase B and the adjacent ice rink perimeter walkway.

44. Noise from music and associated sources( including DJ's and amplified voices) must not be audible to such an extent that it constitutes a nuisance at any noise sensitive properties.

45. We require that a suitable and sufficient health and safety risk assessment (or Event Management Plan) of the boxing activity be submitted to the Licensing Authority and Environmental Health a minimum of 21 days prior to each event taking place. For the event on the 19th July 2019 we have agreed that the submittal will be a minimum of 14 days.

46. There shall be in place for the premises a written Challenge 25 policy to prevent the sale or supply of alcohol to persons under 18 years of age. That policy shall require any person who appears to be under the age of 25 years who is attempting to buy alcohol to produce a recognised proof of age card accredited under the Proof of Age Standards Scheme (PASS) or if a proof of age card is not available a photo driving licence or passport.

47. A Challenge 25 notice or notices shall be displayed in and at the entrance to the premises where they can be clearly seen and read, a further notice should be displayed at the bar service area where it can be clearly seen and read.

48. A Refusal Register shall be kept on the premises and made available for inspection for an authorised officer.

Further to my memorandum dated 06/11/19, relating to the full variation licence application for the above premises, the applicant has amended the application and proposed the following:

- *To amend our application to a one off variation to our licence for 1 day only for Friday 13<sup>th</sup> December 2019, extending all our licensing objectives for this day for an hour until 00:00.*
- *Change the closing time from 00:30 to 00:00 - We are comfortable that midnight allows for enough of a safety buffer. The TV show is scheduled to finish at 11pm so the extra hour is a safety net for any unforeseen circumstances to the event schedule.*
- *Limit the number of events to 8 times per year - that we operate until the later hours. Initially we didn't include a restricted number of events in the application, we feel this is a much fairer proposal for the long term, considering the wider neighbours.*
- *Noise / environmental - In addition to the security plan submitted for the previous show. We also have additional stewards in the car park in front of the building this time. To help manage the traffic and the public arriving / leaving the venue. These are there to control any noise pollution, particularly one exit and remind all attendees to respect our neighbours.*
- *Letter Drop - We will be conducting a letter drop in the area to let all the local neighbours know about the event. On this we will now include a dedicated hotline and have someone man the phone throughout the event. This will be for neighbours to have direct contact with the organisers for any issues / concerns they have. So that we can communicate our plans and/or react to solve them.*
- *Travel - Being so close to the train station and tram station, any people traveling in to Manchester have access to the train station on our doorstep to leave the area. These trains run until 00:37 so will be operating around our event egress.

The Pollution section has reviewed the above amendments. Whilst the concerns relating to public nuisance from the premises still stand due to the nature of the building and historical complaints, there would be no objection to allowing for a one off event to take place on Friday 13<sup>th</sup> December 2019, extending all forms of regulated entertainment on this day for an hour until 00:00. This would be subject to the following conditions:

- Noise from music and associated sources (including DJ's and amplified voices) must not be audible to such an extent that it constitutes a nuisance at any noise sensitive properties.
- Acoustic consultants shall be employed to monitor noise relating to the event and associated activities to comply with the above condition.

REP Pool of Licensing Conditions.

- A noise management plan shall be submitted for approval, 14 days prior to the event to demonstrate how noise associated with the event will be managed (to include proposals for monitoring noise relating to the event, noise from traffic/public arriving at/leaving the venue, measure to address noise from plant and vehicles relating to the event set up, letter drop to local residents, action phone line in the event of complaints including plans for corrective action, noise from staff and any other noise associated with the event).
- All external doors and windows shall be kept closed when regulated entertainment is being provided except in the event of an emergency.
- There shall be placed at all exits from the premises in a place where they can be seen and easily read by the public, (or member and their guests) notices requiring customers to leave the premises and the area quietly. (Note, this may also include a reference to vehicles).

The Pollution Section do not support the proposal for 8 events per year at this stage due to historical noise complaints relating to the premises since these comments relate solely to the proposed event to be held on Friday 13<sup>th</sup> December 2019.

Dear Sir/Madam,

I wish to object to Licensing Application LA0317/19 and have sent this objection to the Licensing Section's postal address as instructed.

It should be noted that I have already made a complaint about the late ending of a boxing event at Altrincham Ice Rink this year due to excessive noise and disturbance caused to residents on Oakfield Road. It was dealt with by Nasreen Ali. The event on that occasion finished just after midnight and the boisterous crowd took at least an hour to disperse which meant people were shouting to each other, sounding car horns and banging car doors. The crowd was fuelled not only with the excitement of an aggressive sporting event but also very clearly with alcohol which made them extra loud. My house has triple glazing at the front and back but even this was insufficient to allow me to get to sleep.

My objections to the above application are as follows, based on the fact that the venue is located in a residential neighbourhood and is surrounded on three sides by residences in apartments and terraced houses:

1. I believe it would be severely detrimental for local residents for the venue to be allowed to serve alcohol so late into the night (midnight), particularly as alcohol causes people to become very loud, irrational, emotional, inconsiderate and sometimes physically violent.
2. I believe it would be unreasonable to allow the venue to host large crowd events until the early hours of the morning (12.30am) as it will result in more noise and disturbance for residents lasting, based on previous experience, for at least an hour after the event finishes (1.30am), possibly longer.
3. I understand that the Ice rink has recently been made a lawful building rather than a temporary one, but this does not negate the fact that it is just a tin shed and has no sound proofing like other purpose-built venues. The result is that residents are always going to be disturbed by crowd and entertainment noise within the building. It is therefore unreasonable to allow the venue to host large crowd events 365 days a year, and particularly with the time extensions requested above in points 1 & 2. Residents are already disturbed by the ice rink's normal events (ice hockey matches and ice dance entertainment) but at least these events end at a generally reasonable time. Giving the venue free reign to disturb residents 365 days a week into the early hours is just not acceptable.

Residents already have to put up with a lot being so close to the town centre. I appeal to the Licensing Committee not to make it impossible for them to live without unreasonable disturbance.
