## REASONS FOR THE DECISION

Through submitting a comprehensive Trafford Communities and Place Investment Plan, Trafford will benefit from significant funding being awarded to the borough to deliver a wide range of projects that meet Corporate Priorities and local need.

## RECORD OF THE DECISION

PROPOSED CHANGES/SAVINGS TO THE COUNCIL TAX DISCRETIONARY SCHEMES INCLUDING THE COUNCIL TAX SUPPORT SCHEME FROM APRIL 2023

- (i) That the implementation of the Council Tax Discretionary Scheme changes on the discretionary Empty Property Charges, detailed in this report from April 2023, be approved.
- (ii) That the introduction of the maximum charge on long term empty properties, subject to the outcome of the Levelling Up and Regeneration Bill, be approved.

## REASONS FOR THE DECISION

The following discretionary discounts on empty and unfurnished properties were offered by

#### Trafford:

- 100% discount for up to 1 month, including new properties;
- 100% discount for up to 12 months on properties requiring structural repairs or alterations to make it suitable to live in.

In 2021/22, the total amount of these awards cost the Council c£985k.

There was no overwhelming opposition to the proposals to remove these discretionary schemes from the consultation exercise carried out. Therefore, it was proposed to remove the discounts in order to support the Council's overall budget position and protect vital community services.

### ALTERNATIVE OPTIONS CONSIDERED AND REJECTED AT THE MEETING/BY MEMBERS

The Council could decide to leave the existing discretionary awards in place however, this would potentially mean that savings would need to come from elsewhere which is more likely to have a more direct impact on vulnerable and/or financially struggling residents.

(i) That the 2023/26 proposed budget strategy, including the 2023/24 draft revenue

budget and the 2023/27 MTFS, be approved.

- (ii) That the proposal to increase Council Tax by 2.99% in 2023/24 (comprising 1.0% adult social care precept and 1.99% general increase) and by similar levels for the remaining years of the MTFS 2023/26 be noted.
- (iii) That the assumptions made in setting the MTFP in section 3.2 and the degree of uncertainty be noted.
- (iv) That the remaining budget gap for the years 2023/24 to 2025/26 be noted.
- (v) That the commentary of the Director of Finance and Systems, the Council's statutory S151 officer, regarding the financial sustainability of the Council in Section 1.6 be noted.
- (vi) It be noted that the draft proposals are subject to various consultation exercises, further analysis of reserves, savings and income including impact assessments, potential future movements in core funding and specific grants, revised costings and robustness assessments.
- (vii) It be noted that the review of the Capital Programme which is ongoing and agreed that no further contractual commitments are made on capital projects which are financed from either capital receipts or borrowing until the current review of the capital programme is completed.
- (viii) That the flexible use of capital receipts to support in part the cost of the Modernisation Team in developing the Council's Finance and Change Programme for the next two years be noted.

# REASONS FOR THE DECISION

To enable consultation with the public, businesses (s65 of the Local Government Finance Act 1992), stakeholders, staff and Scrutiny Committee to take place.

## ALTERNATIVE OPTIONS CONSIDERED AND REJECTED AT THE MEETING/BY MEMBERS

The budget proposals included within the report assume an overall increase to the level of council tax of 2.99% in 2023/24 comprising an increase of 1.0% for the 'adult social care precept' to be earmarked for adult social care expenditure and 1.99% general increase in the 'relevant basic amount'.

An alternative option could be made to increase its 'relevant basic amount of council tax' above these levels. However, this would exceed the referendum limits, which would mean a local referendum would be required to be held before any such increase could be implemented.

Alternatively, not increasing council tax by the level recommended in this report, subject to the final referendum level being notified in December 2022, would increase the overall funding gap by up to £3.41m in 2023/24 which would mean further reductions to expenditure on council services would be necessary.
