# RECORD OF THE DECISION

CONSULTATION RESULTS FOR MCF CROSSINGS PROPOSALS AT A56 DUNHAM ROAD AND GORSEY LANE, ALTRINCHAM

- 1. That the content of the report be noted.
- 2. That the proposals for the junctions within the report be progressed to detailed design and subject to no significant design amendments, the proposals then proceed to delivery.

### REASONS FOR THE DECISION

The proposals align with Trafford Council's Corporate Plan, improve pedestrian and cycle facilities at the junction, and have general support from the local community.

#### ALTERNATIVE OPTIONS CONSIDERED AND REJECTED AT THE MEETING/BY MEMBERS

An alternative layout which could be considered include upgrading the junction to include two stage bicycle turn. This involves cyclists proceeding on a green light with traffic and then waiting in a pocket within the junction to join the green light for the perpendicular traffic. This particular layout has been used in cities such as London, however, it leaves cyclists in a vulnerable position within the junction, while it would require extensive training and guidance within the local community for people to understand how to use them. A CYCLOPS junction such as the one proposed, protects pedestrians and cyclists throughout the junction, and is easier to navigate.

#### TAMWORTH DEVELOPMENT UPDATE

# ALTERNATIVE OPTIONS CONSIDERED AND REJECTED AT THE MEETING/BY MEMBERS

- 1. The option to do nothing would have a serious impact on the level of capital receipts required to support the three year capital programme and will also incur abortive costs that will add pressure to the Council revenue.
- The Council could dispose of the site at open market value, however, this would not ensure the Council's outcomes would be achieved as the Council would not have development control of the site through the LLP nor would it benefit from any development profit.
