I wish to place a formal objection regarding the application by the quarry bank pub, Timperley, for a licence to serve alcohol in all outside areas.
The level of noise we have had to endure has greatly increased since the outbreak of the virus, people are drinking much closer to residential properties and this noise goes on continually until 11.30- 12 at night and on a Friday and Saturday night it is getting on for 1a.m. we have to sleep with all the windows closed and even in the early evening the noise can be heard above our television, it is impossible to sit in the garden and relax because of the noise. I am greatly concerned that a licence to serve outside would increase the noise level and also in the future they could build serving areas anywhere in the grounds once they have the licence. My neighbours are having similar problems with the noise and i think that further investigations by the council should be made to inform all the affected neighbours individually as i am sure not everyone would read a note stuck to the pub door.

We are aware and concerned that social distancing in the outside drinking area is **non-existent** and regularly see the rules being disregarded.
