New Premises Alcohol Licence

A M Mini Mart, 173 Canterbury Road, Urmston, M41 0SE (PL081030)

Please find attached copies of the petition opposing the granting of an alcohol licence to the above premises. (Original sheets are available on request)

Local residents were and are in the main unaware of the above licence application. Due to limited time available from learning of the application I have only had time to approach a small number of residents.

Several residents were unavailable, either out or on holiday, but of those approached **100% are opposed to a second mini mart/off licence** in the small row of shops.

We already have 9 off-licences within a 1-mile radius. This new application seeks to attract customers early morning and late at night when other outlets are closed.

Our grounds for objection are:

#### **Anti-Social Behaviour**

The existing mini mart (Price Cutters) at 163 Canterbury Rd, open 8am to 10pm, already acts as a magnet for groups of youths, several from outside the estate. These individuals congregate outside the row of shops often drinking and smoking drugs. On numerous occasions motorists have had to stop and give way to these groups riding several abreast across the road, taunting and intimidating drivers. We're now also seeing an increase in hoodies on scooters, coming through the motorway subway in the evenings heading for the off-licence and park. A second off-licence with longer opening hours will only serve to exacerbate the problem and unfortunately the police do not have sufficient manpower to patrol our area on a regular basis.

#### **Public Nuisance**

We already have a serious litter problem with broken bottles, cans and cigarette ends immediately outside the shops and also along the surrounding roads. Amey and Trafford do not have the resources to clear the roads/pavements as often as necessary and we rely on neighbourhood volunteers to clean up on a daily basis. A second off-licence open for 17/18 hours a day will bring in additional trade and increase the problem.

The premises is in the middle of the Canterbury Rd estate and surrounded by residential properties. A retail outlet open 6am to 11pm/midnight will cause unacceptable noise disturbance for local

residents. It will attract more individuals from outside the area looking to buy alcohol late at night and early morning.

The Canterbury Road estate was purpose built. The properties are predominantly three- and four-bedroom family homes. Residents are doing their best to maintain the area but we need Trafford Council to help us to do this. We neither want or need a second odd-licence in our row of 8 shops.

We respectfully request the Licence Application is refused.
