1.	Welcome and apologies	Apologies were received from Councillor Acton.	
2.	Minutes	The minutes of the meeting 15 th December 2021 were agreed as an accurate record.	
3.	Membership	There had been no changes to the Membership since the last meeting.	
4.	Update on the current Covid-19 situation in Trafford	 The Board agreed to note the update. The following messages were shared with the Board: The rates across Trafford had significantly increased with rates at 1960 per 100,000; Trafford had the second lowest rates across Greater Manchester with Wigan having the highest rates; The positivity rate was 36%; 0-44 year olds had the highest rates; The rates in over 60s had increased to 1267 per 100,000; 	All

		 6. Timperley, Davyhulme East and West and Flixton wards had the highest rates across Trafford; 7. The Omicron variant had less severe symptoms than previous variants however the Delta variant was still circulating and had more severe symptoms; 8. As of 2nd January there had been 528 Covid-19 related admissions into hospitals across Greater Manchester; 9. People needed to take additional care (even if vaccinated) by avoiding crowded places, meeting people outdoors where possible, wearing a mask, keeping up with hand hygiene, and working from home if able.

5a.	Mass Testing	 The Board agreed to note the update. The following messages were shared with the Board: 1. It is now possible to end self-isolation after 7 days following 2 negative Lateral Flow tests taken on day 6 and day 7, 24 hours apart; 2. From 11th January, people who have a positive Lateral Flow test do not require a confirmatory PCR test and should immediately self-isolate. However, you should still get a PCR if experiencing symptoms; 3. That demand for Lateral Flow tests is still high but they should be available from Stretford, Urmston, Altrincham and Sale Libraries; 4. That it was important to plan ahead and take a Lateral Flow test if: a. Visiting elderly people b. Visiting a crowded place c. Attending work or school 5. To encourage people to get PCR tests when experiencing any symptoms; 6. Testing at home twice weekly with Lateral Flow tests should continue. 	All
5b.	Contact Tracing and Outbreak Management	 The Board agreed to note the update. The following messages were shared with the Board: 1. There had been an increase in cases in schools and workplace settings; 2. To be able to claim the £500 self-isolation support you must have a confirmatory PCR test within the 10 day self-isolation period; 3. The team had followed up a very high number of Level 2 cases over the past week; 	All

5c.	Mass Vaccination	 The Board agreed to note the update. The following messages were shared with the Board: 1. As of the 4th January, 163,000 Trafford residents had had their 1st dose which was 83% of the eligible population; 2. As of the 4th January, 157,000 Trafford residents had had their 2nd dose which was 80% of the eligible population; 3. As of the 4th January, 126,000 Trafford residents had had their booster dose which was 82% of the eligible population; 4. That Trafford was the best performing Local Authority in Greater Manchester for delivering the booster programme; 5. That Trafford had vaccinated over 60% of the 167,000 aim by 31st December. 	All
5d.	Update and escalations from the COVID-19 Community Engagement Group	The Board agreed to note the update. The following messages were shared with the Board: 1. The team had been working on delivering covid safe messaging and using targeted digital ads; 2. That resources were being refreshed and sent out to frontline staff with focus on anti-vax points; 3.
