To prevent public nuisance	Please state your reasons: Complaints from two households were received on 26 and 27 July 2021 about loud music breakout that was verified by a subsequent monitoring visit on 3 September 2021. It was noted during the visit at approx. 9.45 – 10.45pm that loud RnB music was audible by residential premises. This music was confirmed to be emanating
	from the Astoria premises frontage especially through doors that were being kept open. A letter was sent to the Premises Manager on 7 September 2021 advising of complaints and the outcome of the monitoring visit which confirmed the likelihood of a statutory nuisance being caused. The letter also requested that action was taken to abate the nuisance. A second visit to the monitoring location on 17 September 2021 found that music noise breakout had reduced significantly and that doors to the premises were being kept closed.

The current Licence contains the following condition which relates to the control of music noise:

4. Music and associated sources (including DJ's and amplified voices) should generally not be audible inside noise sensitive properties at any time.

It is considered that the above condition would be difficult to verify, either by the Licence holder or council enforcement officers, since access would be required to the inside of noise sensitive properties in order to check on compliance.

I would therefore request that any Licence granted following the review has this condition removed, and replaced with the following, which is considered a more meaningful and enforceable control measure.

Noise from music and associated sources (including DJ's and amplified voices) must not be audible to such an extent that it constitutes a nuisance at any noise sensitive properties.

I would also request that the following additional condition is attached to the Licence to ensure that music noise breakout through openings can be minimised, since this is an issue that has been highlighted during the investigation of complaints:

All external windows and doors must be kept shut at all times when regulated entertainment is being provided. Doors may be opened for normal entrance and egress of people but must be shut immediately thereafter.
