Statement of Pc Karen Packer - Licensing Officer - Trafford District

- 1. I am PC 7116 Karen Packer of the Greater Manchester Police currently stationed at Stretford Police Station, Trafford.
- 2. Greater Manchester Police is a responsible authority, I act under a delegated authority representing Greater Manchester Police and am authorised to make an application under section 51 Licensing Act 2003 for a standard review of the premises licence in relation to Astoria, 32-34 Flixton Road, Urmston, Manchester. M41 5AW in my capacity as licensing Officer.
- 3. I have 24 years' service working on the Trafford district working in various roles during my career one of which was as an operational response officer where I became familiar with the issues caused by licenced premises on the district and the locations where demand was high.
- 4. As a response officer, one area of the district I found myself being directed to in the evenings midweek and the early hours of a weekend was to respond to fighting or large scale disturbances at a licenced premises named Chadwick's, 32-34 Flixton Road, Urmston,
- 5. On 18th March 2018 I was given the role of the licensing officer covering the district of Trafford. My role involves providing guidance and information to interested parties and ensuring compliance by the licence holders. I work with licenced premises to ensure they comply with the four licensing objectives.
- 6. The legislation provides a clear focus on the promotion of four statutory objectives which must be addressed when licensing functions are taking place. Each objective is of equal importance
 - The prevention of crime and disorder
 - Public Safety
 - The prevention of public nuisance
 - The protection of children from harm
- The licensing legislation supports a number of key aims and purposes which are vitally important and should be principle aims for everyone involved in licencing work.

- Protecting the public and local residents from crime, anti-social behaviour and noise nuisance caused by irresponsible licenced premises
- Giving the police and licensing authority the powers they need to effectively manage and police the night-time economy and take action against those premises that are causing problems
- 8. On 22nd March 2019 I received a licensing application licence number PL000238 from the local authority for a transfer of a premises licence at the premises 32-34 Flixton Road, Urmston, from Midland Inns to Shaw Leisure Holdings Ltd with the proprietor being Mr William Shaw (William). The premises was described as a Bar & Restaurant

Licensable activities attached to the licence are as follows:

Live music - indoors - Sunday to Wednesday - 08.00 to 00.00 Thursday to Saturday - 08.00 to 01.00

Recorded music - indoors - Sunday to Wednesday - 08.00 to 00.00 Thursday to Saturday - 08.00 to 01.00

Facilities - Music - Indoors - Sunday to Wednesday - 08.00 to 00.00 Thursday to Saturday - 08.00 to 01.00

Facilities - Dance - Indoors - Sunday to Wednesday - 08.00 to 00.00 Thursday to Saturday - 08.00 to 01.00

Alcohol - On The Premises - Sunday to Wednesday - 08.00 to 00.00 Thursday to Saturday - 08.00 to 01.00

Alcohol - Off The Premises - Sunday to Wednesday - 08.00 to 00.00 Thursday to Saturday - 08.00 to 01.00

Late night refreshments - Sunday to Wednesday - 23.00 to 00.30 Thursday to Saturday - 23.00 to 01.00

Opening Hours - Sunday to Wednesday - 08.00 to 00.30 Thursday to Saturday - 08.00 to 01.30

- 9. I hereby exhibit a copy of the premises licence and emails mentioned above as 'KP1'.
- 10. Due to the known history of the premises on 25th March 2019, I made contact with William the owner of the premises/director of the company to arrange a meeting to

establish how much he knew of the previous premises and the problems it had caused within the area. I also wanted to know how he intended to run the premises and what preventive measures he intended to put into place to prevent the disorder that had been occurring when the premises was Chadwick's. The PLH replied providing his contact number and was looking forward to speaking.

- 11. On 7th June 2019 I received an e-mail from William stating all being well he was looking at being open for mid-July, he was conscious that we had not met up and would hope to do so before he was up and running. He stated he had started talking to security firms but would appreciate a meeting prior to making a decision. William queried if he needed to purchase a drugs box or if this was supplied by GMP. He described the premises as a building site but I was more than welcome to pop in for a chat.
- 12. **On 26**th **June 2019** I attended the premises and met with William. We discussed the history of the premises and the problems it had caused in the past. We discussed the current problems on Flixton Rd and the work I had been doing with licensed premises to reduce crime and disorder and to improve public safety, I explained that I wanted Trafford to be the place to visit with a good reputation for decent licenced premises.
- 13. I discussed the license for Chadwick's (the previous licenced premises); and the current conditions which I felt did not promote the licensing objectives. We talked about minor variations to the license and it was agreed I would email conditions with what I believed to be appropriate to the operation of the premises with consideration of William submitting a minor variation. He was advised that if he did not submit the variation and crime and disorder occurred I would consider taking the licensed premises to a standard review where I would be seeking to have the conditions imposed on the licence by the licensing committee. William asked for my advice in relation to door staff. I advised that I was unable to nominate a door company. It was agreed to use a different door team to those that already worked on Flixton Rd to reduce the possibility of one door team having the monopoly of the area.
- 14. **On 27**th **June 2019** I emailed William referring to the above conversation with an attachment of the conditions. I suggested he voluntarily included the conditions on his licence as a variation to assist with the reduction of crime and disorder within his premises and the immediate vicinity and to assist with public safety.
- 15. **On 5th August 2019** I emailed William asking how he was getting on with the refurbishment and when he was likely to open. I mentioned I had not seen any paperwork and queried if he had submitted anything. He replied stating they were

getting there and for me to attend the premises and have a look as it looked completely different.

- 16. William stated he had just spoken to licensing who were sending him the forms to add on some of the voluntary conditions. He stated those conditions would not be on his licence but he is imposing a discretionally over 21 age limit with a dress code to filter out the rif-raf. William confirmed they were opening on Saturday 10 August 2019 with a door team (Thoreum Security). He confirmed he would be on the premises all week and I was welcome to call in for a chat.
- 17. **On 7th August 2019** I attended at the premises and spoke with William and his bar manager. I informed William I had still not received any paperwork and if he did not change the licence over to a new licensee by the time Saturday came, he would not be able to sell alcohol. William stated he had submitted the paperwork to the local authority the previous day. The local authority confirmed the paperwork had been received on the 4th August with a Designated Premises Supervisor change to Rachel Mylchreest. Rachel is the partner of William.
- 18. Whilst on this visit, again we talked about the history to the premises and suggested measures to prevent crime occurring. We talked about locking the disabled toilets to prevent drug dealing. William confirmed he was having 4 door staff, 2 at the front, 1 at the back and 1 roaming. He was not allowing under 21's years to enter and there was a strict dress code, with a challenge 25. He showed me the drinks list to show they are of an average price stating the price reflected the type of clientele he was trying to attract. He also confirmed the CCTV had been serviced and covered internally and externally together with all hotspots and clarified the back door would not be accessible to the public whilst the premises were in operation. He was to speak to the door company to suggest at least one of them wore a body camera.
- 19. William confirmed he had not submitted a variation with improved conditions, this was not because he was being awkward, he advised he would get round to it.
- 20. Once the premises opened there was an exchanged of emails between the police and William and on each occasion an incident occurred William was contacted to ensure he was aware of the incident to reflect on how it occurred and if anything could be learnt from to prevent it happening again.
- 21. Below are the exchanges of emails and conversations with copies of the email threads exhibited.

21st August 2019

- 22. William called to inform me he wanted to trial a bottomless brunch in the premises and he was just letting me know. I asked if he could send me the details via email of what he was proposing.
- 23. He confirmed he did not have a set date but when he did he will let me know so I could have a look over the wording. William confirmed it would operate between 12-5 on a weekend but tables would be limited to 90 minutes and drinks would be selected. The customer would order with their server who would create a ticket which would be sent to the bar, the bar staff will make the order. The server would collect and deliver to the table. It would not be a free for all with drinks constantly being topped up.
- 24. I hereby exhibit the email thread as 'KP2'.

16th September 2019 - Email from Karen Packer to William

- 25. Saturday night an incident occurred either inside your premises or at the point that a group were leaving. Door staff pushed the customers outside onto the street and closed your front doors leaving the group to fight amongst themselves.
- 26. One of your door staff is seen to walk out from the back of your premises and to the side of Get Chucked, peek at the group who had just left then sneak back round to the rear of your premises.
- 27. You are responsible for your customers and throwing them out onto the street, expecting the police to pick it up is not acceptable.
- 28. Can you please speak to your door team and explain that they take responsibility for what goes on not only inside but also outside if they are your customers.
- 29. I hereby exhibit the email thread as 'KP3'.

21st October 2019 - Email received from William

- 30. We had a minor incident Saturday night whereby a customer was ejected and then engaged in some shoving with one of the door team.
- 31. As I was next to the incident inside the premises I feel that all this could have been avoided were it not for the approach taken by one of the door team.
- 32. As such, we have decided to change the team as I am not completely comfortable

with them. This will come into effect at the start of November.

- 33. Furthermore, we had a visit Friday night from licensing. Myself and Rachel were In Altrincham at the time visiting her family but we did come back immediately however they had already left. I am told everything was fine but I just wanted to make sure that It was simply routine and if there were any issues would we be able to have a conversation about this?
- 34. I replied asking if this was the second door team he had employed since opening the premises or if he had just changed one of that team. I also advised the visit was routine, I had requested the licensing bus complete a visit; no issues had been reported back. I advised they would visit again over the next few weeks with Christmas coming up.
- 35. I hereby exhibit the email thread as 'KP4'.

21st October 2019

- 36. William phoned to tell me about an incident whereby two males had tried to gain entry using a police warrant card, he was asked to reserve the CCTV and I would collect it.
- 37. A follow up visit was made to the premises by me and my Sergeant to view the CCTV to establish if we could identify the two males. We were met by William and a male he introduced as his CCTV technician. William said unfortunately the CCTV hard drive had corrupted during recording and therefore no recording had taken place. He was unable to show me the footage. He assured me this is the first time he had tried to play the CCTV back since opening the premises so was not aware of the fault but his technician was going to replace the hard drive and it would be working by the end of that week.

16th November 2019 - Email received from William

- 38. I have just WhatsApp you the correlating CCTV footage from an incident last night with the local gypsy family They have been making threats that this is their street and they own it. One was refused entry last night for wearing his hi visibility work attire.
- 39. Unfortunately my door supervisor was then set upon by 5-6 of them and taken to hospital with very serious injuries. I have reported this morning and am now waiting for a resolution officer to contact me.
- 40. This is not the first time they have been in and caused trouble. When they return we

will simply call 999. We don't want them in.

- 41. Are you available this week to come and see us as I am worried that this could escalate? We have security but they're not there to just fight. I do believe that this issue now requires police intervention.
- 42. I hereby exhibit the email thread as 'KP5'.
- 43. On 18th November 2019 I followed the above up with a call. William was not happy that police did not patrol Urmston/Flixton on a Saturday night; he felt that they did not get the police support. I explained the incident grading system and that police do not have the resources to sit on Flixton Road. William stated he had been speaking to most of the managers on Flixton Road and they are to write to their MP.

22nd November 2019

44. Police patrols gave passing attention to the premises and made themselves known to the door staff and the licensee

28th November 2019 - Email received from William

- 45. William was thankful the patrols had visited the premises; his licence stated that he only needed two door staff but he always has at least three. This week he had three per night. Christmas eve and New Year's Eve he will be stepping up to either 4 or 5
- 46. William had submitted a temporary event for the Christmas period to close the premises at 3am and believed this would also give him an extra half hour drinking up time.
- 47. I hereby exhibit the email thread as 'KP6'.
- 48. During a phone call to discuss the temporary event I informed William due to the issues the premises were experiencing and the conflict on Flixton Road I would be submitting an objection to the temporary event for the late licence to the local authority. After a discussion it was agreed between William and the police the premises could have an extension till 2am on the dates requested with confirmation a minimum of 3 door staff would be on duty at all times.

Monday 30th December 2019

49. Rachel and William attended at Stretford Police Station on the request of myself to discuss the disorder being caused at Astoria.

- 50. The following day I emailed Rachel and William with the contents of that conversation and again addressed a variation with controlled conditions. William responded stating he will go through this and respond as soon as possible.
- 51. I hereby exhibit the email thread as 'KP7'.

2nd January 2020

52. I phoned William asking him how he felt New year's Eve went. William confirmed it went better. The door staff had been briefed re the clientele. Toilet checks had been done and drugs had been found. They had a radio link between the staff and search wands had been ordered. William had moved the smokers to the rear of the premises to prevent groups forming at the front door. The local taxi company had been contacted and they were to install a button for ease of access, they will form up outside. Water had been issued out by staff and accepted by some. The bar staff had been briefed not to serve drunks. William stated he and Rachel felt more in control

3rd January 2020 - Email from William

- 53. Sorry to keep emailing you but we are constantly thinking of things to improve the area one of which is the implementation of a pub watch along with the other bars.
- 54. Something we would like to raise is the positioning of a police car/van on a night. We are aware you have said you do not have the resources for this but do you know what the associated cost would be for this and then we can raise it with everyone else?
- 55. I responded by informing William the police would not be able to provide an officer paid for privately to patrol an area of licenced premises. The responsibility is for the licenced premises to manage the four licensing objectives of Crime and Disorder, Public Safety, Public Nuisance and Protect Children from harm. I confirmed the purpose of the Security Industry Authority is to assist venues to prevent crime and disorder and to ensure that people who are not welcome do not enter the premises. If the clientele, policies and procedures are followed and licensing conditions enforced it should be the case that crime and disorder is very minimal.
- 56. I hereby exhibit the email thread as exhibit 'KP8'.

12th January 2020 - Email received from police officers

57. Officers stated they had been unable to obtain the footage from the incidents in December. After several negative attempts officers attended at the premises and

spoke with William who stated he had been having problems with the CCTV and the recorder was defective leaving him unable to download, view or save the footage. The engineer will arrange a new hard drive. The officer advised William we will arrange for the police technical unit to attend and retrieve the footage. William responded "Hopefully it's not been replaced then"

- 58. The officer formed the opinion William did not wish to provide the footage as he didn't want to be involved in an argument between the travellers and the door company. The officer stated it was his bet by the time the police had obtained the recorder; it would either have been wiped or replaced.
- 59. I hereby exhibit the email thread as exhibit 'KP9'.

15th January 2020 - Email from Karen Packer to William and Rachel

60. I have received information from officers regarding the CCTV issues which related to the assault at your premises. We discussed your CCTV before Christmas regarding two males who reported to be officers trying to gain entry. Your CCTV was not working then and you assured me it would be repaired or replaced. The police now have to arrange for GMP technical engineers to attend to make attempts to recover the footage. We have discussed your licensing conditions prior to and since opening without any changes being made.

I advised I would be submitting a review of the premises Astoria to the local authority for consideration of a committee hearing.

61. I hereby exhibit the email thread as exhibit 'KP10'.

21st January 2020

62. Greater Manchester Police Technical services attended the premises to try and obtain the footage relating to the Christmas assaults. The Technician reported the DVR has an overwrite period of 14 days. The earliest footage stored was 8th January meaning the footage for the Christmas assaults had been lost.

11th July 2020

- 63. I was on duty working a licensing operation with Sergeant Young. The purpose of the operation was to visit licenced premises across the district to ensure Covid compliance and to discuss any issues they may have.
- 64. At approximately 22.30 hours we attended at Astoria where we spoke to William. On arrival we noted the queuing system outside with approximately 15/20 customers on the footpath. Inside William was serving behind the bar. Whilst

speaking to William I asked if those outside were likely to be allowed entry to which he said no they were full. I asked him to speak to his door staff and remove those queuing and send them away which he did. I also suggested closing the doors and only allowing those inside to remain, and refuse entry to others. William said he would do that. Whilst we were leaving the door staff appeared to be having issues with a group of males outside. William stated the males are there every week and cause him problems. I asked over the police radio for uniformed police patrols to attend the location should they be required.

- 65. The following day around lunchtime again I along with Sergeant Young attended Astoria where we spoke to William. We discussed how other premises were operating and how they were managing financially. We talked about how premises since Covid had noticed a financial increase during the day rather than opening late at night. We got talking about my own daughter who is 18 years and had just started visiting bars; He asked if I would allow my daughter to drink in his premises to which I replied No. I asked him if he had a child would he be comfortable allowing them to drink in his premises, he also said no. We talked about the disorder in the premises which was being run as a nightclub at weekends. Will stated his intentions were not to operate as a night club, he wanted it to be more of a restaurant/bar. We left William with various options/suggestions as to how he could look at improving his venue.
- 66. I hereby exhibit the statement of Sergeant Young as exhibit 'KP11'.

24th July 2020 - Email from Karen Packer to Rachel and William

- 67. As you will be aware since the opening of licenced premise post Covid, your premises continues to place a high demand on the emergency services with reports of fights occurring outside your premises.
- 68. The licensing objectives of Crime & Disorder and Public Safety are not being met.
- 69. We recently discussed possible options of how to reduce disorder but there does not appear to be any reduction in the incidents occurring.
- 70. Having tried to work with you since the opening of the premises, the police are now in a position where we have no option than to collate the evidence to submit to the local authority for consideration of a review hearing.
- 71. Please give me a call to discuss further when you are free.

72. I hereby exhibit the email thread as 'KP12'

24th July 2020 - Response from William

- 73. Apologies for the late reply. We were closed today whilst we undertook a deep clean and had contractors in sanitising the whole venue. I am free during the day tomorrow if that suits you?
- 74. I note that you reference trying to work with us since the opening of the premises. I would like it to be known that we have always been amenable and approachable in the sharing of information, expertise and advise when it comes to carrying out the licensing objectives. This being evidenced in the fact that since the reopening of the premises we have cut short our trading hours on a Friday and Saturday night, something that you and your inspector (?) thanked me for. Coupled with the shorter trading hours, upon your advice we did not permit any entry after 22:45 in order to alleviate a queue forming and people milling about on the street. This was explained to sergeant Hunt last week when he came to speak to us about two males who had caused a scene outside, both of which were not patrons of ours and had not and did not gain entry to our premises before or after their altercation. I believe one of these males was also on top of a vehicle but the officers present did not feel this warranted an arrest.
- 75. The real issue that I see is the large gatherings of people who for some reason enjoy standing around on the street generally making the place look unsightly. With this in mind myself and Rachel will be sitting down with our door team and drawing up a more robust dispersal policy which we will be shared with yourselves. If you have anything you may want to add to this then please send over and we will see what we can do.
- 76. As I said in our very first conversation, we will always be approachable to speak to and would much rather work with the police and licensing in respect of the objectives than against them. I appreciate that dispersal needs tightening up and this is now our main priority. However, not everyone on that street and seen on camera are customers of ours. There is a lot of anti-social behaviour that goes on up and down Flixton Road and just because we happen to be the last one open does not make it, always, our fault.
- 77. I hereby exhibit the email thread as exhibit 'KP13'.
- 78. In August 2020 I was unfortunate enough to catch the Coronavirus disease and was forced to work from home with limited operational equipment. During this time I was restricted from certain duties which caused difficulties from proceeding with the review of Astoria. I was deemed fit for operational duties in April 2021 but

remained working from home until very recently.

- 79. On 15th September 2021 I attended at Astoria and spoke to William Shaw, I asked to see the signing in book relating to the door staff. William showed me a book that should contain all door staff details. Recorded was only 4 numbers for each individual which William confirmed were part of the SIA badge numbers. I was unable to identify any door staff by the details recorded. William stated a member of staff from the Security Industry had called into the premises weeks prior to and requested that the full details of the door staff were recorded, William believed this was being complied with and could not explain why it was not.
- 80. **On 26th October 2021** I made contact with William over the phoned and advised him that I was now in a position to proceed with a review as it was evident that disorder was continuing. I advised him what my review would contain and described the issues that I felt needed addressing.
- 81. I advised William of the intelligence that GMP held on their system regarding the door staff, I also mentioned that police had received information that the DPS Rachel Mylchreest was no longer acting in that capacity for the premises. William confirmed she was and he would get Rachel to contact me. The following day I received a call from a female who confirmed she was Rachel Mylchreest. Rachel confirmed she remains the DPS at the premises but admitted she has a day job and is not normally on the premises at weekends. Rachel stated a female living on the premises of Astoria was completing her personal licence course and in time she would be taking over as the DPS, William further confirmed this.

- 82. I have provided a list of incidents recorded against Astoria that mainly relate to incidents of violence. Each incident has been thoroughly scrutinised to identify the link between the incident and the premises or directly outside and in the vicinity. Those directly outside have been witnessed by Trafford council CCTV that persons responsible have come from the entrance to the premises. I have provided a copy of those logs which have been edited to remove personal or sensitive information.
- 83. I hereby exhibit the incident log as exhibit 'KP14'.
- 84. I also made notes after a number of the visits and hereby exhibit the notes as 'KP15'.

CCTV

85. Over the past two months I have attended several times at Trafford Council CCTV Control room to view footage stored on their system relating to incidents outside Astoria. I have produced 5 recent incidents from Saturday 24th July to Saturday 13th November 2021 to show the scale of the disorder outside the premises. It should be noted the times of these incidents occur after Midnight on each occasion. I have provided footage of an incident dated 26th December 2019 which related to an incident at the rear of the premises where police attended. This does not show the incident but provides an overview to show the committee how the premises operates as a nightclub and continues to do so. These incidents have been compiled on a disc which will be produced to the committee for viewing and will be served on the premises.

Intelligence Recorded Against Astoria

- 86. **October 2021** The licensee of Astoria Bar is being bullied and coerced in his role as a licensee. He has no control over his bar and people that run it on his behalf have complete control.
- 87. There are known drug dealers frequenting the establishment as well as known offenders who have been barred from most other places
- 88. **July 2021** A security company named Securitite is run by local brothers. They provide security for the doors at Astoria which are licenced premises in Urmston. Fights occur every weekend inside Astoria but go unreported due to threats being made by the brothers. The brothers are dealing drugs from Astoria.

89. **June 2021** - There are drugs being openly used and dealt in The Chadwick Bar (Astoria), Flixton Rd. This is taking place in the main bar and toilets. Local drug dealers are being allowed to sell drugs in the bar by the bouncers especially a bouncer who runs the "door" and allows certain individuals to sell illegal substances.

Conclusion

- 90. It is evident this premises operates as a bar with a restaurant function on weekdays but on Friday, Saturday and Sunday the premises operates as a night club. It is on these days that incidents of crime and disorder occur.
- 91. From the evidence provided it is clear the door staff have not performed to a level which is expected. They have failed to monitor customers entering and leaving and there does not appear to be any structure as to who is allowed entry. Door staff have failed to act when incidents have occurred outside. They have failed to present themselves at egress stage to monitor the exit procedures.
- 92. On 16th November 2019 William raised concerns that the were making threats and wanted to control the street, he stated they were responsible for the assault on his door staff. Only recently intelligence suggests the premises have been taken over by a group who are controlling the doors.
- 93. <u>Incident 4</u> Relates to Fighting ongoing. One male hitting other people, male still outside Astoria. One male who was being beaten has got into a car saying they were coming back. Informant says the male who was hitting everyone is a male called who runs the doors at Astoria.
- 94. Door staff are permitted to use reasonable force to eject individuals from a premises to control a situation. The CCTV footage does not show who is wearing a white top wearing anything that would identify him as door security. From CCTV to be seen assaulting members of the public.
- 95. In relation to the way the premises operated on New Year's Eve in 2019 William and Rachel confirmed by having regular toilet checks drugs were found, a radio link between door staff with search wands ordered, smokers moved away from the entrance, water had been issued and a full briefing of expectations with staff that the premises appeared to run smoothly with William and Rachel feeling like they had more control.

- 96. The premises have been approached and asked on several occasions to submit a variation to amend the conditions of the licence to comply with the licensing objectives which they have failed to do.
- 97. The role of a designated premises supervisor (DPS) is the person who has day to day responsibility of running the premises; they should also act as the primary contact for local government and the police. Rachel Mylchreest the DPS, has confirmed she holds down a full time job and is not on the premises particularly at weekends and when the disorder is taking place. The exhibited emails shared between myself and the premises suggest it is the premises owner/director who appears to be running the premises. Officers have confirmed when attending incidents of disorder neither the DPS nor the premises owner/director have been on site.
- 98. Greater Manchester Police would therefore request consideration is given by the committee to review the premises licence at Astoria 32-34 Flixton Road, and to consider implementing the following conditions on the licence, and in the meantime suspend the licence until confirmation is received that the conditions have been complied with to prevent further incidents of crime and serious disorder.

General Conditions

- Removal of the current door team "Securitite" to be replaced with a door security company who are members of the 'Approved Contractor Status Scheme 'ACS managed by the Security Industry Authority (SIA).
- Notify the police and relevant authorities of the details of the ACS approved contractor Status Company when appointed and any changes made in the future.
- No less than 6 door staff in operation on the premises each Friday,
 Saturday and Sunday and any day prior to a bank holiday, Christmas Eve,
 Boxing Day and New Year's Eve until 30 minutes after the terminal hour.
- Removal of the current Designated Premises Supervisor.
- A dress code to include no hoodies or caps to be worn inside the premises.
- The rear door leading to a delivery yard to be a fire exit only and not to be used for any other purpose.
- There to be no furniture or table and chairs to the front external area.

- No alcohol or refreshments can be consumed in any external area. For the purposes of off sales, alcoholic drinks and refreshments must be in a sealed container and consumed away from the premises.
- Polycarbonate vessels and plastic bottles only to be used on a Friday,
 Saturday and Sunday and any day prior to a bank holiday, Christmas Eve,
 Boxing Day and New Year's Eve and to be risk assessed at all other times
- No vertical drinking will be permitted. Customers must be seated to consume alcohol
- A personal licence holder will be on duty on the premises at all times from 18.00 hours on Friday, Saturday and Sunday and any day prior to a bank holiday, Christmas Eve, Boxing Day and New Year's Eve until 30 minutes after the terminal hour.
- A direct telephone number for the manager of the premises shall be available at all times to the public whilst the premises are in operation.
- The premises licence holder shall ensure that staff at the premises are trained in respect of licensing legislation, responsible retailing, refusal of service and challenge 25 as befits their particular roles.
- The premises licence holder shall maintain s dispersal policy dealing with matters pertaining to dispersal of customers from the premises. Door staff shall ensure customers do not congregate outside the premises whilst the premises are in operation. A copy of the policy shall be kept at the premises and produced for inspection at the request of police or authorised officers

Licensable Activity

- Licensable activities to cease at Midnight
- The premises to close at 00.30 hours
- There shall be no admittance or re-admittance to the premises after 22.45 hours.
- The premises to operate a strict no under 21's policy on a Friday,

Saturday and Sunday and any day prior to a bank holiday, Christmas Eve, Boxing Day and New Year's Eve and there shall be no under 21's on the premises from 21.00 hours until close of business except where licensable activities cease at 23.00 hours.

 A challenge 25 proof of age scheme shall be operated at the premises where only acceptable forms of identification are recognised photographic identification cars, such as a driving licence, passport or proof of age card with the PASS Hologram

Search Policy

 A search policy shall be in place and will include procedures for the confiscation of prohibited articles such as drugs and weapons. Searches will be conducted at the discretion of SIA registered door staff. Search policy to include random searching.

CCTV:

- The premises shall maintain a comprehensive CCTV system on the licensed premises.
- CCTV cameras cover internal and external areas of the Premises and all areas where customers have legitimate access (Excluding Toilets).
- One CCTV camera is specifically positioned to capture facial images of any persons entering the Premises at the main entrance and all other entrances where searches may be undertaken, the searches of patrons will be captured on the CCTV camera.
- All areas are sufficiently illuminated for the purposes of the recording of CCTV images.
- All CCTV recorded images have sufficient clarity/quality/definition to enable facial recognition to an evidential standard.
- CCTV images are retained in an unedited format for a period of 31 consecutive days.
- Any person left in charge of the Premises is trained in the use of any such CCTV equipment and is able to produce/download/burn CCTV images to an evidential standard.
- CCTV is maintained on a regular basis and kept in good working order at all times and images shall be produced to the Police or Authorised Licensing Officers (Trafford Council Licensing Service) immediately upon request.
- CCTV checked daily and a written record to be kept of such checks. If found not to be in good working order to notify the police and the Licensing Authority, and rectify the fault within 3 days.

- The CCTV system records images at all times that any member of the
 public is at or on the Premises. For the purpose of this condition a
 "member of the public" is defined as is any person other than the DPS,
 Premises Licence Holder, Spouse, Partner or Employee thereof.
- A TV monitor to be placed at the entrance relaying live images of all persons entering the Premises to the patrons.

Notices:

- Posters, no smaller than A4 size, are clearly and prominently displayed at the entrance and exit of the Premises stating that CCTV is in operation and that images are being captured for the purposes of crime prevention and public safety.
- Posters no smaller than A4 size clearly and prominently displayed stating that bag searches are undertaken.
- Posters no smaller than A4 size, clearly and prominently displayed stating Premises operate a zero tolerance policy to drugs

Drugs:

- If any individual is found to be in possession of a small amount of drugs for personal use following a search, the SIA registered supervisor conducting the search will advise the individual that the drugs in question will not be returned to them and that the drugs will be handed to the police for destruction.
- The drugs seizure will be captured on the CCTV, in accordance with the CCTV condition herein.
- Following this the date, time and name of the person who seized the
 drugs, together with the suspected type of drug, will be recorded in
 a 'Drugs Book' to be kept on the Premises and then secured within a
 safe on the Premises.
- Police Officers will attend on an agreed weekly or fortnightly basis to collect any drugs from the safe for destruction, and the Officers will sign the 'Drugs Book' to confirm the drugs have been removed from the Premises and handed to the Police.

Door Supervisors

- A minimum of 6 SIA licensed door supervisors shall be on duty from 19.00 hours at the premises on Friday, Saturday and Sunday and on any day prior to a bank holiday, Christmas Eve, Boxing Day, and New Year's Eve.
- At least 50% of the licensed door supervisors on duty at any time shall wear body worn cameras which must be in operation at all times.
- The premises licence holder shall risk assess the need for and the numbers of SIA licensed door supervisors required on any other night or at any other time.
- SIA licensed door supervisors to be in radio communication at all times with the premises management staff.
- Prior to any "designated sporting event" the premises licence holder shall ensure that a written risk assessment is undertaken assessing the need for and the numbers of SIA licensed door supervisors needed on the day of the event.
- At least 2 SIA licensed door supervisors shall be on duty at all times at the front of the premises from 19.00 hours with an additional 2 licenced door supervisors from 21.00 until 30 minutes after the last customer has left the premises.
- Search and ID checks to be conducted within view of the CCTV camera which will be positioned at the entrance when door supervisors are on duty.
- On departure two members of the door team to be responsible for departure of internal elements of the Premises and will undertake the departure in a controlled manner.
- The door supervisors to all be in radio communication with one another
- The door supervisors will encourage patrons to leave the area and encourage the use of taxi's and walking home to avoid groups congregating.
- The Premises Licence Holder shall ensure that a record of all SIA Door

Supervisors employed at the premises is kept and which includes the following details:

- a. Full name and date of birth
- b. 16 digit SIA badge number
- c. Dates and times employed
- This record, which may be electronic, shall be made available to the Police Licensing Team or Authorised Officers on request.
- The premises will operate a search policy, including the use of search wands, from 21:00 on a Friday, Saturday and Sunday and any day prior to a bank holiday, Christmas Eve, Boxing Day and New Year's Eve, and/or at such times when SIA licensed door supervisors are on duty (except where licensable activities cease at 23.00 hours) which will be operated by SIA licensed door supervisors and monitored by the premises CCTV system.
- All staff engaged outside the entrance to the premises, or supervising or controlling queues, shall wear high visibility yellow jackets or vests
- An incident log shall be kept at the premises, and made available on request to an authorised officer of the Council or the Police. It must be completed within 24 hours of the incident and will record the following:
- all crimes reported to the venue
- all ejections of patrons
- any complaints received concerning crime and disorder
- any incidents of disorder
- all seizures of drugs or offensive weapons
- any faults in the CCTV system, searching equipment or scanning equipment
- any visit by a relevant authority or emergency service
- In the event that a serious assault is committed on the premises or in the immediate vicinity of the premises (or appears to have been so committed) the management will immediately ensure that:
- The police (and, where appropriate, the Ambulance Service) are called without delay;
- All measures that are reasonably practicable are taken to apprehend any suspects pending the arrival of the police;
- The crime scene is preserved so as to enable a full forensic investigation to be carried out by the police; and
- Such other measures are taken (as appropriate) to fully protect the

safety of all persons present on the premises

 The Premises Licence Holder/DPS shall invite the Police Licensing Team to meet once every quarter to discuss any issues (if any) pertaining to operation of the premises.

Public Safety

- The approved arrangements at the premises, including means of escape provisions, emergency warning equipment, the electrical installation and mechanical equipment, shall at all material times be maintained in good condition and full working order.
- The Premises Licence Holder shall operate a strict "no drugs" policy at the premises with notices advising customers of the policy clearly displayed at the entrance to the Premises.
- The premises holder shall have in place a clear and detailed dispersal
 policy for the premises which all door supervisors and staff will be
 trained so that they are aware and undertake the process whenever the
 premises are open to the public.

The Protection Of Children From Harm

- A Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram
- A record shall be kept detailing all refused sales of alcohol. The record should include the date and time of the refused sale and the name of the member of staff who refused the sale. The record shall be available for inspection at the premises by the police or an authorised officer of the Council at all times whilst the premises are open.
- Any child under the age of 18 years must be accompanied by an adult/parent, with no child under the age of 16 allowed at the premises beyond 20.00 hours

 - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

ADDITIONAL MANDATORY CONDITIONS (1st October 2014)

- 8. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purposes of encouraging the sale or supply of alcohol for consumption on the premises:

- 3. Prominent, clear and legible notices shall be displayed at all exits requesting the public respect the needs of local residents and leave the premises and area quietly.
- 4. Music and associated sources (including DJ's and amplified voices) should generally not be audible inside noise sensitive properties at any time.

Referring to our conversation yesterday I have attached a list of conditions we would impose if we were taking your premises for a review.

Have a look at them and see what you are prepared to add as voluntary conditions to be followed up by you for a minor variation. You can do this when you submit your change of premises name / Licence holder details. If you have other conditions of your own, no problems adding them on.

One other thing I forgot to mention if it applies. If you have a disabled toilet, can it have a lock on it with a note that the key is behind the bar. This prevents groups going into the toilet to deal.

GENERAL

- All bar and front of house staff to wear recognizable premises related clothing (uniform) when licensable activities are conducted
- On Fridays and Saturdays there shall be no admission or re-admission to the premises in the last hour of trade;
- An incident book, or record, will be kept and maintained at the premises. Each entry made shall carry the day, date and time that each report was made and pages shall carry consequential numbering.
- The incident book to be retained at the premises and made available to the officer upon request.
- Name and contact details (mobile phone) of SIA registered door staff or manager making entries to be included;
- The incident book shall record the following: Details of any crime and disorder, ejections, violence, drug or weapon seizures to feature.
- Refusal log to be retained at the premises and records to be made available to officers upon requests.
- An age challenge scheme for use when alcohol sales are involved (Challenge 25) shall be in use at all times licensable activities are undertaken. The only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram
- Toilet checks, after 8pm, on Fridays and Saturdays, will be conducted no less than once per hour, at irregular intervals, to deter patrons from illegal activity.
- A register of toilet checks will be kept at the premises throughout the trading period;
- No open drinks or containers are permitted to be brought outside the premises. (For off sales, sealed container are still permitted – If you have off sales);
- Clear notices to be display asking customers to respect the neighbours/ advising customers on good conduct and behaviour expectations.
- The premises licence holder shall ensure that staff at the premises are trained in respect of licensing legislation, responsible retailing, refusal of service and challenge 25 as befits their particular roles at the premises.
- All bar and front of house staff to wear recognisable premises related clothing (Uniform) when licensable activities are taking place.

SECURITY

- A minimum of 2 SIA licensed door supervisors shall be employed from 8pm on Friday and Saturday nights, on Sundays before bank holidays, on Christmas Eve, Boxing Day, and New Year's Eve and risk assess the need for the numbers of Sia licenced door supervisors at all other times:
- At least one of the licensed door supervisors on duty at any time shall wear body worn cameras which will be maintained in good working order
- SIA registered door staff to be linked via radio (link to also include management);
- All staff engaged outside the entrance to the premises, or supervising or controlling queues, shall wear high visibility yellow jackets or vests.

- The Premises Licence Holder shall ensure that a record of all SIA Door Supervisors employed at the premises is kept and which includes the following details:
- a. Full name and date of birth
- b. 16 digit SIA badge number
- c. Dates and times employed
- This record, which may be electronic, shall be made available to the Manchester Police Licensing Team or Authorised Officers on request.
- The premises will operate a search policy, including the use of search wands when SIA licensed door supervisors are on duty.

SEARCHES

- A search policy shall be in place and will include procedures for the confiscation of prohibited articles such as drugs and weapons. Searches will be conducted at the discretion of SIA registered door staff. Search policy to include random searching, weapon detection, drug awareness etc
- Search and ID checks to be conducted within view of the CCTV camera which will be positioned at the entrance when door supervisors are on duty.
- Suitable notices explaining protocols and procedures (to include the searches throughout etc.)
- Posters no smaller than A4 size clearly and prominently displayed stating that bag searches are undertaken.

CCTV

- The premises shall maintain a comprehensive CCTV system on the licensed premises.
- CCTV cameras cover internal and external areas of the premises and all areas where customers have legitimate access (Excluding Toilets).
- One CCTV camera is specifically positioned to capture facial images of any persons entering the premises at the main entrance and all other entrances where searches may be undertaken, the searches of patrons will be captured on the CCTV camera.
- All areas are sufficiently illuminated for the purposes of the recording of CCTV images.
- All CCTV recorded images have sufficient clarity/quality/definition to enable facial recognition to an evidential standard.
- CCTV images are retained in an unedited format for a period of 31 consecutive days.
- Any person left in charge of the premises is trained in the use of any such CCTV equipment and is able to produce/download/burn CCTV images to an evidential standard.
- CCTV is maintained on a regular basis and kept in good working order at all times and images shall be produced to the Police or Authorised Licensing Officers (Trafford Council Licensing Service) immediately upon request.
- The CCTV system records images at all times that any member of the public is at or on the premises. For the purpose of this condition a "member of the public" is defined as is any person other than the DPS, Premises Licence Holder, Spouse, Partner or Employee thereof.

Posters, no smaller than A4 size, are clearly and prominently displayed at the
entrance and exit of the Premises stating that CCTV is in operation and that images
are being captured for the purposes of crime prevention and public safety

DRUGS

The premise shall operate a strict "No Drugs Policy" including a Drug Safe scheme. The Drug Safe procedure will involve a dedicated log of illegal substances placed in the safe by staff. It will record details of where the substance was discovered (or from whom it was recovered) date and time as well as details of the person seizing the substance(s). If the person making the entry in the log is different to the person seizing the substance(s) their details shall also be included in the log entry.

Posters no smaller than A4 size, clearly and prominently displayed stating Premises operate a zero tolerance policy to drugs

DISPERSAL POLICY

A dispersal policy shall be in place. Such policy to include evictions and confirmation of no re-entry following ejection, non-congregation outside front of premises which all door supervisors and staff will be trained so that they are aware and undertake the process whenever the premises are open to the public.

I refer to our meeting at Stretford police station dated 30th December 2019 at 12.30 hrs and would just like to confirm the details of that meeting. I went through the incidents the police have recorded against your premises Astoria, Flixton Road. I talked about how the demand on the emergency services and the number of victims and level of assaults coming from your premises is at an unacceptable level and needs immediate improvements, we also discussed the following;

- Crime and Disorder is of an unacceptable level
- Police are unable to prosecute without the support of the victims including the staff you employ
- As the licensee you should be reporting incidents of crime or encourage your staff to do the same
- All staff should be debriefed prior to commencing their duties so they know what is expected of you as the licensee.
- Reports of you allowing those who have previously caused a disturbance to re-enter and cause a further disturbance
- Domestic issues having an impact on you as a Licensee
- Facebook posts criticising the behaviour of the staff towards the customers.
- A dispersal policy How do you filter out rather than request everyone to leave at the same time
- Controlling those who hang around outside to cause trouble moving them on
- Serving alcohol to those that are already highly intoxicated. It is an offence to serve someone who is drunk.
- Pot collectors being your eyes and ears. Brief them to look and listen and share with you their findings. They are your good source of intelligence
- As a licensee you should be present in the premises at least until the issues are resolved. Stand back and
 watch what is happening then act upon it. You can't see what's going on in your premises if your serving
 behind the bar.
- New Year You confirmed you would have 8 door staff on duty
- Wrists bands would be sold at the door to control numbers entering
- A dress code would be implemented.
- Door staff would be briefed.
- A dispersal policy would be implemented to control customers leaving
- Those that appear to be intoxicated would be offered water and refused alcohol.
- Those that had previously been removed for causing disorder would not be allowed to enter.
- Contacting the police should you experience disorder at the premises.

I also note the press release in the Manchester Evening news from your door staff who have been assaulted. The release states "the door staff recognised the offenders known previously for causing trouble in the area, they always come in a big group and think they own the bar and do whatever they want "that's how it works". The manager intervened and let the men enter in an attempt to calm the situation".

We discussed this during our meeting. It was confirmed those responsible for the disorder over the Christmas period are those who were responsible for the disorder back in November. As a licensee you have a right to refuse anyone

entry. Part of the licensing objectives are prevention of crime and disorder and public safety. Allowing those who continually cause disorder to frequent your premises is not addressing the licensing objectives.

I have spoken to the officers who are dealing with an assault on one of your door staff.

The officer has informed me you are unable to provide the details of the door staff who was assaulted in November as you do not keep a log of their details.

I find this hard to believe. Surely you record all staff that are on duty on each occasion they work, in particular door staff, do you not record the details of each individual member on each occasion they work?, how do you confirm they are registered Sia if they are not being checked?, how do you know who you are paying?. When it comes to identifying your staff for the purposes of an investigation how do you do that? You should know your staff or at least know their full details.

Every member of staff who works should be signed in with their full details recorded. Is this not being done.

On 27th June 2019 I sent you a list of conditions for you to consider attaching to your licence and which is good practice for a successfully run business. On this list it referred to recording details of door staff and also included a dispersal policy which we again talked about yesterday. You chose not to implement any of these conditions and did not submit a variation to improve conditions.

I have attached these conditions again for your attention and consideration of issuing a minor variation and implementing these conditions to improve the licensing objectives of Crime and Disorder, Public Nuisance and Public Safety with immediate effect.

Part of my review process should this be the next step, will be addressing all the above.

Hi Karen

Just to give you a bit of an update. Geoff has tried several times to get the footage for my job and an incident he's picked up earlier in December but hasn't had any luck speaking to Will (owner) to get the footage, In fairness Will does call or email back.

I attended the bar this afternoon approx. 14:00, the bar was shut but I managed to get the attention of staff and was let in and I spoke with Will. He again wanted to clarify why the offender wasn't arrested on the night. I explained my rationale which he accepted – I also reminded Will that on the night Will suggested he dropped the offender off home rather than me taking him away from the area, Will was shaking hands with offender and telling him they'd catch up in the week (offender considers himself a regular and friendly with Will) so Will was quite happy on the night and even wanted to drive the offender away himself to smooth things over. Will said he couldn't remember the night that clearly as he was really busy but my BWV was on and I remember it crystal clear.

Whilst trying to get the footage Will told me that he had been having problems with the recorder and showed me an email between him and his engineer who stated the recorder is defective and he isn't able to download, view or save any footage on the system and the engineer will arrange a new hard drive for the recorder asap. I asked Will if the hard drive had been replaced and he said it hadn't at first so I informed him that our tech people may be able to recover the lost data on the hard drive and I will arrange for them to come out. As I was leaving Will said "hopefully it's not been replaced then" when talking about the recorder.

I just wanted to let you know as initially he implied that his CCTV isn't currently recording, he sounded quite helpful but the cynic in me thinks he might be telling porkies as he doesn't want to get involved in any arguments between the travellers or the door firm. If I was a gambling man I'd bet by the time we get the recorder it will have been replaced/wiped but I didn't want to seize it then and there as if the recorder has being replaced and I took it I'd be confiscating their recorder which in theory means they can't open or them would be in breach of their licence?.

Unfortunately my BWV wasn't on for this conversation so it's just my word for it.

I've completed a VFE asking for someone from digital imaging unit to attend asap to recover the footage.

I am Police Sergeant 12990 YOUNG of Greater Manchester Police currently based at Altrincham Police Station.

On the weekend of the $4^{th} - 5^{th}$ July 2020, I was on-duty working part of Operation Kingfisher, with Trafford's licensing officer PC Packer. Op Kingfisher was the Forcewide initiative to support the reopening of licenced premises, following a significant period of closure (COVID19). The purpose of the operation was to support local licensees to reopen their businesses and ensure that public safety was maintained.

Over that weekend PC Packer and I attended a number of licenced premises across the District, offering our support and guidance to the licensees/landlords and their staff. Our intention was to assist their operations on what was a challenging weekend for that business sector; specifically with the numerous COVID19 guidelines, which they were ask to comply with.

At approximately 22.30hrs on Saturday 4th July PC Packer and I attended Astoria in Urmston to speak with the landlord, a male I now know to be called Will. On arrival at the premises on Flixton Road, Urmston I noticed that there were a number of people (approximately 15) queuing on the pavement outside the premises waiting to get in. There were door staff employed by the business and two were permanently situated at the entrance monitoring access/egress.

PC Packer and I entered the premises to speak with Will, whom I noticed was working behind the bar in the first instance. Whilst PC Packer spoke with the licensee, I was approached by one of the door staff who was explaining to me that they were preventing further access due to the fact they had reached capacity (under COVID guidelines) inside.

As we were leaving the premises, approximately 10 min later, I noticed a group of males approach the door staff at the entrance and both Will and the gentleman I was speaking with went over to the entrance to engage with these males and support the other door staff, who looked flustered. At that time we were approximately 4-5 meters from the door and had a clear line of site. I would say these males looked agitated after it appeared that they were refused entry. Having spoken with the males Will returned inside the premises and spoke with PC Packer and myself. He explained that the males he engaged with cause problems at the premises every week and it is a recurring issue. At this point PC Packer and I left the building and asked for a uniformed presence outside the Astoria to monitor this group of males and support the door staff if required.

At approximately 1700hrs on Sunday 5th July PC Packer and I returned to Astoria to follow up with the Licensee (Will) and see if we could offer any further assistance or guidance, following the issues the previous night. Will was sat in the premises with a friend when we spoke with him. He stated that it had been a challenge over the last couple of months during lockdown and that he was glad to be up and running and making some money. He was also talking about trying

to attract a different clientele, who would cause him less problems and spend more money inside the premises. When asked about the group of males the previous night, he stated that they were a constant problem who created issues for both staff and customers both inside and outside of the premises. At this point PC Packer asked him would he allow his children to drink inside the premises, to which he replied "No".

Following the conversation PC Packer and I left the premises and I took no further part in part in proceedings.

Good Evening Karen

Apologies for the late reply. We were closed today whilst we undertook a deep clean and had contractors in sanitising the whole venue.

I am free during the day tomorrow during the day if that suits you?

I note that you reference trying to work with us since the opening of the premises. I would like it to be known that we have always been amenable and approachable in the sharing of information, expertise and advise when it comes to carrying out the licensing objectives. This being evidenced in the fact that since the reopening of the premises we have cut short our trading hours on a Friday and Saturday night, something that you and your inspector (?) thanked me for. Coupled with the shorter trading hours, upon your advise we did not permit any entry after 22:45 in order to alleviate a queue forming and people milling about on the street. This was explained to sergeant Hunt last week when he came to speak to us about two males who had caused a scene outside, both of which were not patrons of ours and had not and did not gain entry to our premises before or after their altercation. I believe one of these males was also on top of a vehicle but the officers present did not feel this warranted an arrest.

The real issue that I see is the large gatherings of people who for some reason enjoy standing around on the street generally making the place look unsightly. With this in mind myself and Rachel will be sitting down with our door team and drawing up a more robust dispersal policy which will be shared with yourselves. If you have anything you may want to add to this then please send over and we will see what we can do.

As I said in our very first conversation, we will always be approachable to speak to and would much rather work with the police and licensing in respect of the objectives than against them. I appreciate that dispersal needs tightening up and this is now our main priority. However, not everyone on that street and seen on camera are customers of ours. There is a lot of anti-social behaviour that goes on up and down Flixton Road and just because we happen to be the last one open does not make it, always, our fault.

The informant, CCTV operator for Trafford local authority has captured a large mixed group of approximately 20-30 male and females outside the Astoria Nightclub, Flixton Road, Urmston.

Whilst viewing the camera, the group have begun fighting amongst themselves which has spilled into the road. Persons in the group have been seen throwing punches and kicks. The informant has then reported the disturbance over the airwaves when officers have attended the location. The group had dispersed on foot in several directions prior to officer's arrival, a few individuals on the street were spoken to but were not forth coming with any information. No persons made themselves known to officers at scene and no weapons seen on the footage captured.

10. Saturday 18th July 2020 @ 00.17 - Incident 0662691/20

Email received from the attending police Sergeant.

As part of the ongoing Operation 'Shandy', myself and my patrols attended Flixton Road for hi-vi patrolling. As we drove on to the road, an altercation was already taking place near to the pub. Champs and other premises appear to be already closed, and the main group of persons present were outside or near to Astoria.

There were several incidents of minor disorder outside the pub and on the road, which were quickly diffused and no arrests were made. I confirmed the parties involved had been drinking inside the Astoria.

Whilst outside, myself and other officers observed several persons walking around with glasses, and bottles of champagne, having left the pub without being challenged by door staff. I approached one person and directed him back into pub, and a member of door staff actually tried to stop him going in, saying the glass was not from the pub.

I spoke with the 2 owners (apologies, I didn't record their names), and had a chat with them about ongoing issues outside, and he mentioned you had visited during the week. He did advise they had changed their age policy to 21 from 18.

With regards to Covid regulations, any social distancing was non-existent, and it was difficult to see exactly what measures the pub had in place.

11. Saturday 11th July 2020 @ 01.22 - 0640272/20

Disturbance outside Astoria

A large gathering of approximately 30 people pushing each other outside. On police arrival people started to disperse . Females present had been hit by a bottle, the offender had been identified.

I was taken by the ambulance but before I left I found out that the police had seen the footage of the incident but did nothing to the lads, they were allowed back in the club as if nothing had happened

I just wanted to bring to your attention an incident we dealt with on, Flixton Road, near to Astoria in the early hours

Log 73 18/07/20 refers, but generated on 'Patterjacks'. There is little information on the log.

As part of the ongoing Operation 'Shandy', myself and my patrols attended Flixton Road for hi-vi patrolling. As we drove on to the road, an altercation was already taking place near to the pub. Champs and other premises appears to be already closed, and the main group of persons present were outside or near to Astoria.

There were several incidents of minor disorder outside the pub and on the road, which were quickly diffused and no arrests were made. I confirmed the parties involved had been drinking inside the Astoria.

Whilst outside, myself and other officers observed several persons walking around with glasses, and bottles of champagne, having left the pub without being challenged by door staff. I approached one person and directed him back into pub, and a member of door staff actually tried to stop him going in, saying the glass was not from the pub.

I spoke with the 2 owners (apologies, I didn't record their names), and had a chat with them about ongoing issues outside, and he mentioned you had visited during the week. He did advise they had changed their age policy to 21

With regards to Covid regulations, any social distancing was non-existent, and it was difficult to see exactly what





Two bouncers say they were the victims of a racially-motivated attack on Boxing Day.

Security guards Silvio and Adilson Samuel were working at a Trafford bar and restaurant on Thursday (December 26) evening when two men tried to enter.

The brothers recognised the men, apparently known for previously causing trouble in the area, and told them they weren't allowed in.

Fearing repercussions, the owners of the bar have asked the Manchester Evening News not to publish the business' name.

"We told them they couldn't come in and they started arguing and shouting at us," Silvio said.

"When they've gone there in the past, they always come in a big group and think they own the bar and do whatever they want.

"That's not how it works."

A manager intervened and let the men enter the venue in an attempt to calm the situation.

The brothers say they were then attacked.

Police were called before the brothers went to hospital to be checked over.

"My brother is in so much pain in his jaw he cannot speak properly," Silvio said.

"He is also a bodybuilder and it is affecting him because he can't get to the gym to train."

I attended the premises and met with Will. We discussed the history of the premises an the problems it has caused in the past. We discussed the current problems on Flixton Rd and the word I have been doing with licensed premises to reduce crime and disorder and increase public safety.

It was discussed the license for Chadwick's is old and does not fit in with what needs to be achieved. We talked about Minor variations to the license and it was agreed I would email conditions with IO believed to be fitting with the premises with consideration of Will submitting a minor variation. Will was advised if he chose to submit the variation, if crime and disorder did occur I would consider taking the license for a review where I would be seeking to have the conditions imposed.

Will asked for my advice re door staff. I advised I was unable to nominate a door company, it was agreed to use a different door team to those that already work on Flixton Rd to reduce the possibility of one door team having the monopoly of the area.

l attended at the premises and met Will and the Bara manager. Will confirmed they were opening on Saturday 10th August.

We talked about locking the disabled toilets to prevent drug dealing. Will confirmed he was having 4 door staff, 2 at the front, 1 at the back and 1 roaming. he was not allowing under 21's years to enter and there was a dress code, there will be a challenge 25 Will showed me the drinks list, the drinks are of an average price, Will said the price reflected the type of clientele he was trying to attract.
