1. APOLOGIES

An apology for absence was received from Steven Boyle and Elizabeth McKenna.

2. DECLARATION OF INTEREST

4. Q2 5 STAR PERFORMANCE MANAGEMENT

The Assistant Director for Development for STAR Procurement presented the Q2 5 STAR Performance Management Report, informing members that the current efficiencies target is £5.2 million and currently achieving £4.8 million. The target for the local spend is 50% and currently at 43.8% on an upward trajectory from Q1.

The Assistant Director explained that a review on social value data has been carried out around data accuracy. This review was undertaken to ensure the contractual offer secured was accurate and so that we can start reporting on the delivery of secured social value from April 2023.

STAR are currently undertaking a comprehensive review of performance measures for the next financial year, and will update at the next meeting.

5. Q2 CONTINUOUS IMPROVEMENT UPDATE

The Assistant Director for Development for STAR Procurement informed that the Continuous Improvement group meets regularly on items including the progression to the new Procurement Bill. The new Procurement Bill is currently going through Parliament.

The Community Impact Fund (CIF) which was set up from April 2022, now has £5000 in it for each authority and each partner organisation is deciding how this will be spent in line with providing community support particularly during this economic crisis.

For the 2022/23 income plan, we are exploring commission opportunities with several different organisations. More information will be available at next meeting.

STAR continues to work with Stockport Council on data performance management support which is working very well.

The Chair stated that other local authorities have been stung by the energy contracts in recent months and asked what has been learnt from this. He was informed that STAR has been monitoring this and has been on national and regional working groups on this issue. Key lesson learnt is to continue to work together, and monitor developments before making decisions on next steps.

Councillor North asked if it were possible to receive a note on the Community Impact Fund.
