1. Background

1.1 St Alphonsus Parish Centre is sited in Old Trafford in a residential area and has the benefit of a premises licence PL000343 (Appendix B).

2. Application for the Variation of a Premises Licence

- **2.1** On 3rd July, 2015, the Licensing Section received an application (**Appendix A**) from SDC Trading Ltd (Salford Diocese) for the grant of a variation to the existing premises licence for St Alphonsus Paris Centre.
- 2.2 The applicant has complied with all requirements under the application process including advertising the application in a newspaper, advertising by way of public notice at the premises and submitting a copy of the complete application to all Responsible Authorities. The application is deemed to be correctly submitted.

3. Representations

- **3.1** During the consultation period, a representation was received from the Council's Pollution Section (**Appendix C**).
- 3.2 The recommended conditions have been agreed by the applicant and will form part of the proposed conditions to be attached to the premises licence (Appendix C).
- **3.3** Representations have been received against the application from local residents and are attached as **Appendix D**.
- **3.4** The Committee are respectfully advised that the representations received against the application broadly relate to all Licensing Objectives:
 - · Crime & Disorder
 - Public Nuisance
 - Prevention of Public Nuisance
 - Protection of Children from Harm
- **3.3** It is recommended that, in borderline cases, the benefit of the doubt about any aspect of a representation should be given to the person making that representation. The subsequent hearing would then provide an opportunity for the person or body making the representation to amplify and clarify it.
- **3.4** The Members will be required to determine the relevance of the representations.
- **3.5** When considering the relevance of the representations the Licensing Sub-Committee must apply three rules:

Licensing Act 2003 - St Alphonsus Parish Centre

- i. the representation must be from persons who live, or are involved in a business in the area and are likely to be affected by the application;
- ii. it must not be repetitious, vexatious or frivolous;
- iii. it must relate to one or more of the licensing objectives.

4. Licensing Policy and Guidance

4.1 The Committee are respectfully referred to the Council's own Licensing Policy relating to the Licensing Act 2003 objectives and to the Secretary of State's Guidance. (Copy available at meeting)

5. Options

- **5.1** The Sub-Committee to take such steps as they consider necessary for the promotion of the Licensing Objectives in accordance with the provisions of subsection (4) of the Licensing Act 2003. The steps specified are:
 - 5.1.1 To grant the licence subject to-
 - Conditions consistent with the operating schedule accompanying the application modified to such extent as the authority considers necessary for the promotion of the licensing objectives, and;
 - Any mandatory conditions which must be included under the Licensing Act 2003
 - **5.1.2** to exclude from the scope of the licence any of the licensable activities to which the application relates;
 - **5.1.3** to refuse to specify a person in the licence as the premises supervisor;
 - **5.1.4** to reject the application.
- **5.2** The Sub-Committee is advised that any findings on any issues of fact should be on the balance of probability and any decision should be based on the individual merits of the application.
- **5.3** The Sub-Committee, in arriving at its decision, must have regard to relevant provisions of national guidance and its own statement of licensing policy and reasons should be given for any departure.





ANNEX 1 - MANDATORY CONDITIONS

1. Alcohol shall not be sold or supplied except during the hours granted on the licence and the following:

On Good Friday, 12.00noon to 10.30pm.

On Christmas Day, 12.00noon to 3.00pm and 7.00pm to 10.30pm.

On New Year's Eve from the end of licensing hours on New Year's Eve to the start of licensing hours on the following day (or, if there are no licensing hours on the following day, midnight on 31st December).

- 2. The above restrictions do not prohibit:
- (a) during the first twenty minutes after the above hours the consumption of the alcohol on the premises;
- (b) during the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;
- (c) during the first thirty minutes after the above hours the consumption of the alcohol on the premises by persons taking meals there if the alcohol was supplied for consumption as ancillary to meals;
- (d) consumption of alcohol on the premises or the taking of sale or supply of alcohol to any person residing in the licensed premises;
- (e) the ordering of alcohol to be consumed off the premises, or the dispatch by the vendor of the alcohol so ordered;



- (g) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;
- (h) the taking of alcohol from the premises by a person residing there; or
- (i) the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of the alcohol by persons so supplied; or
- (j) the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.
- 3. No person under fourteen shall be in the bar of the licensed premises during the permitted hours unless one of the following applies:
- (a) He is the child of the holder of the premises licence.
- (b) He resides in the premises, but is not employed there.
- (c) He is in the bar solely for the purpose of passing to or from some part of the premises which is not a bar and to or from which there is no other convenient means of access or egress.
- (d) The bar is in railway refreshment rooms or other premises constructed, fitted and intended to be used bona fide for any purpose to which the holding of the licence is ancillary
- 4. In this condition "bar" includes any place exclusively or mainly used for the consumption of alcohol. But an area is not a bar when it is usual for it to be, and it is, set apart for the service of table meals and alcohol is only sold or supplied to persons as an ancillary to their table meals.
- 5. No supply of alcohol may be made under the premises licence -
- (a) at a time when there is no designated premises supervisor in respect of the premises, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 6. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 7. Where the premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each such individual must be licensed by the Security Industry Authority.
- 8. No Off Sales.
- 9. No Occasional Licences
- 10. Intoxicating liquor shall only be sold or supplied to:-



- (b) Persons attending charitable functions admission to which is by way of invitation or ticket obtained otherwise than at a door of the said premises.
- (c) Members of St Alphonsus Parish Centre and their bona fide guests.
- 11. A list of members of the centre should be maintained at all times on the premises (and shall be produced to a constable on demand).
- 12 This Licence shall also be subject to the standard and additional conditions relating to the Public Entertainment Licence hereto attached.
- 13. The occupancy shall not exceed 460 of which 180 on the first floor and 280 on the ground floor.

ADDITIONAL MANDATORY CONDITIONS (28th May 2014)

- 14. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 15. For the purposes of the condition set out in paragraph 1
 - (b) "permitted price" is the price found by applying the formula—

$$P = D + (D \times V)$$

Where -

- (i) P is the permitted price;
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol;

and

- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—
 - (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

- 17. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

ADDITIONAL MANDATORY CONDITIONS (1st October 2014)

- 18. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purposes of encouraging the sale or supply of alcohol for consumption on the premises:-
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to :-
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
 - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
 - 19. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
 - 20. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.



Dear Jan

I am writing to you regarding the above application for a late licence and wish to raise a serious objection to this application.

I have lived in Alphonsus Street for over a year now and am on occasion disturbed by the noise from late running events at the parish centre. This situation is completely manageable at present but I do fear if a late licence was granted to the premises that my mental and physical health would suffer.

I particularly chose to live on Alphonsus Street as it seemed like a peaceful street with a great mix of young families and elderly neighbours.

Since my partners death a few years ago I am working very hard to raise my young child as a single mother and I hold a demanding position which requires me to commit a great deal of my time. I therefore require childminders to be at home with my daughter from time to time, including my parents who are in their 70s. The thought of them and my child being disturbed by noise and I fear potential criminal activity from across the road is a lot for me to bear.

I have heard people on the streets late at night following events at the centre and a late licence will only make this worse. Sometimes I can hear bad language and smell marijuana from my bedroom window which directly faces the centre.

I strongly fear that the late licence will exacerbate this and attract even more unsavoury types and harder drugs. This is of great concern to a parent and I do fear for the safety of my child as the waste this kind of behaviour leaves on the street is potentially harmful should a child pick anything up.

I don't wish to feel intimidated in my own home and I imagine this feeling is even worse for my elderly neighbours.


I would ask you to take this into consideration whilst you review the licence application.

Alphonsus Street is a good place to live at present and although events at the centre are irritating when they run on late so far none of the issues presented have been unsurmountable. However if a late licence was granted, even just for two days a week I think this would make the centre into a public nuisance and I will be forced to seek legal advice in this matter.

I Mrs. Susan Land of the above aforementioned address wish to make a formal representation about the Extended Alcohol Licence application made by SDC Trading Limited on Alphonsus Street, Parish Centre, 2 Powell Street, Old Trafford, Manchester, M16 TQQ, that has been applied to the Licensing Authority of Trafford Council, dated 2nd July 2015, by John Gaunt & Partners, Solicitors.

The application indicates that SDC Trading Limited are requesting to extend their current alcohol trading licence until the terminal hour of 02:00am Friday, Saturday and Sundays on a Bank Holiday Monday weekend.

My concerns are that I have <u>lived at the property above for 49 years</u>; I am a <u>Retired Disabled</u>

<u>Pensioner</u> and I have lived adjacent to the Alphonsus Street, Parish Centre for approximately 40 years and I worry that history will repeat itself.

There have been late night licences in place before at the Alphonsus Parish Centre and there was never any duty of care to the neighbourhood shown by the proprietors. Every other weekend there would be fighting in the streets, cars and people's property was being damaged, and their inebriated customers were caught urinating, being sick in neighbourhood gardens and at times it was very stressful.

There were also problems with noise pollution from the premises playing loud music, people shouting/screaming, taxi's doors opening/closing, taxis beeping awaiting customers and their customer's talking and laughing outside our properties into the early hours of the morning.

The reason I'm making this <u>Formal Representation</u> is that there is no formal control in place at present, so what will be SDC Trading Limited <u>Duty of Care</u> to Noise <u>Pollution</u>, from their activities be going forward.

I also feel that Trafford Council have a duty of care to its resident's public health and wellbeing and I would like to understand, what the Councils intentions will be to control or prevent any public nuisance, IF SDC Trading Limited cannot manage both its noise and disturbance

I hope that you do not reject my comments with regards to this letter of Formal Representation but I feel passionate about our surrounding neighbourhood and I feel that this application needs to be reviewed before being implemented.

I awalt your response and would gladly attend any meeting to discuss the above.
